1.0 Introduction

This report presents official Quarterly Gross Domestic Product (QGDP) estimates at current and constant prices for Tanzania Mainland. The QGDP estimates do facilitate frequent and appropriate policy interventions by providing reliable and timely reports on recent short term economic developments.

Data used in the compilation of QGDP were collected from all economic activities performed in the economy from January to March, 2015. The type of data collected were the production of goods and services. The compilation follows the United Nation Statistics Division's guidelines on the compilation of national accounts statistics including the System of National Accounts 2008

1.1 Economic Performance

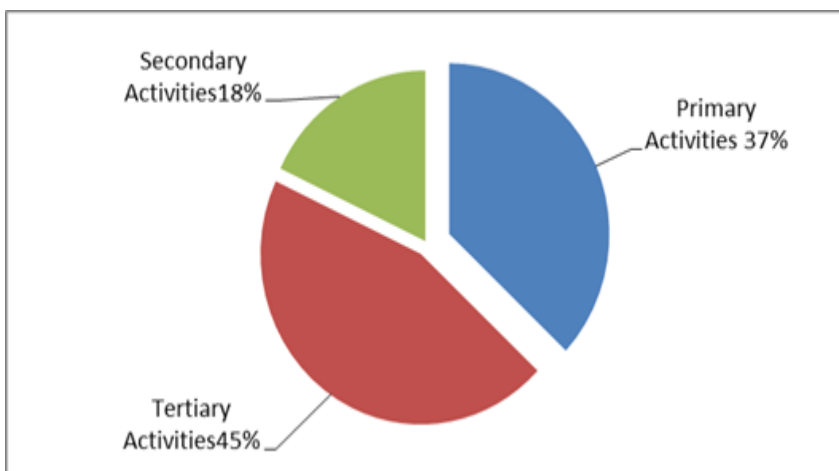
During the period under review, in absolute terms, the value of QGDP at current prices rose from TZS 18,596,774 million in the year 2014 compared to TZS 21,913,381 million in 2015.



The value of QGDP in real terms, constant price, was TZS 10,639,607 million in the year 2015 compared to TZS 9,994,803 million in the first quarter of the year 2014.

In the first quarter of 2015, the largest share of GDP was that of Tertiary an activity which was 45 percent, followed by Primary activities by 37 percent and. Secondary activities had the least share of 18 percent.

Chart1: Percentage Share of Economic Activities at Current Prices



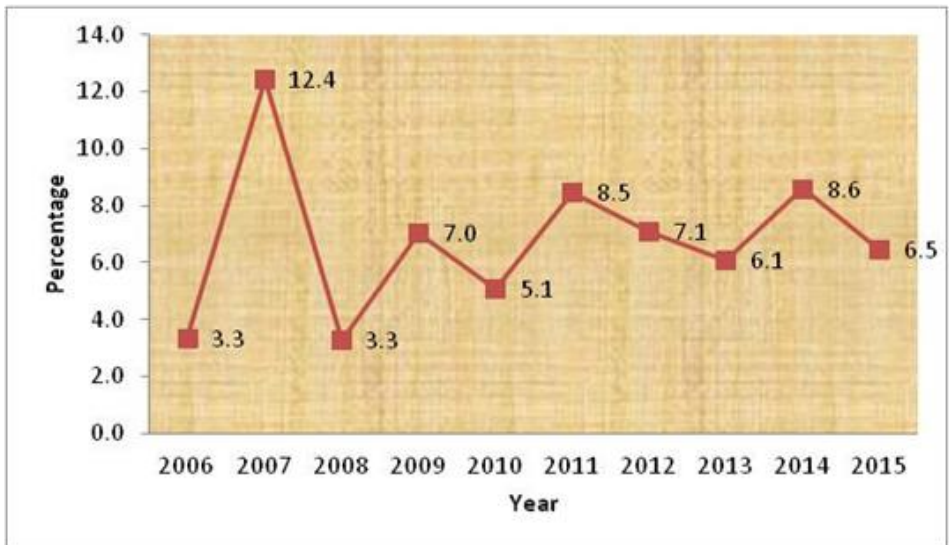
In the period January to March 2015, real Gross Domestic Product at market price increased at a growth rate of 6.5 percent compared to a growth rate of 8.6 percent in a similar quarter of 2014, Chart 2.

The decrease of 2.1 percentage points is attributed a decrease in agricultural production due to unfavorable short rains in the agricultural year 2014/15.

During the period, the highest growth was attained by electricity activity with a growth rate of 13.0 percent due to the increase of generated electricity in the country. Mining and quarrying recorded the least growth rate at 0.6 percent due to low production of gold, diamond and tanzanite which have a higher weight in the mining and quarrying activity. This decrease was due to a drop in the price of gold in the world market which discouraged production.

2.0 Sector Performance

2.1 Agriculture, Forestry and Fishing

This activity includes the exploitation of vegetable and animal natural resources, comprising the activities of growing of crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

The agriculture sector registered a growth rate of 2.6 percent in the first quarter of 2015 as compared to 3.4 percent recorded in the similar quarter of 2014.

Crop production registered a growth rate of 2.7 per cent in the first quarter of 2015 as compared to 4.3 per cent in the first quarter of 2014.

The lower increase in growth rate was due to unfavourable rainfall for agricultural production during the short rainfall season for the agricultural year 2014/15. The quantity of maize harvested went up by 2.7 percent from 2,055 thousand



tonnes in the first quarter of 2014 to 2,111 thousand tonnes in the first quarter of 2015. Paddy harvested increased by 11.9 percent from 420 thousand tonnes in the first quarter of 2014 to 470 thousand tonnes in the corresponding quarter of 2015. Sweet potatoes harvested in the first quarter of 2014 were 27 thousand tonnes as compared to 28 thousand tonnes in the corresponding quarter of 2015 which was an increase of 3.7 percent, while cassava harvested increased by 3.3 percent from 209 thousand tonnes in the first quarter of 2014 to 216 thousand tonnes in the first quarter of 2015 and beans harvested decreased by 6.8 percent from 412 thousand tonnes in 2014 to 384 thousand tonnes in 2015.

Livestock activity registered a growth rate of 2.9 percent in the first quarter of 2015 as compared to 2.2 percent in the first quarter of 2014. The increase in growth rate was due to the increase in the number of livestock sold for slaughter in the first quarter of 2015.

Forestry activity registered a growth rate of 2.1 percent in the first quarter of 2015 as compared to 5.0 percent recorded in



the same quarter of 2014. The decrease in growth rate was due to the decrease in harvested logs.

Fishing activity grew at a rate of 0.9 percent in the first quarter of 2015 as compared to a growth rate of 2.3 percent recorded in the first quarter of 2014. The decrease in growth rate was due to the decrease in fish catch during the reference period.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction can be underground, on the surface mining or well operation. It also includes supplementary activities aimed at preparing the crude materials for marketing, for example, crushing, and grinding, cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. These operations are often accomplished by the units which extract the resource and/or other located nearby.



Mining and quarrying is divided into four industries which are:

- 1) Mining of coal and lignite and extraction of peat;
- 2) Crude petroleum and natural gas;
- 3) Mining of metal ores; and
- 4) Other mining and quarrying

The activity recorded a growth rate of 0.6 percent in first quarter of 2015 as compared to 19.7 percent recorded during the similar quarter of 2014. The small growth was mainly due to decrease in production of gold, diamond and Tanzanite which were caused by a fall in prices in the world market as well as closure of Buzwagi and Tulawaka Mines. However, copper, silver, salt and other mining and quarrying registered increased in growth.

2.3 Manufacturing

Manufacturing activity involves physical or chemical (industrial) transformation of materials, substances, or components into final or semi processed goods. These materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity recorded a growth of 5.7 percent in the first quarter of 2015 compared to 8.2 percent in the similar quarter of the year 2014. Growth rate was attributed to the increased in the production of industrial goods in general. Noticeable increases were realized in the production of textiles and wearing apparel, food products, chemicals and pharmaceuticals and the production of furniture. Index of Industrial production increased by 6.9 percent, from 144.9 in the first quarter of 2014 to 154.9 for the similar quarter in 2015.

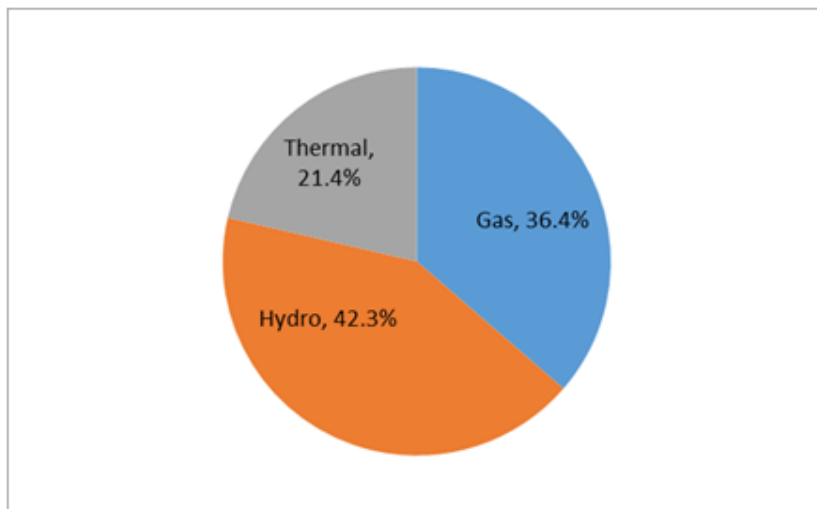


2.4 Electricity

The activity covers provision of electric power, natural gas, through a permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are the power generation companies.

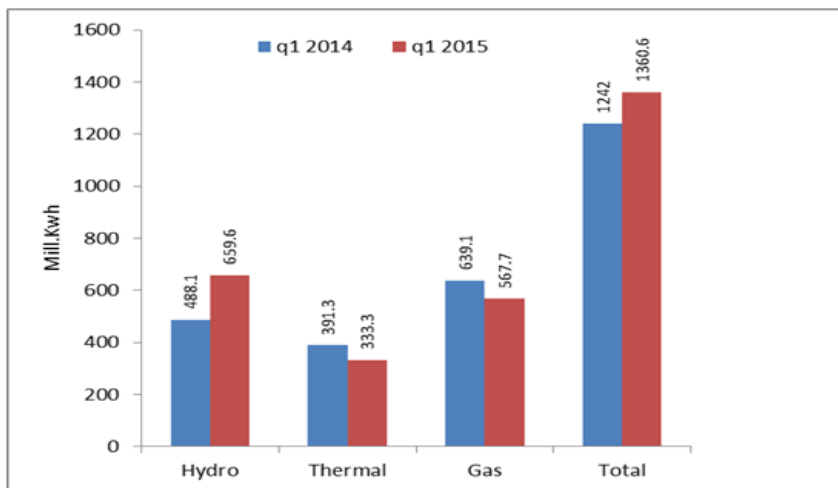
In the period January to March 2015, total electricity generated increased to 1,561 mill.kwh from 1,519 mill. Kwh generated in the corresponding quarter of 2014. Electricity generated from hydro sources accounted for 42.3 percent of the total power generated in the reference quarter. The shares of other sources were gas (36.4 percent) and thermal (21.4 percent).

The growth of the activity is determined by the quantity of electricity generated. During the quarter under review, total electricity generated increased to 1,360.6 mill.kwh from 1,242 mill.kwh generated in the similar quarter of 2014. Hence, the activity recorded a growth rate of 9.5 percent due to availability of water in hydropower dams; as well as and improvement of transmission and distribution lines.

Chart 4: Quantity of Electricity Generated (Mill Kwh) by Source, Tanzania Mainland, First quarter of 2014 and 2015



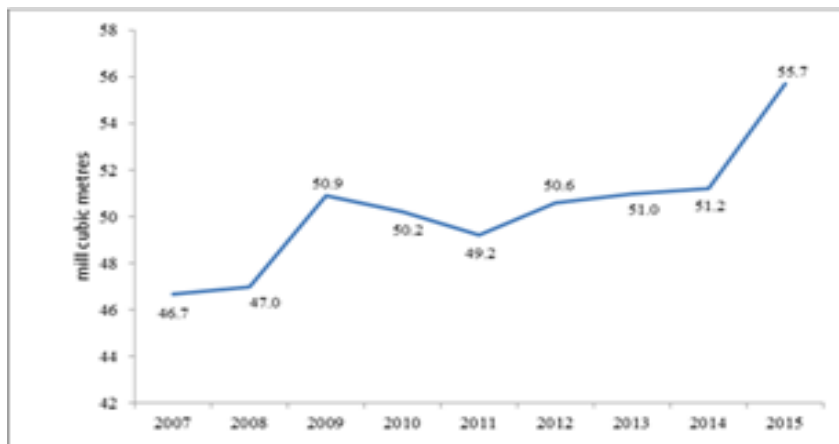
2.5 Water Supply and Sewerage

The activity includes collection and purification of water for water supply purposes, desalting of sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on own account in agriculture or households. It also includes water distribution activities.

The indicator of growth of water supply activities is mainly the quantity of water supplied. In the period January to March 2015 the quantity of water supplied increased to 55.7 million cubic metres from 51.2 million cubic metres recorded in the similar quarter of 2014.

During the period under review, the activity grew at rate of 8.8 percent compared to 0.7 percent in the corresponding quarter of 2014. The growth was attributed to the improvement of water supply infrastructure and favourable weather condition.

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and also construction of a temporary nature.

General construction is the construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., it also includes construction in civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc.

The activity grew by 8.8 percent in the first quarter of 2015, as compared to 21.4 percent in the same quarter of 2014. The decline in growth rate was attributed to decrease in construction activities in roads and bridges, residential and non-residential buildings.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sale (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves the buying and selling of goods.

The activity recorded a growth rate of 6.5 percent in the first quarter of 2015 as compared with a growth rate of 10.6 percent observed in the same quarter of 2014. The decline in growth was due to decrease of traded goods specifically agriculture products and manufactured goods.

2.8 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water or air and associated activities such as cargo handling, storage etc. The activity also includes renting of transport equipment with driver or operator and postal and courier activities.

Transport and storage activity activities grew at the rate of 12.9 percent in the first quarter of 2015 as compared to 14.7percent in the first quarter of 2014. This growth rate was attributed to the increase in number of passengers carried and freight handled during the period under review.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services grew at the rate of 1.7 percent in the first quarter of 2015 compared to a growth rate of 3.4 percent in the first quarter of 2014. This small increase in growth was due to small increases in tourist arrivals and bed occupancies. The number of tourist arrivals and bed occupancies were 296,051 and 320,523 respectively in the first quarter of 2015 compared to 295,613 and 319,332 respectively in similar quarter of 2014.

2.10 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities and information service activities e.g. data processing; news agencies.

The activity recorded a growth rate of 10.3 percent in the first quarter of 2015 compared to 17.1 percent in the first quarter of 2014. Despite the decline in the growth rate there was an increase in airtime used by mobile phone customers and the expansion of broadcasting and internet services in the country.

2.11 Financial and Insurance Activities

The activity covers financial services, insurance and reinsurance, voluntary pension funding, auxiliary to financial service. It also includes the activities of holding

assets, such as holding companies, trusts, funds and similar financial entities.

The activity recorded a growth rate of 9.1 percent in the first quarter 2015 as compared to a growth rate of 11.2 percent in the same quarter 2014. The growth in financial and insurance activity was attributed to increase in level of deposits from 13.8 trillion in 2014 to 15.4 trillion in 2015; increase in level of lending from 10.6 trillion in 2014 to 12.9 trillion in 2015; and increase in services provided by insurance companies.

2.12 Real Estate Activities

This activity includes selling or buying real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity recorded a growth rate of 2.2 percent in the first quarter of 2015 compared to a growth rate of 2.1 percent in first quarter of 2014. The growth rate was attributed to increase in the demand for accommodation especially in urban areas.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. These activities require a high degree of training, as well as making specialized knowledge and skills available to users.

This involves Legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity recorded a growth rate of 2.5 percent in the first quarter 2015 as compared to a growth rate of negative 0.3 percent in the corresponding quarter in 2014. The growth rate was attributed to the increase in other professional, legal and accounting activities.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involves rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; services to buildings and landscape; office

The activity recorded a growth rate of 11.5 percent in the first quarter 2015 compared to a growth rate of 12.7 in the first quarter 2014. The growth rate was attributed to the increase in the performance of travel agent and tour operators' activities.

2.15 Public Administration and Defence; compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defence, public order and safety, immigration services, foreign airs and the administration of government programmes. This activity also includes compulsory social security activities.

The activity recorded a growth rate of 12.0 percent in the first quarter of 2015 as compared to a growth rate of negative 0.2 percent in the corresponding quarter of 2014. The increase in growth was attributed to the government activities of maintaining peace and order.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at its different levels as well as adult education, literacy

Programmes etc. The activity includes public as well as private education.

The activity recorded a growth rate of 6.7 percent in the first quarter of 2015 as compared to a growth rate of 5.4 percent in the same quarter of 2014. The growth was attributed to the increase of number of enrolled students in primary and secondary schools. Pupils enrolled in primary school increased from 8.2 million in 2014 to 8.5 million to 2015, while students enrolled in secondary schools increased from 1.7 million in 2014 to 1.8 million 2015.

2.17 Human Health and Social Welfare

The activity includes the provision of health and social work activities. It includes a wide range of activities, starting from health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

The activity recorded a growth rate of 8.0 percent in the first quarter of 2015 as compared to a growth rate of 8.4 percent in the same quarter of 2014. The decline in growth rate was attributed to general decrease with the exception of increase in the provision of services in health facilities.

2.18 Art, Entertainment and Recreation

This activity includes a wide range of activities to meet varied cultural, entertainment and recreational interests of the general public, including live performances, operation of museum sites, gambling, sports and recreation activities.

The activity recorded a growth rate of 5.6 percent in first quarter 2015 as compared to 7.2 percent in the corresponding quarter 2014. The decline in growth rate of this activity was mainly attributed to the slow increase in number of tourist arrivals from the rest of the world. The total number of tourist in the first quarter 2014 was 295,613 as compared to 296,051 tourists in the corresponding quarter 2015.

2.19 Other Services Activities

This Industry (as a residual category) includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification.

The activity recorded a growth rate of 6.8 percent in the first quarter 2015 as compared to 6.6 percent in first quarter 2014. The growth rate was attributed to the increase in the urban population and personal service activities.

2.20 Activities of Households as Employers

Activities of households as employers include domestic personnel such as maids, cooks, waiters, valets, butlers, laundresses, gardeners, gatekeepers, chauffeurs, caretakers, governesses, babysitters, tutors, secretaries etc. The activity allows the domestic personnel employed to state the activity of their employer in censuses or studies, even though the employer is an individual. The product produced by this activity is consumed by the employing household.

The activity recorded a growth rate of 2.6 percent in the first quarter 2015 as compared to 2.7 percent in the corresponding quarter 2014. The growth rate was attributed to the increase in the urban population.
