## WELCOMING REMARKS BY THE DIRECTOR GENERAL OF THE NATIONAL BUREAU OF STASTISTICS, DR. ALBINA A. CHUWA DURING THE CELEBRATION OF AFRICAN SATISTICS DAY, 2013, HELD ON 20TH NOVEMBER, 2013 AT THE NATIONAL MUSEUM HALL, DAR ES SALAAM

- a) To provide quality statistics to be used by the Government, businesses and international organizations for planning and evidence based decision making,
- b) To coordinate statistical activities in order to enhance production of authentic statistics.

**Hon. Guest of Honor,** in year 2010, the Government of Tanzania approved a comprehensive statistical plan known as Tanzania Statistical Master Plan (TSMP). The main objective, among others was to coordinate and monitor production of good quality statistics by all producers, including Ministerial Departments and Agencies. Through TSMP, producers and users of statistics are also guided on the use of agreed standard, methods and definition set by the United Nations Statistical Division with regard to production and dissemination of official statistics.

Thus, today is a special and important day, not only for statisticians, but also for all statistics stakeholders in Africa. In this day, statisticians meet to discuss various statistical related issues and remind statistics stakeholders on the importance of using statistics in their daily activities.

**Hon. Guest of Honor,** I understand that your speech is full of key messages for statisticians about this day. There are also other professionals from different sectors of the economy who are with us today. They will be given opportunities to present and discuss about the importance of quality statistics in development planning and supporting progress.
