NATIONAL CONSUMER PRICE INDEX (NCPI) FOR THE MONTH OF MAY, 2020

METHODOLOGICAL NOTE

Definition

The NCPI measures the change over time in the cost of a fixed basket of goods and services that are purchased by a representative sample of households in Tanzania. A basket includes a list of 278 goods and services of which 97 are Food and Non-Alcoholic Beverages and 181 are Non-Food items that are being priced on monthly basis.

Weights and a Reference Period

The NCPI weights are based on monetary expenditures relating to consumption for all households in the 25 geographic regions of Tanzania Mainland. The index weights are based on expenditures of both urban and rural households derived from 2011/12 Household Budget Survey and the price reference period is December, 2015.

Classification

The NCPI follows the internationally recommended Classification of Individual Consumption by Purpose (COICOP). NCPI is being disseminated with indices for the 12 major groups of COICOP as well as several additional index aggregations. These additional indices are; 1) Food and Non-alcoholic Beverages - combining food consumed at home and food consumed in restaurants; 2) Energy and Fuels - combining electricity and other fuels for use at home including petrol and diesel; 3) All Items Less Food; and 4) All Items Less Food and Energy.

Elementary and Higher Level Indices

The NCPI use geometric mean of price relatives for compiling elementary index aggregates and the Lowe Index formula which is Laspeyres index formula type is used for computing higher level aggregates.

The Headline Inflation Rate measures inflation rate when all items in the fixed CPI basket are included. Table number 1 above indicates that, Annual Headline Inflation Rate for the month of May, 2020 has decreased to 3.2% from 3.3% recorded in April, 2020. The decrease of the headline inflation explains that, the speed of price change for commodities for the year ended May, 2020 has decreased compared to the speed recorded for the year ended April, 2020. The overall index went up to 120.93 in May, 2020 from 117.23 recorded in May, 2019.

Food and Non Food Inflation Rates

Food and Non-Alcoholic Beverages Inflation Rate for the month of May, 2020 has decreased to 4.4% from 4.6% recorded in April, 2020. Annual Inflation Rate for food consumed at home and away from home for the month of May, 2020 has stagnated at 5.2% as it was recorded in April, 2020. The 12-month index change for non-food products in May, 2020 has decreased to 2.4% from 2.5% recorded in April, 2020.

Inflation Rate excluding Food and Energy

The Annual Inflation Rate which excludes food and energy for the month of May, 2020 has slightly increase to 2.2% from 2.1% that was recorded in April, 2020.

The NCPI used to compute this type of Inflation Rate excludes food consumed at home and restaurants, petrol, diesel, gas, kerosene, charcoal, firewood and electricity. Excluding food and energy which are the most volatile components in the total NCPI provides a more stable Inflation Rate figure for Policy Makers.

Chart 1: Movement of National Consumer Price Indices (NCPI) and Inflation Rates from May, 2019 – May, 2020. (Dec. 2015 = 100)




Chart number 1 above explains that; CPI has shown a relatively stable price movement from May, 2019 to May, 2020. In addition, Annual Headline Inflation Rates over the same period have shown a stable trend that range between 3.2% recorded in May, 2020 and 3.8% recorded in November and December, 2019.

MONTHLY CHANGE OF CONSUMER PRICE INDEX FROM APRIL, 2020 TO MAY, 2020

The National Consumer Price Index has increased by 0.2% from April, 2020 to May, 2020 compared to an increase of 0.4% that was recorded from March, 2020 to April, 2020. The overall index has increased to 120.93 in May, 2020 from 120.67 recorded in April, 2020. The increase of the overall index is attributed to the price increase for both food and non food items. Some of food items that contributed to such increase include:- pastry-cook products by 1.5%, sorghum grain by 4.1%, fish by 3.0%, sardines by 1.2%, groundnuts by 2.2%, beans by 5.7%, cassava by 2.6% and cooking bananas by 4.4%. On the other hand, non food items that contributed to such increase includes: - cleaning and maintenance products by 1.1%, men's suit by1.1%, gowns by 1.3%, firewood by 3.0%, exercise books by 1.8% and hair dressing for women by 1.1%
