1.0 Introduction

This report presents Quarterly Gross Domestic Product (QGDP) at current and constant prices for Tanzania Mainland, base year 2015. QGDP reports facilitate frequent and appropriate policy interventions by providing reliable and timely updated data on recent short-term economic developments.

1.1 World Economy

According to the World Economic Outlook (WEO) October 2021 report, the global economic projection growth rate for 2021 has been revised downward to 5.9 percent. The revised growth is 0.1 percentage point lower than the previous projected growth in the WEO July 2021 report. Meanwhile, global economic growth estimates for 2022 have remained unchanged at a rate of 4.9 percent. This revision has considered worsening of pandemic dynamics in low-income countries and also reflect supply disruptions in the advanced economy.

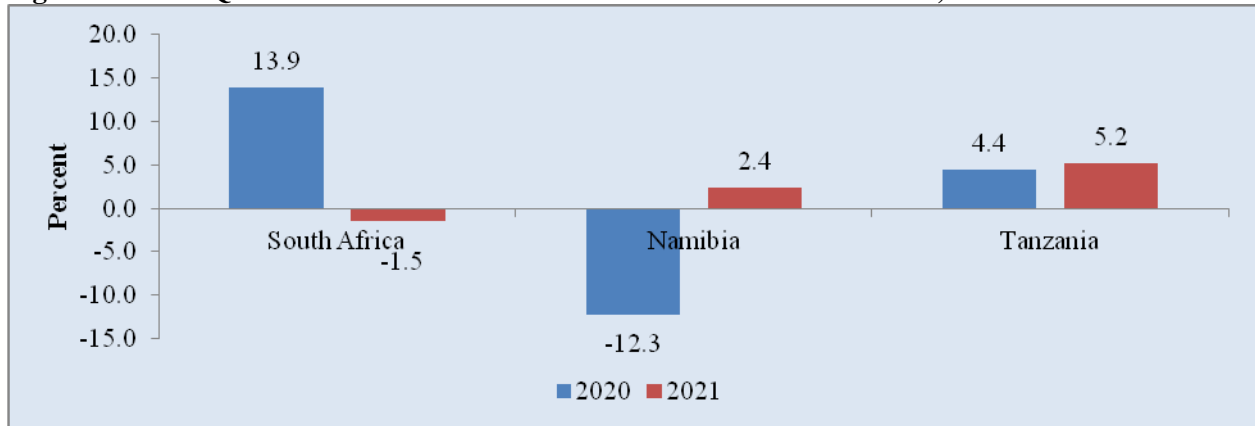
1.2 Sub-Saharan Africa

The projection of economic growth among sub-Saharan Africa countries by the WEO October 2021 report indicates that the economy will grow by 3.7 percent about 0.3 percentage point higher than the July 2021 projection. South Africa economy is projected to grow at a rate of 5.0 percent in 2021, which is an increase of 1.0 percentage points compared to the WEO July 2021 report. In addition, economic growth for other countries are projected to increase due to improved exports which overpass imports of the COVID-19 vaccine.

1.3 Southern Africa Development Community

According to the WEO October 2021 report, economic growth in the region is expected to improve to 3.7 percent is equivalent to an increase by 0.3 percentage points from the July 2021 projection. Economic growth for South Africa shows a decline to 1.5 percent in the third quarter in 2021 compared to 13.9 percent increase over a similar period in 2020. Namibia's economy has also grown to 2.4 percent in the third quarter in 2021 compared to the negative growth rate of 12.3 percent in the similar period in 2020. Tanzania's economy has grown at a rate of 5.2 percent in the third quarter in 2021 compared to a growth of 4.4 percent recorded in a similar period in 2020.

Figure 1: Third Quarter GDP Growth Rates for Selected SADC Countries, 2020 and 2021

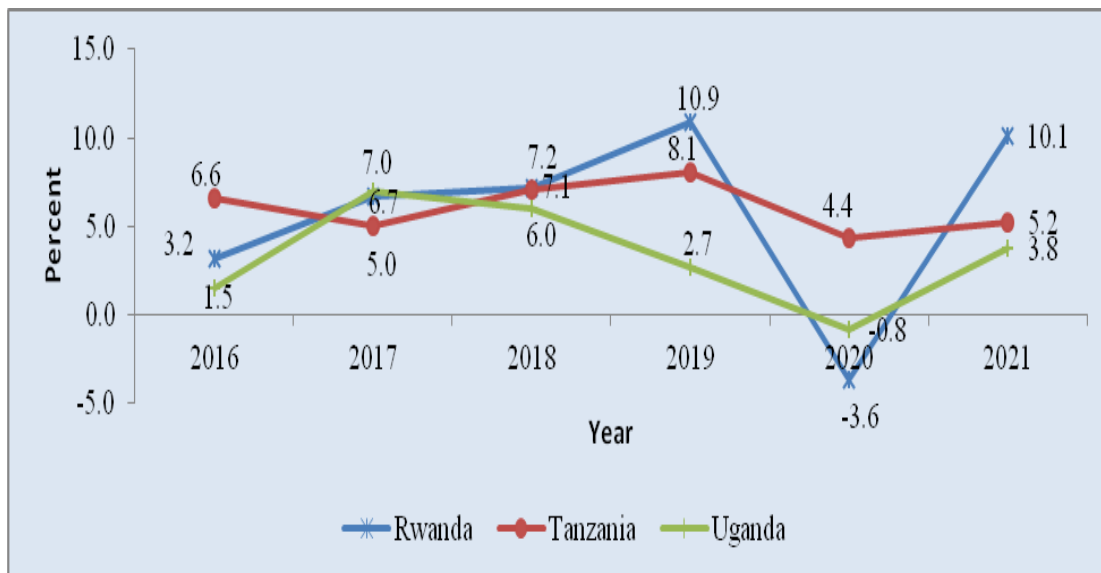

1.4 East Africa Community

Countries in the East African Community that have reported economic performance in the third quarter 2021 show that Rwanda’s economy grew by 10.1 percent compared to a negative growth of 3.6 percent in a similar period in 2020; Uganda's economy expanded by 3.8 percent compared to a negative growth of 0.8 percent in the corresponding period in 2020; meanwhile, Tanzania's economy has grown at a rate of 5.2 percent in the third quarter in 2021 compared to 4.4 percent in the third quarter in 2020.

1.5 GDP Compilation in Tanzania

Compilation of the third quarter GDP (July – September) 2021 used data from all economic activities. Compilation followed the United Nations Statistics Division’s

2008 System of National Accounts. The report presents Gross Domestic Product at current and constant prices for Tanzania Mainland, base year 2015.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in early 2019. The policy allows publication of provisional results subject to availability of new or revised quarterly and/or annual data.

1.5.1 Third Quarter GDP Growth Rate 2021

During the third quarter in 2021, Gross Domestic Product (QGDP) in absolute terms at current prices increased to TZS 37.1 trillion from TZS trillion 34.5 observed in the similar quarter in 2020. Further, QGDP at 2015 constant prices also increased to TZS 32.0 trillion in the third quarter in 2021 from TZS 30.3 trillion in the similar period in 2020, equivalent to 5.2 percent growth rate.

Figure 3: Third Quarter GDP Growth Rate, 2014 - 2021

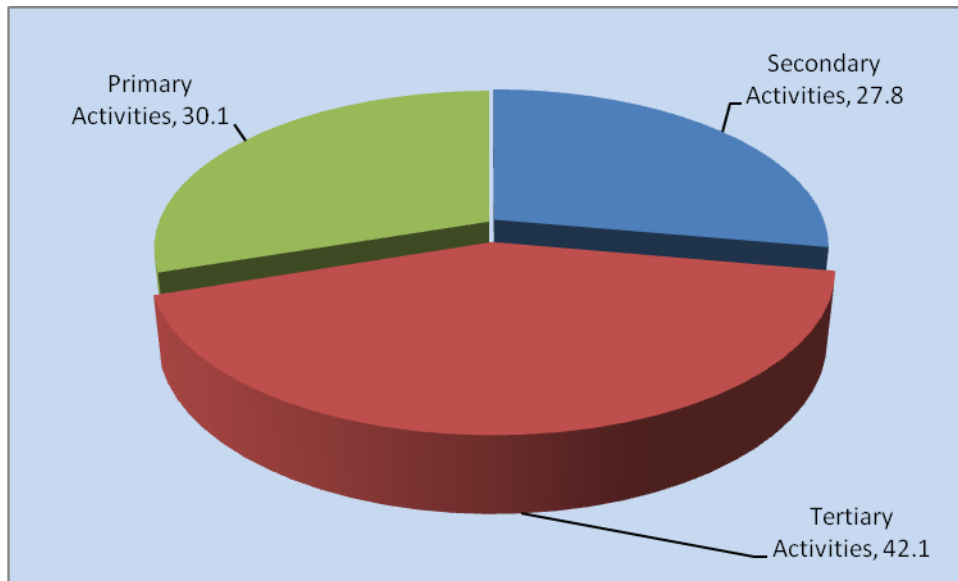

1.5.2 Share to GDP by Broad Economic Classification, Third Quarter 2021

Tertiary activities accounted for the largest share to GDP of 42.2 percent in the third quarter in 2021, followed by Primary activities by 30.3 percent and Secondary activities had the least share of 27.8 percent. Shares to GDP have been derived before adjustment for taxes.

Figure 4: Percentage Share to GDP by Broad Economic Activities at Current Prices

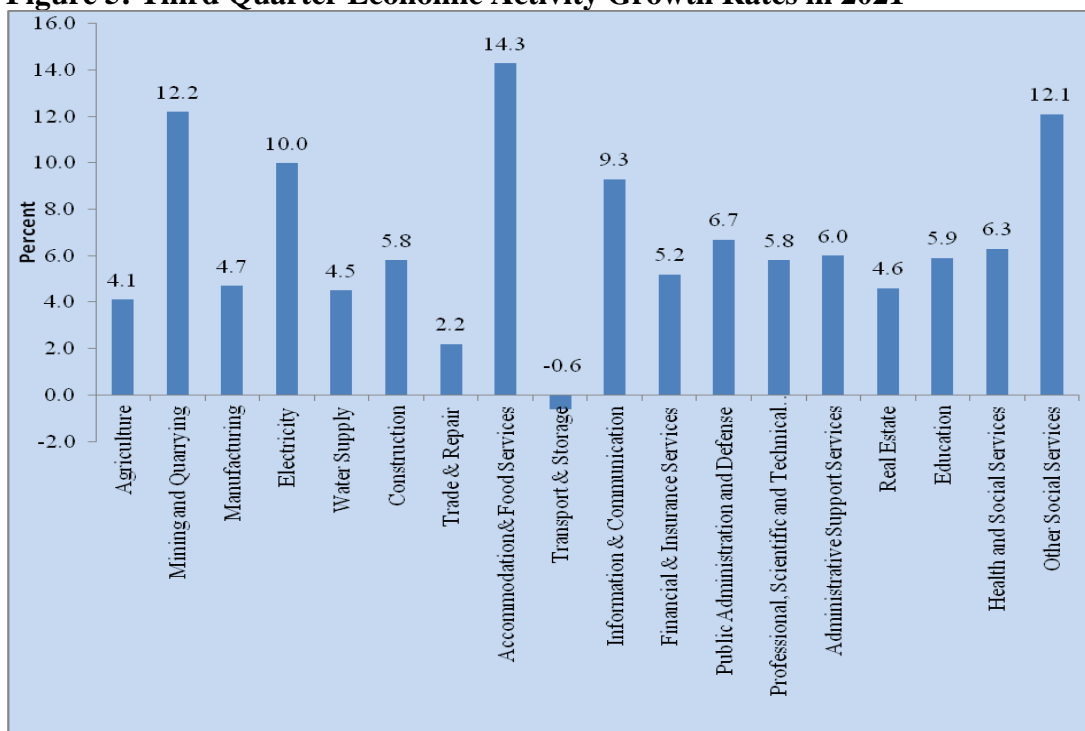

1.5.3 Third Quarter GDP Growth by Economic Activities, 2021

During the period under review, Accommodation and Food Services recorded the highest growth of 14.3 percent, followed by Mining and Quarrying (12.2 percent), Other Services which includes Arts and entertainment, Activities of Households as an Employer (12.1percent); Education (10.3 percent), Electricity Supply (10.0 percent) and Information and Communication (9.3 percent).

1.5.4 Contribution to Growth, Third Quarter 2021

All economic activities undertaken in the economy during the reference period contributed to the growth of 5.2 percent compared with 4.4 percent recorded in the similar period in 2020. Economic activities that contributed significantly to the growth include Construction (18.1 percent), Agriculture (15.1 percent), Mining and Quarrying (11.4 percent); Manufacturing (8.6 percent), Public Administration (5.8 percent); and Trade and Repair (4.0).

2.0 Sectoral Performance

2.1 Agriculture, Forestry and Fishing

This sector includes the exploitation of vegetable and animal natural resources that comprise of growing of crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

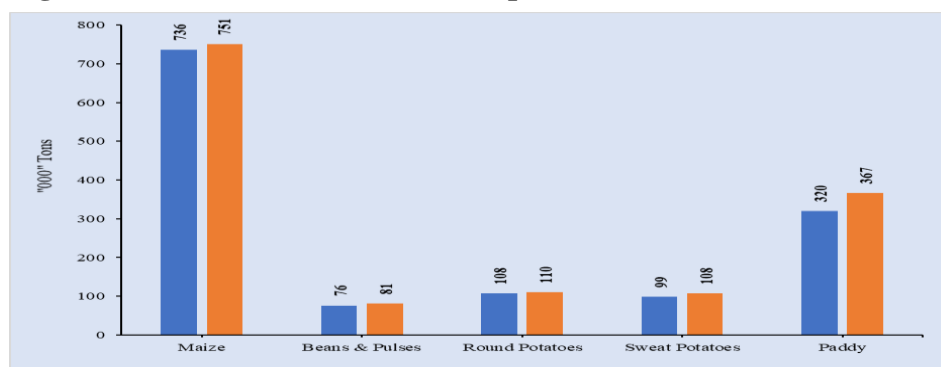
During the period under review, the activity recorded a growth rate of 4.1 percent in 2021 compared to 6.4 percent in the corresponding period in 2020.

2.1.1 Crops

Major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

The activity grew by 7.5 in the third quarter 2021 compared to 9.2 recorded in the similar quarter in 2020. Increase in production of selected crops in figure 6 attributed to the attained growth rate.

Major crops that accounted for performance of the sector include an increase in maize production that increased by 2.0 percent, from 736 million tons in the third quarter in 2020 to 751 million tons in the similar quarter in 2021. Paddy increased by 14.7 percent, from 320 thousand tons in 2020 to 367 thousand tons in the similar quarter in 2021. Sweet potato harvested increased by 9.1 percent, from 99 thousand tons in the third quarter in 2020 to 108 thousand tons in the corresponding quarter in 2021. Round potatoes increased by 1.9 percent, from 108 thousand tons in 2020 to 110 thousand tons in the similar quarter in 2021. Beans and pulses increased by 6.6 percent, from 76 thousand tons in the third quarter in 2020 to 81 thousand tons in the similar quarter in 2021.

2.1.2 Livestock

The activity covers activities of rearing improved and indigenous cattle; goats, sheep, donkeys and horses; guinea pigs and rabbits; indigenous and improved chicken; and other poultry.

During the period under review in 2021, livestock grew by 5.0 percent the same growth rate as observed in 2020. The demand for livestock-based products attributed to the growth due to a significant increase in per capita income, urbanization, taste and preference of consumers as well as increased awareness on food nutrition.

2.1.3 Forestry and Logging

The activity covers production of timber, charcoal, fuel wood and logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity recorded a growth rate of 6.6 percent in the third quarter in 2021 compared to 0.1 percent registered in the similar quarter in 2020. The government intervention to ensure sustainable harvest of forest products attributed to the growth.

2.1.4 Fishing

Fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products.

The activity experienced further contraction to 14.7 percent in the third quarter in 2021 compared to a growth of 10.8 percent registered in the corresponding quarter in 2020. The growth is attributed to the decrease in fish catch during the period under review.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction done can be from underground, on the surface mining or well operations. It also includes supplementary activities aimed at preparing crude materials for marketing, such as crushing and grinding; cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations.

Mining and quarrying activity is divided into four industries namely:

- 1) Mining of coal, lignite, and extraction of peat;
- 2) Crude petroleum and natural gas;
- 3) Mining of metal ores; and
- 4) Other mining and quarrying

The activity recorded a growth rate of 12.2 percent in third quarter in 2021 compared to a growth rate of 4.9 percent recorded during the similar quarter in 2020. The growth was mainly due to an increase in production of gold, coal and gypsum. During the period under review, gold production attributed to the growth rate that increased to 14,915 kg in the third quarter in 2021 from 13,698 kg in the corresponding quarter in 2020.

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity experienced an expansion to 4.7 percent in the third quarter in 2021 compared to 4.9 percent in the similar quarter in 2020. The growth rate was attributed to a general increase in the production of industrial goods.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers provision of electric power and natural gas, through permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are the power generation companies.

During the period of July to September 2021, total electricity generated increased to 2,093 million kWh from 1,920 kWh million generated in the corresponding quarter of 2020. Electricity generated from gas sources accounted for 62.0 percent of the total generation in the reference quarter. The shares of electricity generated from other sources were 36.7 percent from hydro and 1.3 percent from thermal.

The growth of electricity activity is determined by quantity of electricity distributed to various users. During the quarter under review, total electricity distributed increased to 1,807 million kWh from 1,648 million kWh distributed in the similar quarter in 2020. The activity recorded a strong growth rate of 10.0 percent in the third quarter in 2021 compared to 4.4 percent in the similar quarter in 2020.

2.5 Water Supply and Sewerage Services

The activity includes collection and purification of water for water supply purposes, desalting of sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on

own account in agriculture or households. It also includes water distribution activities.

The indicator for the growth of water supply activity is the quantity of water produced. During the period, the quantity of water produced increased to 97.5 million cubic meters from 93.0 million cubic meters recorded in the similar quarter in 2020.

The activity grew at a rate of 4.5 percent in 2021 compared to 7.9 percent in the corresponding quarter in 2020. The growth was attributed to improvement in water production infrastructure, and increased capacity to match water demand due to population growth specifically in urban areas.

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of a temporary nature.

General construction deals with construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., It also includes

construction of civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc .

The activity recorded a marginal growth rate of 5.8 percent in the third quarter in 2021 compared to 13.9 percent in the corresponding quarter in 2020. The growth was attributed to an increase in local production of construction materials like iron and steels which are proxies for construction activities.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sale (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves the buying and selling of goods.

The activity recorded a growth rate of 2.2 percent in the third quarter in 2021 compared to a growth rate of 2.1 in the third quarter in 2020. The growth was due to an increase in traded goods specifically agriculture products and manufactured goods.

2.8 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water or air and associated activities such as cargo handling, storage etc. The activity also includes renting of transport equipment with driver or operator and postal and courier activities.

The activity recorded a negative growth rate of 0.6 in the third quarter in 2021 compared to 7.0 percent recorded in the corresponding quarter of 2020 due to a reduction in passengers and freight transported by road and water.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services recorded a strong growth rate of 14.3 percent in the third quarter in 2021 compared to a negative growth of 25.1 percent recorded in the similar period in 2020. The growth was attributed to a sharp increase in number of tourist arrivals. Tourist arrivals increased to 243,565 in the third of quarter in 2021 from 72,147 recorded in the third quarter in 2020.

2.10 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities and information service activities e.g. data processing; news agencies.

The activity recorded a growth rate of 9.3 percent in the third quarter in 2021 compared to 8.6 percent in the corresponding quarter in 2020. An increase in airtime used by mobile phone customers and the expansion of broadcasting and internet services in the country attributed to the growth experienced.

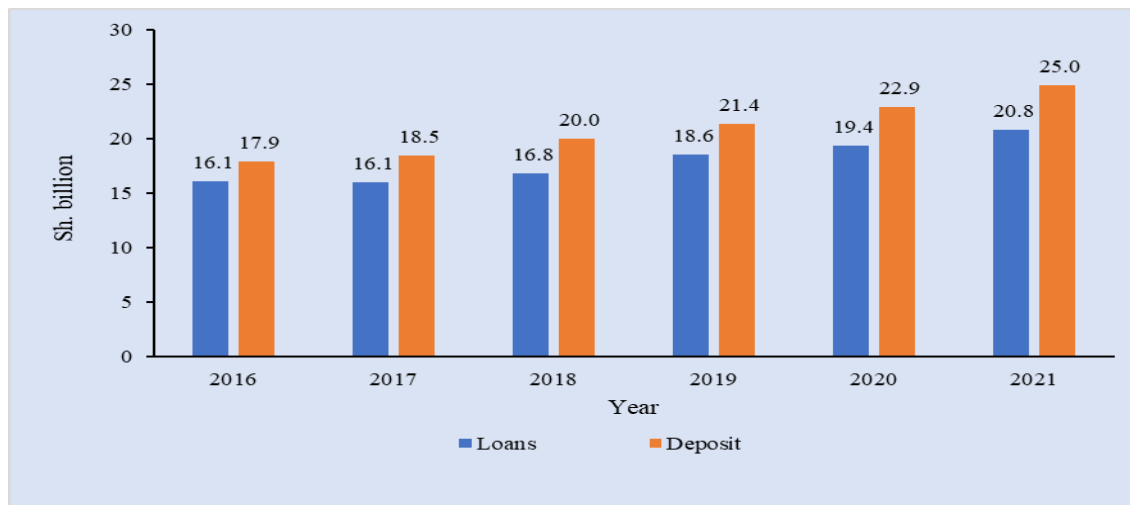

2.11 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, auxiliary to financial service. It also includes the activities of holding assets, such as holding companies, trusts, funds and similar financial entities.

The growth rate of financial activities increased by 5.2 percent in the third quarter in 2021 compared to 1.9 percent in the similar quarter in 2020. The growth was attributed to an increase in level of deposit by 9.1 from TZS 22.9 trillion in the third quarter in 2020 to TZS 25.0 trillion in similar period in 2021. Meanwhile, the level of lending increased by 7.3 percent from TZS 19.4 trillion in 2020 to TZS 20.8 trillion in the similar period in 2021; and an increase in growth rate of insurance services by 5.4 percent in the third quarter in 2021 compared to 3.1 percent in the corresponding quarter in 2020.

2.12 Real Estate

This activity includes selling or buying of real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity recorded the growth rate of 4.6 percent in the third quarter in 2021 compared to 4.5 percent recorded in the third quarter in 2020. The growth was attributed demand for accommodation especially in urban areas.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activities require a high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity recorded a growth rate of 5.8 percent in the third quarter in 2021 compared to 8.6 percent recorded in the similar period in 2020. An increase in professional, legal, and accounting services attributed to the observed growth.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth of 6.0 percent in the third quarter in 2021 compared to 7.7 percent record in 2020. The performance of travel agents and tour operators' activities attributed to the growth.

2.15 Public Administration and Defense; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defense, public order and safety, immigration services, foreign affairs and the administration of government programmes. This activity also includes compulsory social security activities.

The activity growth rate improved significantly to 6.7 percent in the third quarter in 2021 compared to 4.4 percent recorded in the corresponding period in 2020. An increase in government spending in maintaining peace and order as well as provision of social services other than education and health services attributed to the growth.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at its different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

The activity recorded a growth rate of 5.9 percent in the third quarter of 2021 compared to 5.7 percent recorded in the corresponding quarter of 2020. An increase in the number of enrolled students in public and private primary and secondary schools coupled with an increase in government spending in provision of fee-free education services attributed to the growth.

2.17 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

The activity recorded a growth rate of 6.3 percent in the third quarter of 2021 compared to growth rate of 6.0 percent in the similar quarter in 2020.

2.18 Other Social Services

This industry includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification. Other services are Arts and Entertainment; and Activities of Households as Employer.

The activity recorded a growth rate of 12.1 percent in the third quarter in 2021 compared to a negative growth of 0.4 percent recorded in the similar quarter in 2020. An increase in urban population and personal service activities attributed to the growth of the activity.

3.0 Conclusion

During the third quarter in 2021, GDP growth rate increased to 5.2 percent compared to 4.4 percent recorded in 2020. Activities that recorded high growth rates include: Accommodations and Food services (14.3 percent); Mining and Quarrying (12.2 percent); Other Social Services¹ (Arts & entertainment and Activities of household as an employer's, 12.1 percent); Electricity (10.0 percent); Information and Communication (9.3 percent); and Public Administration and Defense (6.7 percent).
