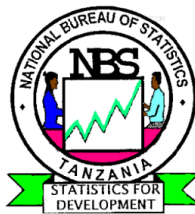

1.0 Introduction

Quarterly Gross Domestic Product (QGDP) reports present detailed information on economic trend at current and constant prices for Mainland Tanzania, to facilitate frequent and appropriate policy interventions through provision of reliable and timely updated data on recent short-term economic developments.

1.1 World Economy

According to the World Economic Outlook (WEO) April 2022 report, the global economy for 2022 is projected at a lower growth of 3.6 percent than the growth of 4.4 percent presented in the WEO January 2022 report. The revised growth is 0.8 percentage point lower than the previous projection. The revision considered supply chain disruptions on account of the on-going Ukraine Russia conflict and the COVID-19 impacts.

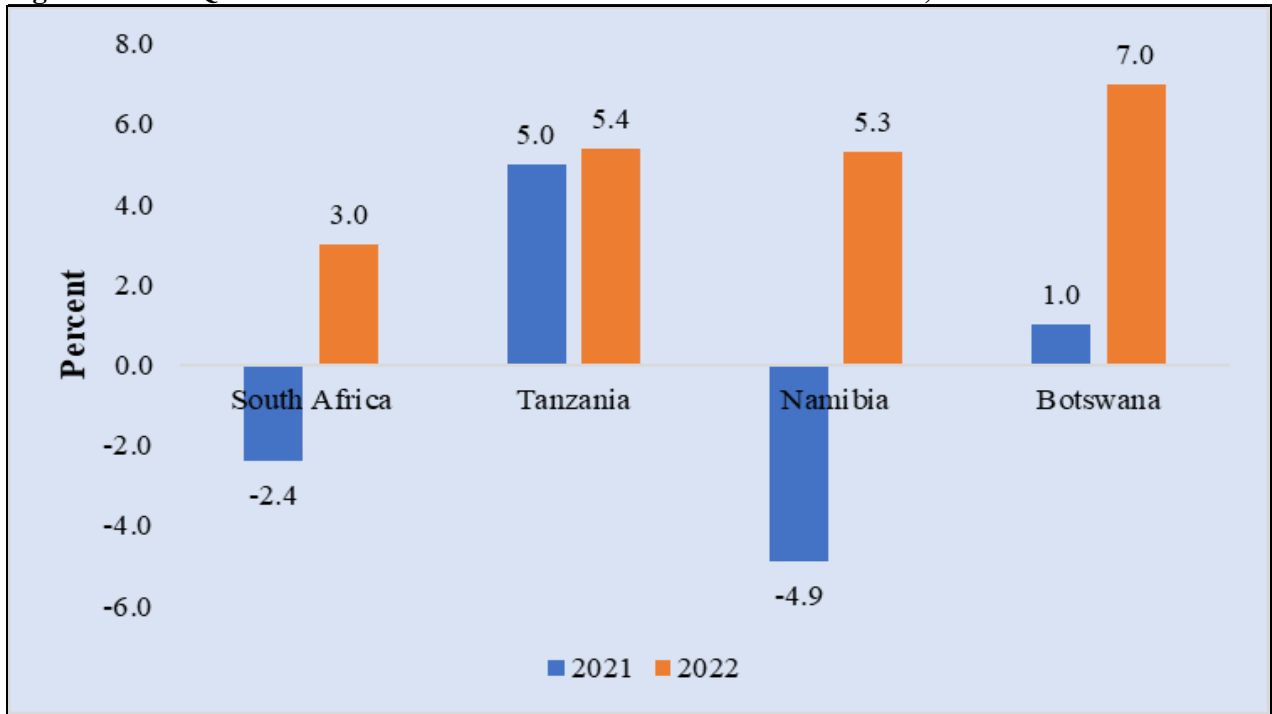
1.2 Sub-Saharan Africa

The projection of economic growth among sub-Saharan Africa countries according to the WEO April 2022 report is estimated at 3.8 percent. The growth is more by 0.1 percentage points than the previous January 2022 projection. South Africa economy is projected to grow at 1.9 percent in 2022 the same growth rate as previously projected in the January 2022 report. Moreover, the economy in Nigeria is projected at 3.4 percent in 2022 up from a growth of 2.7 percent projected in January 2022.

1.3 Southern Africa Development Community

The economy in the Southern Africa Development Community according to the WEO April 2022 report is projected to grow at a higher rate of 3.8 percent than the previous January 2022 projection by 0.1 percentage points. During the first quarter 2022, the economic growth for selected countries in the region show that South Africa's economy expanded to 3.0 percent from a negative growth of 2.4 percent in the similar period in 2021. Other economies in the region include: Tanzania economy expanded to 5.4 percent in 2022 up from 5.0 percent in 2021; Namibia's economy strongly increased to 5.3 percent in 2022 up from a negative growth of 4.9 percent in 2021; and Botswana's economy expanded to 7.0 percent up from 1.0 percent in 2021.

Figure 1: First Quarter GDP Growth Rates for Selected SADC Countries, 2021 and 2022

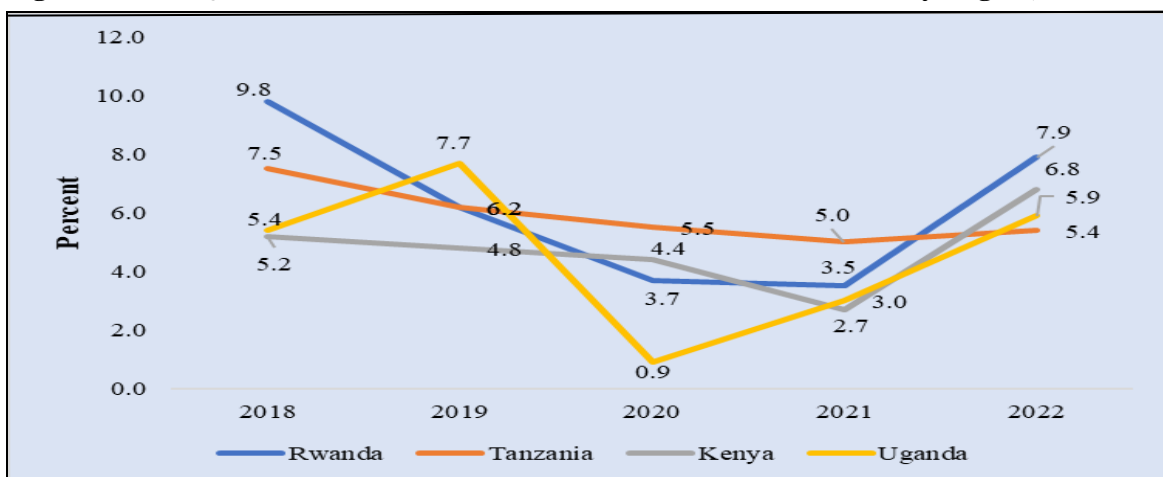

1.4 East Africa Community

Countries in the East African Community that have released reports for the first quarter 2022 show continuous economic recovery during the period under review. Rwanda’s economy expanded to 7.9 percent in 2022 up from 3.5 percent in 2021; Uganda’s economy expanded to 5.9 percent in 2022 up from 3.0 percent in 2021; and Kenya’s economy increased to 6.8 percent up from 2.7 percent in 2021. Meanwhile, Tanzania's economy expanded to 5.4 percent up from 5.0 percent in the similar period in 2021. No reports for the period under review are available from the remaining Partner States.

1.5 GDP Compilation in Tanzania

Compilation of the first quarter GDP (January – March) 2022 used data from all economic activities. GDP Compilation is consistent with the United Nations Statistics Division’s 2008 System of National Accounts. The report presents Gross Domestic Product at current and constant prices for Mainland Tanzania, base year 2015.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in early 2019. The policy allows publication of provisional results subject to availability of new or revised quarterly and/or annual data.

1.5.1 First Quarter GDP Growth Rate 2022

During the first quarter in 2022, Gross Domestic Product (QGDP) in absolute terms at current prices increased to TZS 43.4 trillion up from TZS trillion 38.9 achieved in the similar quarter in 2021. Meanwhile, QGDP at 2015 constant prices also increased to TZS 34.9 trillion up in 2022 from TZS 33.1 trillion in the period under review in 2021, equivalent to a growth of 5.4 percent.

Figure 3: First Quarter GDP Growth Rate, 2014 - 2022

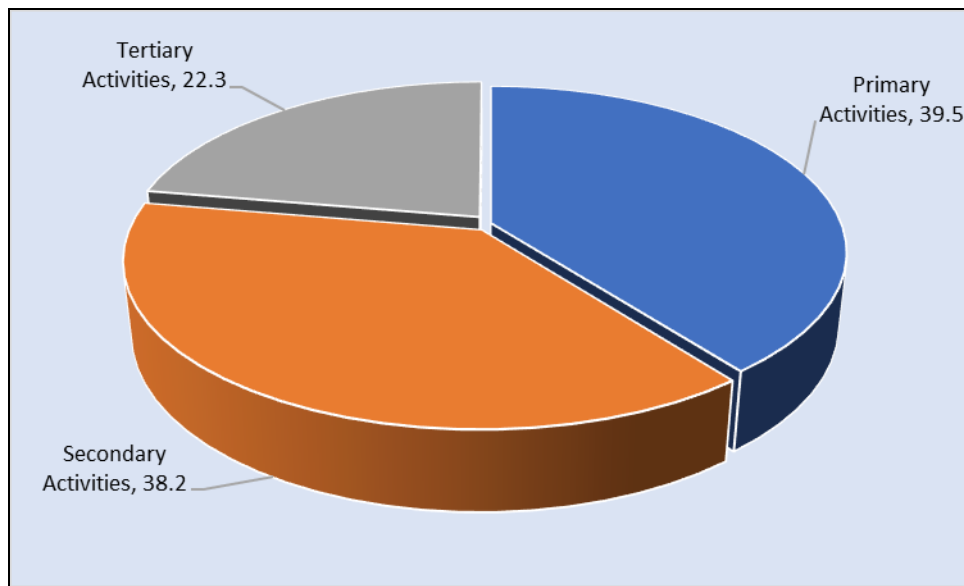

1.5.2 Share to GDP by Broad Economic Classification, First Quarter 2022

During the period under review, analysis of economic activities by Broad Economic Classification (BEC) indicate that, Primary Activities accounted for the largest share to GDP of 39.5 percent, followed by Tertiary activities by 38.2 percent and Secondary activities had the least share of 22.3 percent. Shares to GDP have been derived before adjustment for taxes.

Figure 4: Percentage Share to GDP by Broad Economic Activities at Current Prices

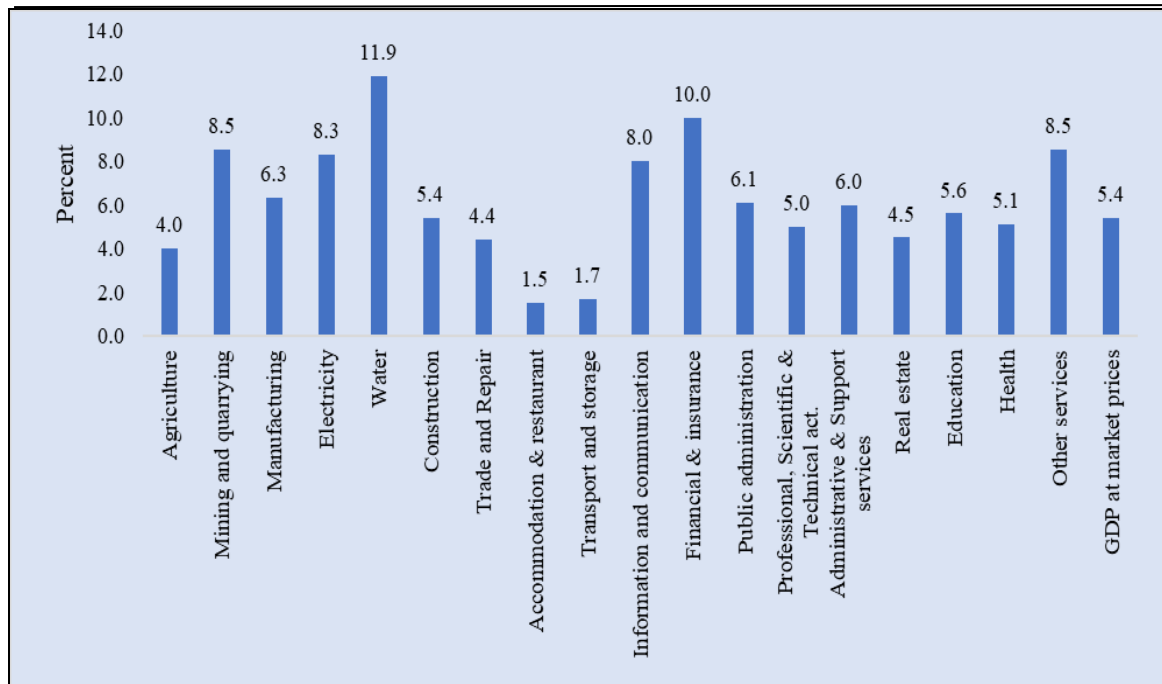

1.5.3 First Quarter GDP Growth by Economic Activities, 2022

During the period of January to March 2022, Water Supply and Sewerage Services attained the highest growth rate of 11.9 percent; followed by Finance and Insurance (10.0 percent); Other Social Services including Arts and Entertainment, and Household Activities as Employer (8.5 percent); Mining and Quarrying (8.5 percent); Electricity (8.3 percent), Information and Communication (8.0 percent); and Public Administration and Defense (6.1 percent).

1.5.4 Contribution to Growth, First Quarter 2021

All economic activities undertaken in the economy during the period of January to March 2022 accounted for the overall growth of 5.4 percent compared to a growth of 5.0 percent attained in the similar period in 2021. Economic activities that significantly contributed to the growth include: Agriculture (19.6 percent), Construction (14.1 percent), Manufacturing (9.0 percent), Construction (14.1 percent), Manufacturing (9.0 percent); Mining and Quarrying (7.1 percent); Trade and Repair (6.7 percent); and Finance and Insurance (6.4).

2.0 Sectoral Performance

2.1 Agriculture, Forestry and Fishing

This sector includes exploitation of vegetable and animal natural resources that comprise of growing of crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

During the period under review, the activity attained a growth rate of 3.9 percent in 2022 down from 5.3 percent achieved in the similar period in 2021.

2.1.1 Crops

Major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

The activity expanded by 3.9 percent in the first quarter in 2022 compared to 1.4 percent recorded in the corresponding quarter in 2021. Increase in crop production as a result of use of technology and inputs; conducive weather in areas of production improved extension services attributed to the attained growth rate.

During the period under review, major crops that accounted for performance of the activity included an increase in paddy production by 18.9 percent, from 465 thousand tons in 2021 to 553 thousand tons in 2022; beans and pulses increased by 3.0 percent, from 167 thousand tons in 2021 to 172 thousand tons in 2022; maize harvested increased by 2.6 percent, from 2.7 million tons in 2021 to 2.8 million tons in 2022; and Sweet Potatoes increased by 0.9 percent, from 342 thousand tons in 2021 to 345 thousand tons in 2022.

2.1.2 Livestock

The activity covers activities of rearing improved and indigenous cattle; goats, sheep, donkeys and horses; guinea pigs and rabbits; indigenous and improved chicken; and other poultry.

During the first quarter in 2022, livestock production increased by 5.0 percent same growth rate as attained in the corresponding period in 2021. The demand for livestock-based products attributed to the growth due to a significant increase in per capita income, urbanization, taste and preference of consumers as well as increased awareness on food nutrition.

2.1.3 Forestry and Logging

The activity covers production of timber, charcoal, fuel wood and logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity attained a growth rate of 3.6 percent up in the first quarter in 2022 from 0.5 percent attained in the similar period in 2021. The government intervention to ensure sustainable harvest of forest and forest products attributed to the growth.

2.1.4 Fishing

Fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products.

The activity recorded 1.7 percent growth rate in the first quarter in 2022 compared to 4.8 percent attained in the corresponding period in 2021. The slow in growth is caused by decrease in fish catch during the period under review.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction done can be from underground, on the surface mining or well operations. It also includes supplementary activities aimed at preparing crude materials for marketing, such as crushing and grinding; cleaning, drying, sorting, concentrating

ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations.

Mining and quarrying activity is divided into four industries namely:

- 1) Mining of coal, lignite, and extraction of peat;
- 2) Crude petroleum and natural gas;
- 3) Mining of metal ores; and
- 4) Other mining and quarrying

The activity increased by 8.5 percent in first quarter in 2022 compared to 9.0 percent observed in the similar quarter in 2021. The growth was mainly attributed to an increase in production of diamond, salt, silver, coal and natural gas. During the period under review, diamond production increased to 115,784 carats in 2022 from 3,571 carats in 2021; coal increased to 452,071 tons in 2022 from 190,932 tons in 2021.

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity expanded to 6.3 percent up in the first quarter in 2021 from 6.1 percent in the similar quarter in 2021. The growth rate was attributed to a general increase in the production of industrial goods.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers provision of electric power and natural gas, through permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are the power generation companies.

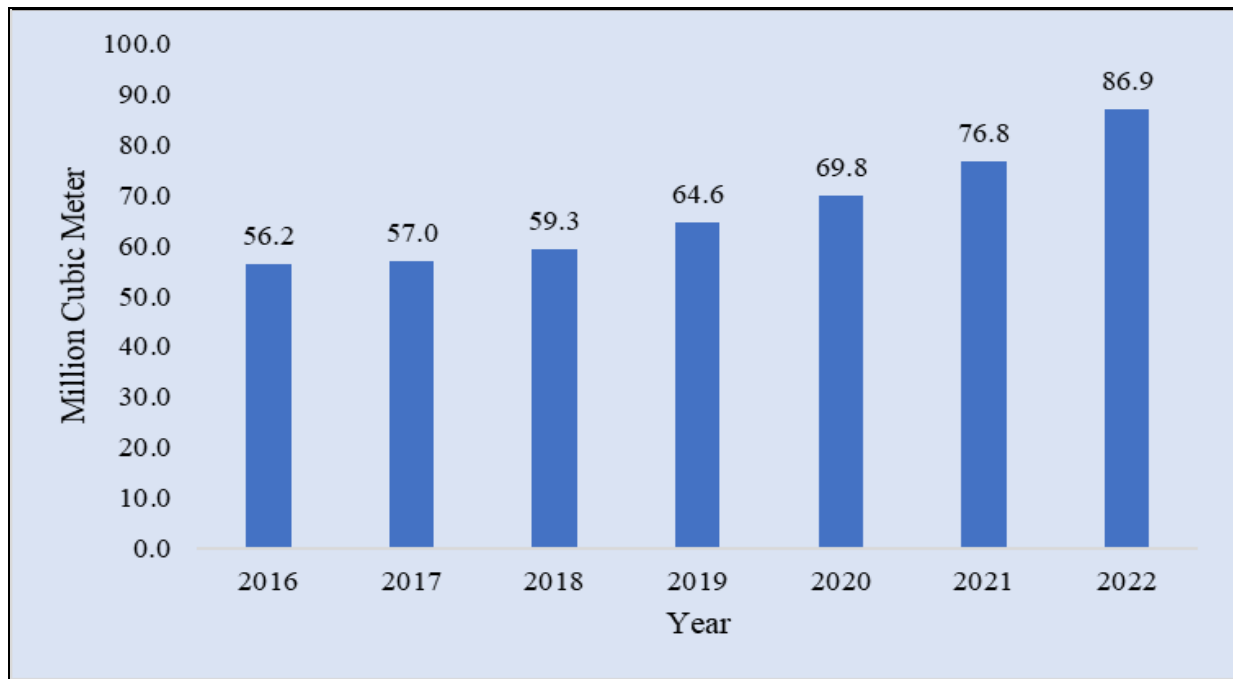
During the period of January to March 2022, total electricity supplied increased to 1,949 million kWh from 1,800 kWh million generated in the corresponding quarter in 2021. The activity recorded a growth rate of 8.3 percent up in the first quarter in 2022 from 7.2 percent in the similar quarter in 2021.

2.5 Water Supply and Sewerage Services

The activity includes collection and purification of water for water supply purposes, desalting of sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on own account in agriculture or households. It also includes water distribution activities.

The indicator for the growth of water supply activity is the quantity of water produced. During the period under review, the quantity of water supplied increased to 86.9 million cubic meters from 76.8 million cubic meters supplied in the corresponding period in 2021. The activity expanded to 11.9 percent in the first quarter in 2022 from 9.0 percent in the similar quarter in 2021. The growth was attributed to further improvement in water production infrastructure and increased capacity to match water demand due to population growth specifically in urban areas.

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of a temporary nature.

General construction deals with construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., It also includes construction of civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc .

The activity expanded by 5.4 percent in the first quarter in 2022 compared to 5.3 percent in the corresponding quarter in 2021. The growth was attributed to an increase in local production of construction materials like iron and steels which are proxies for construction activities.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sale (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It

also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves the buying and selling of goods.

The activity expanded by 4.4 percent in the first quarter in 2022 the same growth rate observed in the corresponding quarter in 2021. The growth was due to an increase in traded goods including agriculture and manufactured goods.

2.8 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water or air and associated activities such as cargo handling, storage etc. The activity also includes renting of transport equipment with driver or operator and postal and courier activities.

The activity recorded a growth rate of 1.7 percent in the first quarter in 2022 compared to 9.0 percent recorded in the corresponding quarter in 2021.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services recorded a growth rate of 1.5 percent in the first quarter in 2022 compared to a negative growth rate of 6.5 percent recorded in the corresponding quarter in 2021. The growth was attributed to a significant increase in tourist arrivals. Tourist arrivals increased to 289,372 in the first quarter in 2022 from 231,131 recorded in corresponding quarter in 2021.

2.10 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities and information service activities e.g. data processing; news agencies.

The activity expanded by 8.0 percent in the first quarter in 2022 compared to 8.3 percent attained in the corresponding quarter in 2021. An increase in airtime used by mobile phone customers and the expansion of broadcasting and internet services in the country attributed to the recorded growth.

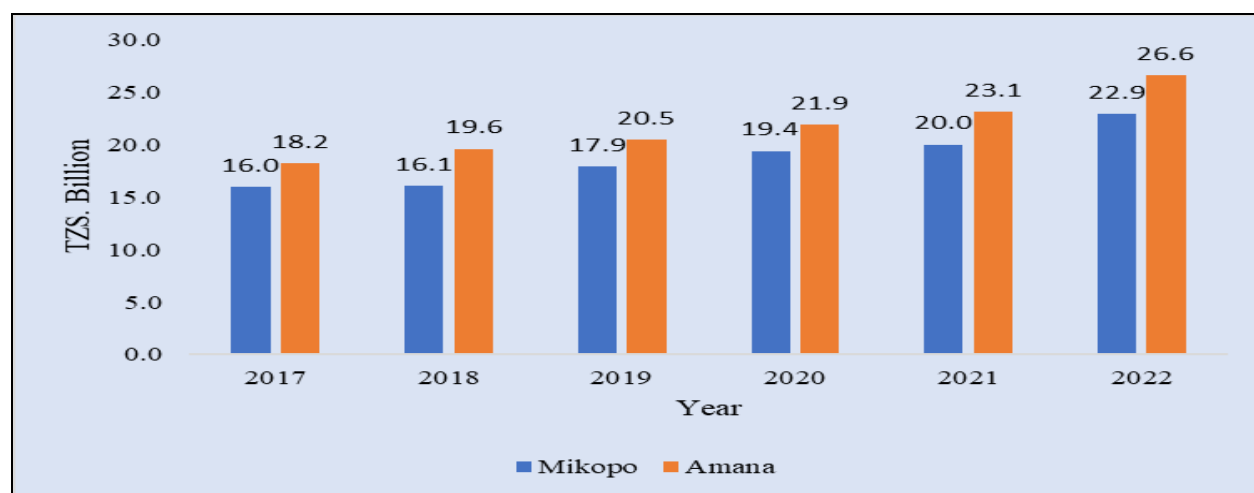

2.11 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, auxiliary to financial service. It also includes the activities of holding assets, such as holding companies, trusts, funds and similar financial entities.

The growth rate of financial services expanded by 10.0 percent in the first quarter in 2022 from 2.7 percent attained in the corresponding quarter in 2021. During the period, an increase in level of deposit by 15.4 percent from TZS 23.1 trillion in 2021 to TZS 26.6 trillion in 2022; meanwhile, the level of lending increased by 15.0 percent from TZS 20.0 trillion in 2021 to TZS 22.9 trillion in 2022. Moreover, an increase in growth rate of insurance services by 6.3 percent in 2022 compared to 9.4 percent in the corresponding quarter in 2021. Growth rates recorded in deposits, lending and insurance services attributed to the noticed growth.

2.12 Real Estate

This activity includes selling or buying of real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity increased at a growth rate of 4.5 percent in the first quarter in 2022 compared to 4.6 attained in the similar quarter in 2021. The growth was attributed to demand for accommodation services specifically in urban areas.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activities require a high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity expanded to 5.0 percent in the first quarter in 2022 compared to 7.8 percent recorded in the corresponding quarter in 2021. An increase in professional, legal, and accounting services attributed to the observed growth.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth of 6.0 percent in the first quarter in 2022 compared to 7.4 percent recorded in the corresponding period in 2021. The performance of travel agents and tour operators' activities attributed to the observed growth.

2.15 Public Administration and Defense; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defense, public order and safety, immigration services, foreign affairs and the administration of government programmes. This activity also includes compulsory social security activities.

The activity growth rate increased to 6.1 percent in the first quarter in 2022 from 2.4 percent attained in the corresponding quarter in 2021. Increased government spending in employees' arrears and maintaining peace and order as well as provision of social services other than education and health services attributed to the growth.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at its different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

The activity increased to 5.6 percent in the first quarter in 2022 from 5.2 percent recorded in the corresponding quarter in 2021. Increased in the number of enrolled students in public and private primary and secondary schools coupled with increased in government spending in provision of fee-free education services attributed to the observed growth.

2.17 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

The activity increased to 5.1 percent in the first quarter in 2022 from 4.8 percent in the corresponding quarter in 2021. The growth was consistent with availability of improved health and social work services.

2.18 Other Social Services

This industry includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification. Other services are Arts and Entertainment; and Activities of Households as Employer.

The activity expanded to 8.5 percent in the first quarter in 2022 from 6.6 percent observed in the similar quarter in 2021. increased tourist arrivals and urban population as well as provision of personal services attributed to the growth.

3.0 Conclusion

During the first quarter in 2022, real GDP growth increased to 5.4 percent from 5.0 percent recorded in the corresponding quarter in 2021. Activities that recorded significant growth rates included: Water supply and sewerage services (11.9 percent); Finance and Insurance (10.0 percent); Mining and Quarrying (8.5 percent); Other Social Services¹ (8.5 percent), Electricity (8.3 percent); and Information and Communication (8.0 percent).
