1.0 Introduction

The Quarterly Gross Domestic Product is an economic indicator that facilitates frequent and appropriate policy interventions by providing reliable and timely reports on recent short-term economic developments in a country.

1.1. Global Economy

The annual global economy is projected to grow at 6.0 percent in 2021 compared to a negative growth of 3.3 recorded in 2020. The outturns in 2021 are higher-than-expected growth for most regions in the post COVID-19 period. Countries are implementing combination of measures including lockdowns, adaption to new ways of working and additional fiscal support in a few large economies and the anticipated vaccine-powered recovery in the second half of the year to boost economic growth. Employment and earnings have severely hit young people, women, workers with relatively lower educational attainment, and the informally employed. Moreover, countries that rely on tourism and commodity exports and for those with limited policy space to respond to COVID-19 economic impact also suffered.

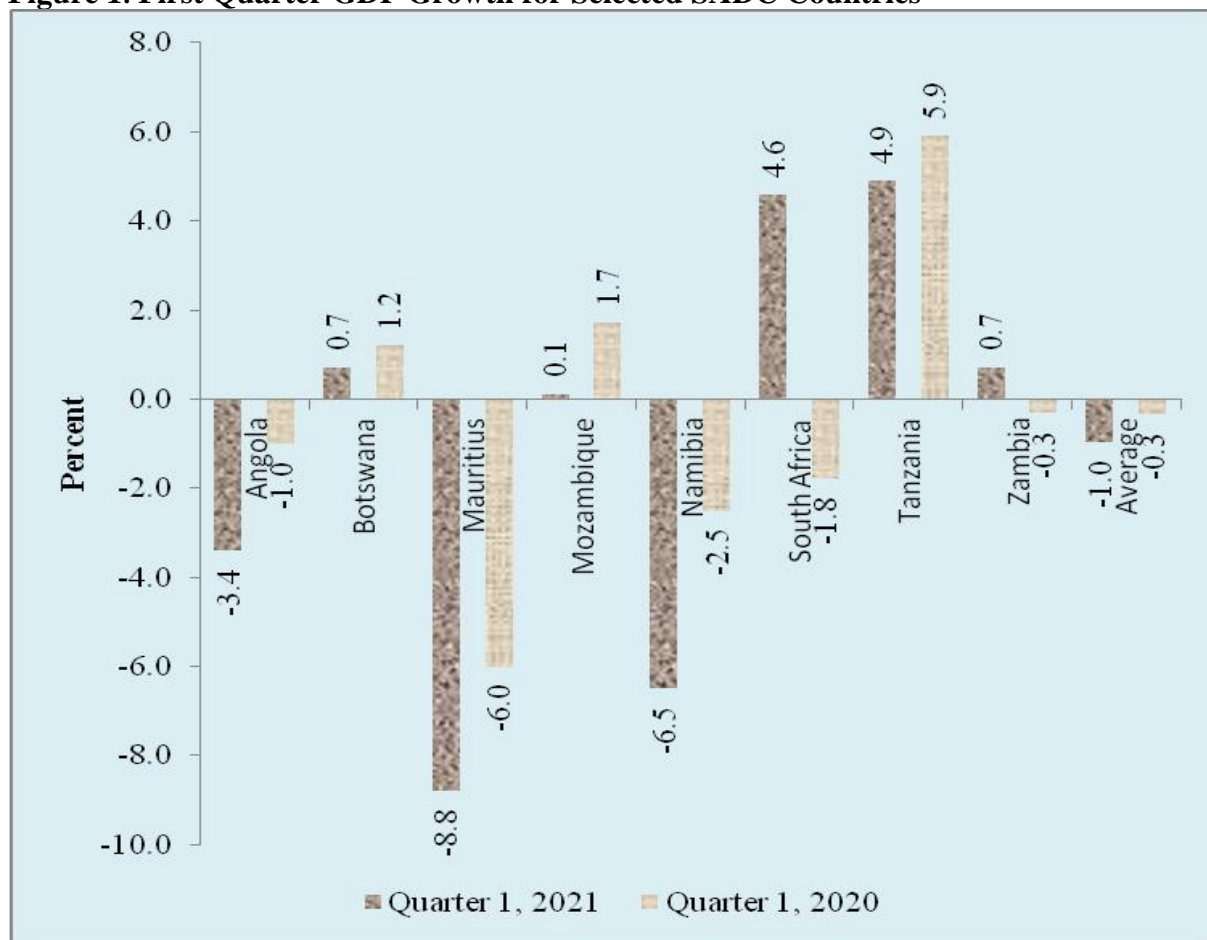
1.2. Sub Saharan Africa

Sub Saharan Africa economy recorded the largest annual negative growth of 1.9 percent in 2020 and is projected to recover from COVID-19 effects and grow at 3.4 percent in 2021. Tourism-reliant economies were the most affected in 2020 and will continue to hit hard these economies. Lockdown measure has been introduced in the source markets resulted in affecting host markets that limit the flow of tourists consequently affecting host economies.

1.3. Southern Africa Development Community

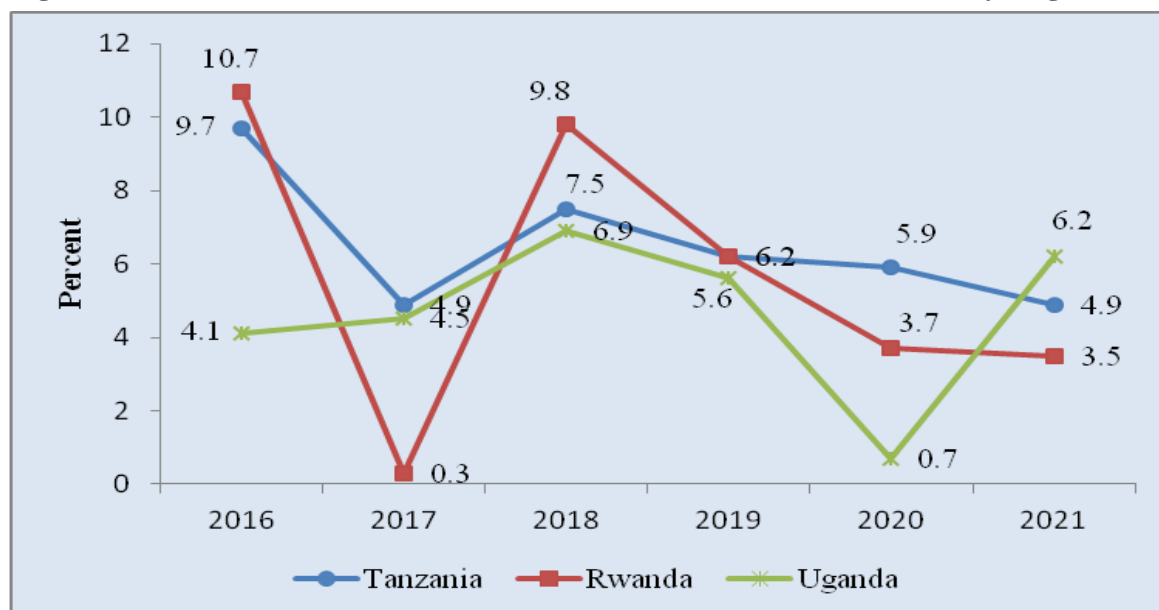
Figure 1: First Quarter GDP Growth for Selected SADC Countries

During the first quarter (January - March) 2021, Southern Africa Development Community (SADC) region also experienced economic disruptions as a result of COVID-19 pandemic since its eruption in 2019 and thereafter. The average economic performance for selected countries in the region experienced a deeper negative growth of 1.0 in the first quarter of 2021 compared to a negative growth of 0.3 in the corresponding quarter of 2020 (Figure 1).

1.4. East Africa Community

The economic performance in the East Africa (EAC) Region during the reference period in 2021 showed that, Rwanda's economy recorded a growth of 3.5 percent compared to 3.7 percent recorded in 2020. Tanzania economy recorded a growth rate of 4.9 percent compared to a growth rate of 5.9 percent in 2020 and Uganda recorded a growth rate of 6.2 percent compared to 0.7 in 2020. Kenya, Burundi, and South Sudan have not yet released respective quarterly GDP reports for the period under review.

1.5. Growth in Tanzania

Data from all economic activities were used to compile first quarter (January – March) GDP for the year 2021. The United Nation Statistics Division’s guideline on the compilation of national accounts statistics known as the System of National Accounts 2008 was followed. The report presents Quarterly Gross Domestic Product (QGDP) at current and constant prices for Tanzania Mainland, using the 2015 base year.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in early 2019. The policy allows publication of provisional results subject to availability of new or revised quarterly and/or annual data.

1.5.1 First Quarter GDP Growth, 2021

During the first quarter of 2021, the value of QGDP in absolute terms at current prices increased to TZS 38.0 trillion from TZS 36.4 trillion in the similar quarter of 2020. Further, the value of QGDP at constant prices increased to TZS 33.2 trillion in the first quarter of 2021 from TZS 31.7 trillion in the corresponding quarter of the year 2020 which is equivalent to a growth of 4.9 percent. Meanwhile, annual economic growth is projected to grow at 5.7 percent in 2021.

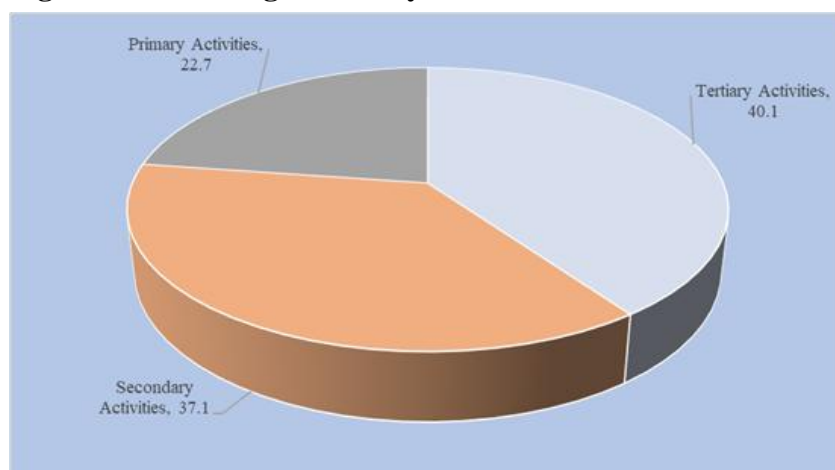
Figure 3: First Quarter GDP Growth Rates, From 2015 - 2021



1.5.2 Share to GDP by Broad Economic Classification, First Quarter 2021

In accordance with the Broad Economic Classification (BEC), the largest share¹ to GDP in the first quarter of 2021 was from Tertiary activities accounting to 40.1 percent, followed by Primary activities by 37.1 percent and Secondary activities had the least share of 22.7 percent (before tax adjustment).

Figure 4: Percentage Share by Broad Economic Activities at Current Prices



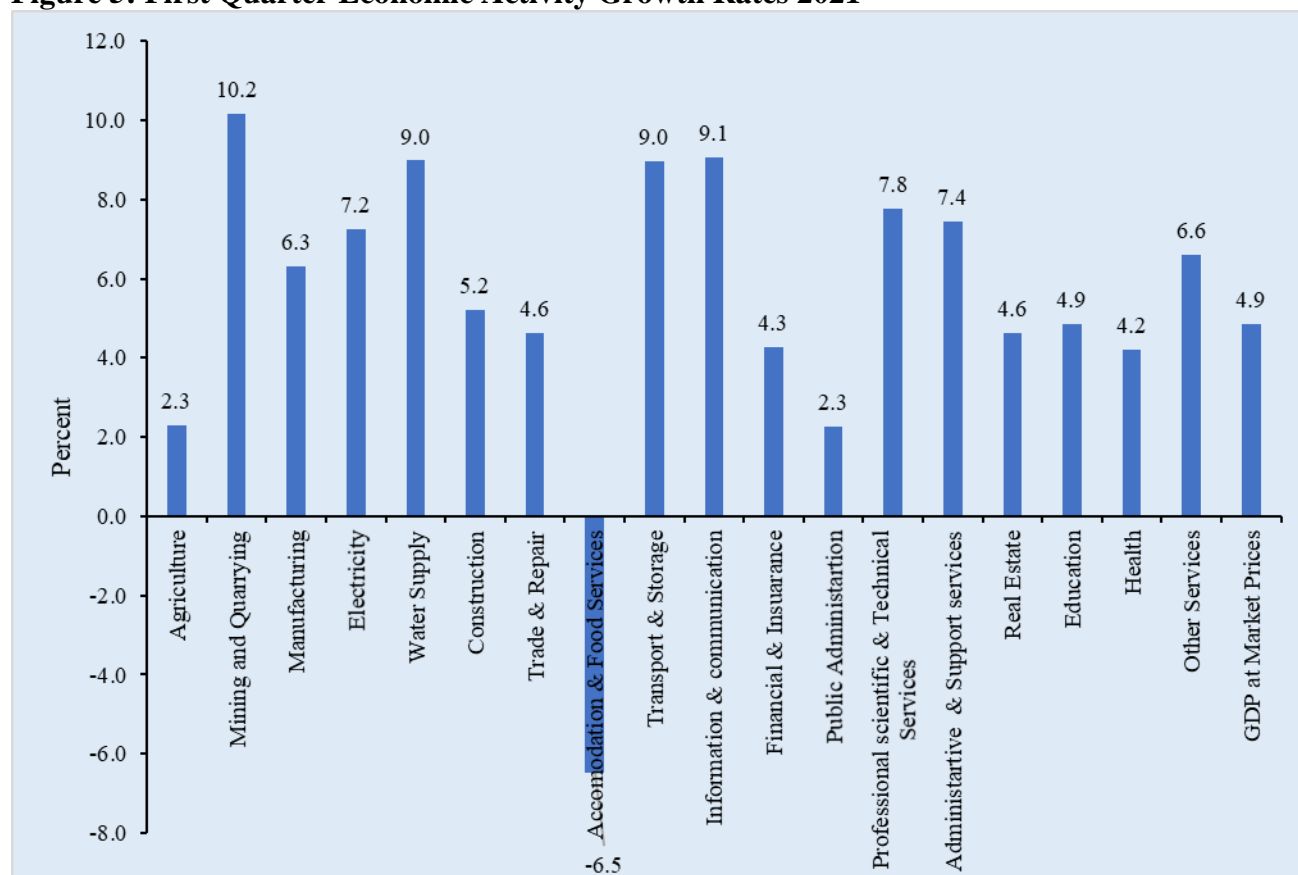
1.5.3 First Quarter GDP Growth by Economic Activities, 2021

During the first quarter (January - March) 2021, Mining and Quarrying recorded the highest growth of 10.2 percent, followed by Information and Communication (9.1 percent); Transport and Storage (9.0 percent); Water Supply (9.0 percent),

Professional Scientific and Technical services (7.8 percent); Administrative Support Services (7.4 percent) and Electricity (7.2 percent).

1.5.4 Contribution to Growth, First Quarter 2021

The first Quarter GDP in 2021 recorded a growth of 4.9 percent. All economic activities contributed to the observed overall growth. Economic activities that mainly contributed to growth were: Construction (14.9 percent); Transport and Storage (14.6 percent); Agriculture (12.7 percent); Manufacturing (9.8 percent) and Mining and Quarrying (8.8 percent).

2.0 Sectoral Performance

2.1 Agriculture, Forestry and Fishing

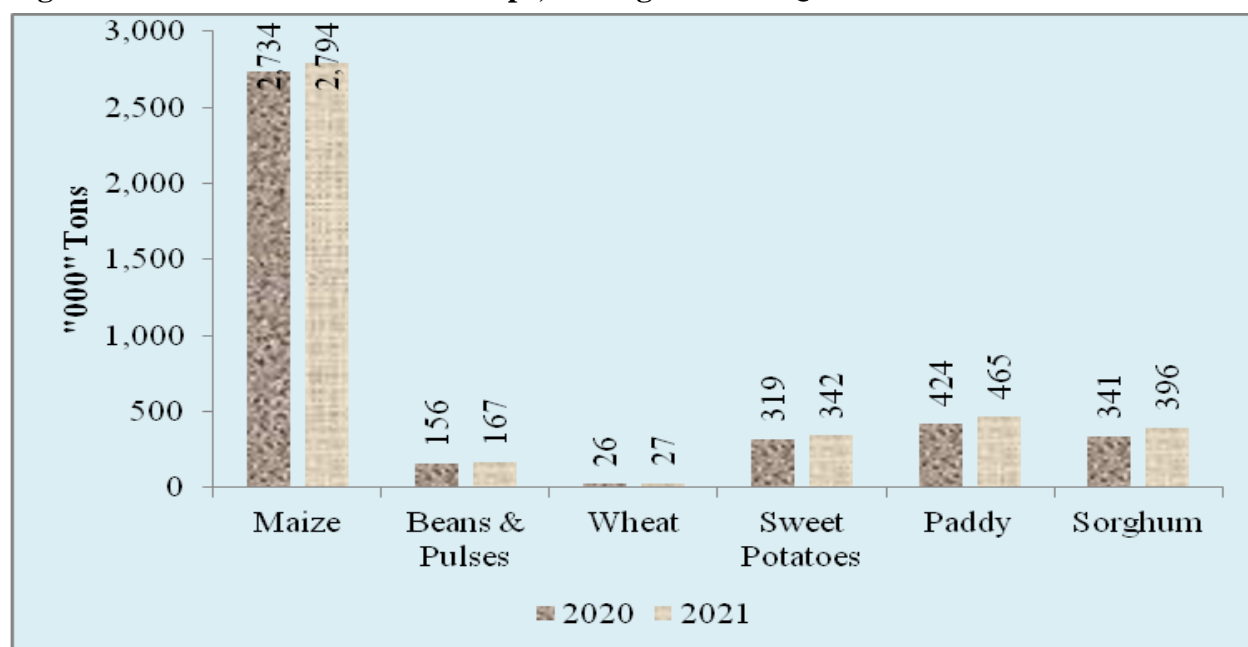
These activities include the exploitation of vegetable and animal natural resources that comprise of growing of crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

2.1.1 Crops

The major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

Crop production slightly increased by 1.6 percent in the first quarter of 2021 compared to 3.8 percent of the corresponding quarter of 2020. Above average rainfall received in areas of the production during the onset of short rain season, resulted to slight increase in growth.

Major crops that accounted for such an increase include maize that increased by 2.2 percent, from 2.734 million tons in the first quarter of 2020 to 2.794 million tons in the corresponding quarter of 2021. Beans and pulses increased by 6.9 percent, from 156 thousand tons in the first quarter of 2020 to 167 thousand tons in the similar quarter of 2021. Sorghum harvested increased by 16.2 percent, from 341 thousand tons in the first quarter of 2020 to 396 thousand tons in the first quarter of 2021. Wheat increased by 1.4 percent, from 26 thousand tons in 2020 to 27 thousand tons in the similar quarter of 2021. Paddy increased by 9.6 percent, from 424 thousand tons in 2020 to 465 thousand tons in the similar quarter of 2021.

2.1.2 Livestock

The activity covers activities of rearing improved and indigenous cattle; goats; sheep; donkeys and horses; guinea pigs and rabbits; indigenous and commercial chicken; and other poultry.

Livestock activity registered a growth rate of 5.0 percent in the first quarter of 2021 compared to 4.9 percent recorded in 2020. The growth was attributed to the demand for livestock products, significant increase in per capita income, urbanization, taste and preference as well as increased awareness on food nutrition.

2.1.3 Forestry and Logging

The activity covers production of timber, charcoal, fuel wood and Logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity recorded a slight growth rate of 0.5 percent in the first quarter of 2021 compared to 7.0 percent registered in the similar quarter of 2020. The government intervention to ensure sustainable harvest of forest products attributed to the growth.

2.1.4 Fishing

The fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products.

The activity recorded a negative growth of 0.6 percent in the first quarter of 2021 compared to a growth of 0.1 percent registered in the corresponding quarter of 2020. The growth attributed to the decrease in fish catch during January to March 2021.

2.2 Mining and Quarrying

Mining and quarrying include extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction can be from underground, on the surface, mining or well operation. It also includes supplementary activities aimed at preparing the crude materials for marketing, for

example, crushing and grinding; cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations.

Mining and quarrying activity is divided into four industries, which are:

- 1) Mining of coal, lignite, and extraction of peat;
- 2) Crude petroleum and natural gas;
- 3) Mining of metal ores; and
- 4) Other mining and quarrying

The activity recorded a growth rate of 10.2 percent in first quarter of 2021 compared to a growth rate of 15.4 percent recorded during the similar quarter of 2020. The growth was mainly due to an increase in production of Gold, Coal and Gypsum. During the period under review, gold production increased to 14,504.42 kg in the first quarter of 2021 from 12,404.32 kg in the corresponding quarter of 2020.

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity recorded a growth of 6.3 percent in the first quarter of 2021 compared to 4.7 percent in the similar quarter of the year 2020. An increased in the production of industrial goods in general attributed to the growth.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers provision of electric power and natural gas, through a permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves

generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are the power generation companies.

During the reference quarter, the activity recorded a growth rate of 7.2 percent compared to a growth of 6.2 percent recorded in the corresponding quarter of 2020.

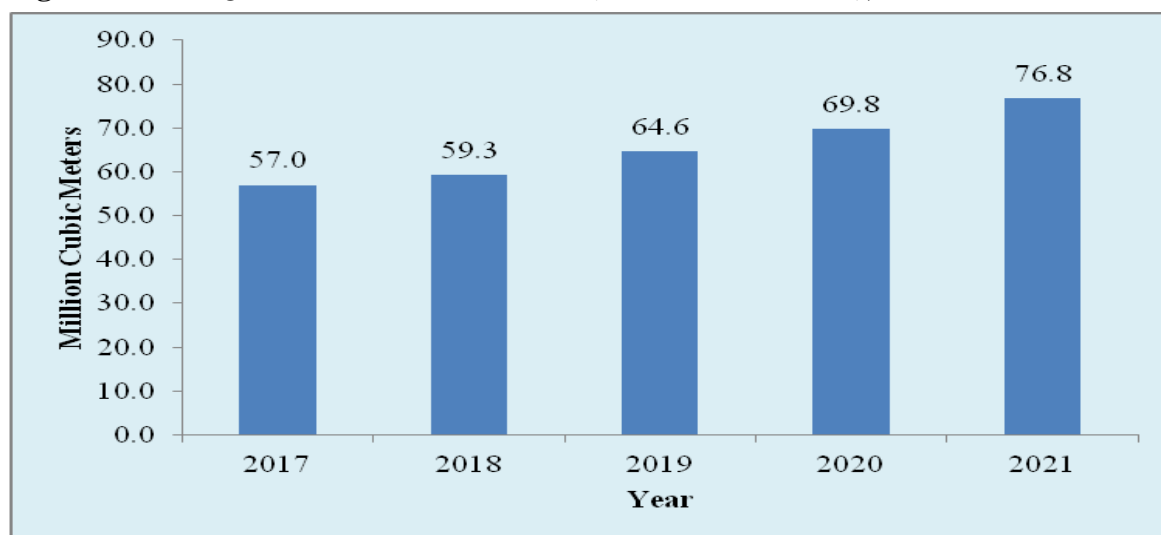
2.5 Water Supply and Sewerage

The activity includes collection and purification of water for water supply purposes, desalting of sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on own account in agriculture or households. It also includes water distribution activities.

The indicator for growth of the activity is the quantity of water produced. In the first quarter of 2021, the quantity of water produced increased to 76.8 million cubic meters from 69.8 million cubic meters recorded in the similar quarter of 2020.

During the quarter under review, the activity recorded the growth rate of 9.0 percent in the first quarter of 2021 compared to 7.2 percent in the similar quarter of 2020. Improvement in water production infrastructure, increased capacity, and production to match the water demand resulted from population increase especially in urban areas among others attributed to the growth of the activity.

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of a temporary nature.

General construction is the construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., it also includes construction in civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc.

The activity recorded a growth rate of 5.2 percent in the first quarter of 2021, compared to 4.9 percent in the corresponding quarter of 2020. Construction activity increased in line with increased local production of construction materials such as iron and steels that are proxy of construction activity.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sale (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves the buying and selling of goods.

The activity recorded a growth rate of 4.6 percent in the first quarter of 2021 compared to a growth rate of 4.8 percent observed in the similar quarter of 2020. The growth was attributed to an increase in all traded goods specifically agriculture products.

2.8 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water or air and associated activities such as cargo handling, storage etc. The activity also includes renting of transport equipment with driver or operator and postal and courier activities.

Transport and storage activity increased at the rate of 9.0 percent in the first quarter of 2021 compared to 8.3 percent in the first quarter of 2020. An increase in the number of passengers carried and freight handled during the period under review attributed to the growth.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services recorded a negative growth of 6.5 percent in the first quarter of 2021 compared to a growth rate of 2.6 percent recorded in the similar quarter of 2020. A decrease in number of tourist arrivals due to lockdown measures introduced in source markets to manage COVID-19 effects resulted into the negative growth. The number of tourist arrivals decreased to 231,131 in the first quarter of 2021 from 336,510 in the similar quarter of 2020.

2.10 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities and information service activities e.g. data processing; news agencies.

The activity recorded a growth rate of 9.1 percent in the first quarter of 2021 compared to 8.2 percent in the corresponding quarter of 2020. An increase in airtime used by mobile phone customers and the expansion of broadcasting and internet services in the country attributed to the growth of the activity.

2.11 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, auxiliary to financial service. It also includes the activities of holding assets, such as holding companies, trusts, funds and similar financial entities.

The activity recorded a growth rate of 4.3 percent in the first quarter of 2021 compared to a growth rate of 4.1 percent in the similar quarter of 2020. The growth was attributed to an increase by 5.4 percent in level of deposits from 21.9 trillion in 2020 to 23.1 trillion in 2021; an increase by 2.7 percent in level of lending from 19.4 trillion in 2020 to 20.0 trillion in 2021; and increase in services provided by insurance companies attributed to the recorded growth.

2.12 Real Estate Activity

This activity includes selling or buying of real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity recorded a growth rate of 4.6 percent in the first quarter of 2021 compared to growth rate of 4.5 percent recorded in the first quarter of 2020. A slight increase in demand for accommodation especially in urban areas attributed to the growth.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activities require a high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity recorded a growth rate of 7.8 percent in the first quarter of 2021 compared to a growth rate 8.9 percent in the corresponding quarter in 2020. An increase in other professional, legal, and accounting services attributed to the growth.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth rate of 7.4 percent in the first quarter 2021 compared to a growth rate of 8.0 percent in the first quarter 2020. A slight increase in the performance of travel agent and tour operators' activities accounted for the growth.

2.15 Public Administration and Defence; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defence, public order and safety, immigration services, foreign affairs and the administration of government programmes. This activity also includes compulsory social security activities.

The activity recorded a growth rate of 2.3 percent in the first quarter of 2021 compared to a growth rate of 5.0 percent in the corresponding quarter of 2020. Government spending in maintaining peace and order and provision of social services during the period under review accounted for the growth.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at its different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

The activity recorded a growth rate of 4.9 percent in the first quarter of 2021 compared to a growth rate of 5.4 percent in the similar quarter of 2020. An increase in the number of enrolled students in public primary and secondary schools, private schools together with an increase in government spending in provision of fee-free education services attributed to the growth.

2.17 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

The activity recorded a growth rate of 4.2 percent in the first quarter of 2021 compared to growth rate of 9.9 percent in the similar quarter of 2020.

2.18 Art, Entertainment and Recreation

This activity includes a wide range of activities with the objective of meeting varied cultural, entertainment and recreational interests of the public including live performances, operation of museum sites, gambling, sports and recreation activities.

The activity recorded a negative growth rate of 5.3 percent in first quarter 2021 compared to 11.4 percent recorded in the corresponding quarter of 2020. A decrease in number of tourist arrivals resulted in the negative growth of the activity.

2.19 Other Services Activities

This industry includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification.

The activity recorded a growth rate of 7.8 percent in the first quarter 2021 compared to 6.0 percent in the first quarter of 2020. An increase in the urban population and personal services attributed to the growth of the activity.

2.20 Activities of Households as Employers

Activities of households as employers include domestic personnel such as maids, cooks, waiters, valets, butlers, laundresses, gardeners, gatekeepers, chauffeurs, caretakers, governesses, babysitters, tutors, secretaries etc. The activity allows the domestic personnel employed to state the activity of their employer in censuses or studies, even though the employer is an individual. The employing household consumes the product produced by this activity.

The activity increased at 3.1 percent in the first quarter of 2021 similar to the rate recorded in the corresponding quarter of 2020. An increase in the urban population attributed to the growth of this activity.

3.0 Conclusion

The QGDP facilitates frequent and appropriate policy interventions by providing reliable and timely reports on recent short-term economic developments. GDP recorded a growth rate of 4.9 percent in 2021 compared to 5.9 percent recorded in 2020. Activities that recorded higher growth rates were: Mining and Quarrying (10.2 percent); Information and Communication (9.1 percent); Transport and Storage (9.0

percent); Water Supply (9.0 percent), Professional Scientific and Technical services (7.8 percent), Administrative Support services (7.4 percent), and Electricity (7.2 percent).
