1.0 Introduction

This report presents Quarterly Gross Domestic Product (QGDP) at current and constant prices for Tanzania Mainland, base year 2015. The QGDP facilitates frequent and appropriate policy interventions by providing reliable and timely reports on recent short-term economic developments.

1.1. World Economy

According to the World Economic Outlook (WEO) January 2023 report, the global economy in 2022 was projected to grow at 3.4 percent higher than 3.2 percent forecasted in the WEO October 2022 report. Meanwhile, global economic growth estimates for 2023 is revised to 2.9 percent, higher by 0.2 percentage points than projected growth in the WEO October 2022 report. The 2022 revision considered surprisingly, strong performance of real GDP in the third quarter of 2022 in numerous economies, including the United States, the euro area, and major emerging market and developing economies. The sources of these surprises were in many cases domestic: stronger-than-expected private consumption and investment amid tight labor markets and greater-than-anticipated fiscal support. Households spent more to satisfy pent-up demand, particularly on services, partly by drawing down their stock of savings as economies reopened. Business investment rose to meet demand. On the supply side, easing bottlenecks and declining transportation costs reduced pressures on input prices and allowed for a rebound in previously constrained sectors, such as motor vehicles. Energy markets have adjusted faster than expected to the shock from Russia's invasion of Ukraine.

1.2. Sub-Saharan Africa

According to the WEO January 2023 report, economic growth among sub-Saharan Africa countries is projected at 3.8 percent equivalent to 0.1 percentage points higher than previous projection in the WEO October 2022 report. South Africa economy is projected to grow at a rate of 2.6 percent in 2022 with an increase of 0.1 percentage points compared to the October 2022 WEO projections. In addition, Nigeria economic growth projection is revised to 3.0 percent in January WEO projection which is 0.2 percentage points higher compared to the WEO October 2022 projection.

1.3. Southern Africa Development Community

According to the WEO January 2023 report, economic growth in the region is expected to grow by 3.8 percent, which is 0.1 percentage points higher than the WEO October 2022 projection. Economic growth for South Africa increased by 0.9 percent in the fourth quarter 2022 compared to 1.7 percent increase over a similar period in 2021. Namibia's economy grew by 4.1 percent in the fourth quarter 2022 compared to 3.1 percent in the similar period in 2021. Botswana economy grew by 5.9 percent in the fourth quarter 2022 compared to 6.0 percent in the similar period in 2021. The Tanzania economy has grown at a rate of 3.6 percent in the fourth quarter 2022 compared to 5.5 percent recorded in a similar period in 2021.




Figure 1: Fourth Quarter GDP Growth Rates for Selected SADC Countries, 2021 and 2022

1.4. East Africa Community

The East African Community countries that have already reported economic performance in the fourth quarter 2022 as at 27th April 2023 show that Rwanda's economy grew by 7.3 compared to 10.3 percent recorded in the fourth quarter 2021. Uganda's economy increased by 4.4 percent in the fourth quarter 2022 compared with a growth of 4.9 percent recorded in the same period in 2021. Meanwhile, Tanzania's economy recorded a growth rate of 3.6 percent in the fourth quarter in 2022 compared to 5.5 percent recorded in the fourth quarter in 2021.




Figure 1: Fourth Quarter GDP Growth in the East Africa Community Region, 2018 - 2022

1.5. GDP Compilation in Tanzania

Compilation of the fourth quarter GDP (October – December) 2022 used data from all economic activities. Compilation followed the United Nations Statistics Division's guideline known as the 2008 System of National Accounts. The report presents Gross Domestic Product at current and constant prices for Tanzania Mainland, using the 2015 base year.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in 2019. The policy allows publication of provisional results subject to availability of new or revised quarterly and/or annual data. In line with the GDP revision policy, the improvement made on the balance of payment statistics by Central Bank has necessitated the revision of GDP from 2017 - 2022.

1.5.1 Fourth Quarter 2022 GDP Growth Rate

During the fourth quarter 2022, the value of Quarterly Gross Domestic Product (QGDP) in an absolute term at current prices increased to TZS 46.1 trillion up, from TZS 42.1 trillion in the similar quarter in 2021. Further, the value of real QGDP (at

2015 prices) also increased to TZS 38.2 trillion in the fourth quarter 2022 up, from TZS 36.8 trillion in a similar period in 2021 equivalent to the growth rate of 3.6 percent.




Figure 2: Fourth quarter GDP Growth Rate from 2018 - 2022

1.5.2 **Share to GDP by Broad Economic Classification**

Primary activities accounted for the largest GDP share (41.5 percent) in the fourth quarter 2022, followed by Tertiary activities (36.1 percent) and Secondary activities (22.5 percent). Note that, shares to GDP have been computed before adjustment for taxes.




Figure 3: Percentage Share to GDP by Broad Economic Activities at Current Prices

1.5.3 Fourth Quarter GDP Growth by Economic Activities, 2022

During the period under review, mining and quarrying activity recorded the highest growth of 18.0 percent, followed by financial and insurance (12.3 percent), other services which includes arts & entertainment and activities of household as an employer (9.4 percent), accommodation and food services (percent 8.5), information and communication (6.1 percent) and professional, scientific and technical services (5.9 percent).




Figure 4: Fourth Quarter GDP 2022 Growth Rates

1.5.4 Contribution to Growth

All economic activities undertaken in the economy in the reference period contributed to the growth of 3.6 percent compared with 5.5 percent recorded in the similar period in 2021. Economic activities which had significant contribution to growth include; mining and quarrying (23.0 percent), agriculture (18.0 percent), construction (9.5 percent), financial and insurance (7.5 percent), wholesale and retail trade (6.2 percent), transport and storage (5.5 percent), and public administration (5.1 percent).

2.0 Sectoral Performance

2.1 Agriculture, Forestry and Fishing

This sector includes exploitation of vegetable and animal natural resources that comprise of growing of crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

2.1.1 Crops

Major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

This activity grew by 1.2 in the fourth quarter 2022 compared to 5.2 recorded in the similar quarter in 2021. The growth was caused by low rainfall in areas of the production during the onset of the long rain season.




Figure: Production of Selected Crops, fourth Quarter 2021 and 2022

Major crops which contributed to such increase include harvested banana which increased by 24.7 percent from 255 thousand tons in the fourth quarter of 2021 to 319 thousand tons in the fourth quarter of 2022. Paddy increased by 24.7 percent

from 769 thousand tons in 2021 to 823 thousand tons in the similar quarter in 2022. Cassava which grew by 24.4 percent from 36 thousand tons in the fourth quarter in 2021 to 45 thousand tons in the similar quarter in 2022.

2.1.2 Livestock

The activity covers livestock rearing activities, improved and indigenous cattle; goats; sheep; donkeys and horses; guinea pigs and rabbits; indigenous and commercial chicken; and other poultry.

During the period under review, livestock activities grew by 5.0 percent as observed in the same period in 2021. The demand for livestock-based products attributed to the growth due to a significant increase in per capita income, urbanization, taste and preference as well as increased awareness on food nutrition.

2.1.3 Forestry and Logging

The activity covers production of timber, charcoal, fuel wood and Logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity recorded a growth rate of 3.4 percent in the fourth quarter in 2022 compared to 6.4 percent registered in the similar quarter in 2021. The growth was attributed to government intervention to ensure sustainable harvest of forest products.

2.1.4 Fishing

The fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products.

The activity recorded a growth rate of 0.5 percent in the fourth quarter 2022 compared to contraction of 6.6 percent registered in the corresponding quarter in 2021. The growth is attributed to the slight increase in fish catch during the period under review.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction done can be from underground, on the surface mining or well operation. It also includes supplementary activities aimed at preparing the crude materials for

marketing, for example, crushing and grinding; cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations.

Mining and quarrying activity is divided into four industries, which are:

- 1) Mining of coal, lignite, and extraction of peat;
- 2) Crude petroleum and natural gas;
- 3) Mining of metal ores; and
- 4) Other mining and quarrying

The activity recorded a growth rate of 18.0 percent in fourth quarter 2022 compared to a growth rate of 7.0 percent recorded during the similar quarter in 2021. The growth was mainly due to an increase in production of diamond, coal, silver and natural gas. During the period under review, diamond production increased to 180,715.2 carats in the fourth quarter 2022 from 34,430.4 carat in the corresponding quarter in 2021, Coal increased to 747,387.6 tons in the fourth quarter 2022 compared to 191,607 tons in the similar period in 2021, silver production increased to 3,601.8 tons from 3,306.9 tons in 2021 and Copper increased to 1,891,894.2 from 1,728,190.9 tons in the fourth quarter in 2021.

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity experienced an expansion of 1.8 percent in the fourth quarter 2022 compared to 4.9 percent in the similar quarter in 2021. The growth rate was attributed to a slight increase in the production of industrial goods.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers provision of electric power and natural gas, through permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are the power generation companies.

During the period of October to December 2022, total electricity generated increased to 2,035 million kWh from 1,955 kWh million generated in the corresponding quarter in 2021. The activity recorded a growth rate of 4.1 percent in the fourth quarter 2022 compared to 10.6 percent in the similar quarter in 2021.

2.5 Water Supply and Sewerage

The activity includes collection and purification of water for water supply purposes, desalting of sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on own account in agriculture or households. It also includes water distribution activities.

The indicator for the growth of water supply activity is the quantity of water produced. During the period, quantity of water produced increased to 98.3 million cubic meters from 96.1 million cubic meters recorded in the similar quarter in 2021.

The activity grew at a rate of 2.2 percent compared to 4.9 percent in the corresponding quarter in 2021. Improvement in water production infrastructure, increased capacity, and production to match water demand due to among others population growth specifically in urban areas.




Figure 5: Fourth Quarter Water Production (Mill. Cubic Meters), 2018 - 2022

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of a temporary nature.

General construction deals with construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., It also includes construction of civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc.

The activity recorded a growth rate of 2.5 percent in the fourth quarter 2022 compared to 4.4 percent in the corresponding quarter in 2021. The growth was attributed to an increase in local production of construction materials including iron and steels which are proxies for construction activities.

2.1 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sale (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It

also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves the buying and selling of goods.

The activity recorded a growth rate of 2.6 percent in the fourth quarter of 2022 compared to a growth rate of 3.6 in the fourth quarter of 2021. The growth was due to an increase in traded goods specifically agriculture products.

2.2 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water or air and associated activities such as cargo handling, storage etc. The activity also includes renting of transport equipment with driver or operator and postal and courier activities.

The activity recorded a growth rate of 2.7 in the fourth quarter of 2022 compared to negative growth 1.2 percent recorded in the corresponding quarter of 2021. The growth was attributed to increased tonnage and passenger transported by road transport services.

2.3 Accommodation and Food Services

This activity includes provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services recorded a growth rate of 8.5 percent in the fourth quarter 2022 compared to 11.3 percent recorded in the similar period in 2021. The growth was attributed to a sharp increase in number of tourist arrivals. The number of tourist arrivals increased to 420,507 in the fourth quarter of 2022 from 306,440 recorded in the similar quarter of 2021.

2.4 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities and information service activities such as data processing; news agencies.

The activity recorded a growth rate of 6.1 percent in the fourth quarter 2022 compared to 8.5 percent in the corresponding quarter in 2021. An increase in airtime used by mobile phone customers and the expansion of broadcasting and internet services in the country.

2.0 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, auxiliary to financial service. It also includes the activities of holding assets, such as holding companies, trusts, funds and similar financial entities.

The overall financial and insurance activities increased by 8.3 percent in the fourth quarter 2022 compared with 8.4 percent recorded in the similar quarter in 2021. The growth was attributed to an increase in level of deposit by 16.4 from TZS 26.4 trillion in the fourth quarter in 2021 to TZS 30.7 trillion in similar period in 2022; an increase by 24.1 percent of the level of lending from TZS 21.9 trillion in 2021 to TZS 27.1 trillion in the similar period in 2022; and increase in growth rate of insurance services by 4.5 percent in the fourth quarter in 2022 compared to 5.9 percent in the corresponding quarter in 2021.

2.5 Real Estate

This activity includes selling or buying of real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity recorded growth rate of 4.4 percent in the fourth quarter 2022, compared to 4.1 percent recorded in the corresponding quarter in 2021. The growth was attributed to increasing demand for accommodation especially in urban areas.

2.6 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activities require a high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity recorded a growth rate of 5.9 percent in the fourth quarter 2022 compared to 6.2 percent recorded in the similar period in 2021. The outstanding increase in other professional, legal, and accounting services attributed to the growth.

2.7 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth of 3.7 percent in the fourth quarter 2022 compared with 7.0 percent record in 2021. The growth was due to good performance of travel agent and tour operators' activities.

2.8 Public Administration and Defense; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defense, public order and safety, immigration services,

foreign affairs and the administration of government programmes. This activity also includes compulsory social security activities.

The activity recorded a growth rate of 4.7 percent in the fourth quarter 2022 compared to 7.3 percent recorded in the corresponding period in 2021. An increase in government salaries and other spending in maintaining peace and order as well as provision of social services attributed to the growth.

2.9 Education

This activity includes education services at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education services offered by the different institutions in the regular school system at different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

The activity recorded a growth rate of 2.8 percent in the fourth quarter 2022 compared to 4.4 percent recorded in the corresponding quarter in 2021. An increase in the number of enrolled students in public and private primary and secondary schools coupled with an increase in government spending in provision of fee-free education services attributed to the growth.

2.10 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care services provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

The activity recorded a growth rate of 4.0 percent in the fourth quarter 2022 compared to growth rate of 5.6 percent recorded in the similar quarter in 2021.

2.11 Other Services Activities

This industry includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification. It also includes Art, Entertainment and Recreation and Activities of Households as Employers.

The activity recorded a growth rate of 9.4 percent in the fourth quarter 2022 compared to a growth of 11.7 percent recorded in the similar quarter in 2021. An increase in tourist arrivals, urban population and personal service activities attributed to the growth of the activity.

3.0 Conclusion

During the fourth quarter of 2022, GDP growth rate increased to 3.6 percent compared to 5.5 percent recorded in 2021. Mining and quarrying services activities recorded the highest growth of 18.0 percent, followed by other services which includes arts & entertainment and activities of household as an employer (9.4 percent), accommodation and food services (percent 8.5), financial and insurance (8.3 percent), information and communication (6.1 percent) and professional, scientific and technical services (5.9 percent).
