1.0 Introduction

This report presents Quarterly Gross Domestic Product (QGDP) at current and constant prices for Mainland Tanzania, base year 2015. The QGDP facilitates frequent and appropriate policy interventions by providing reliable and timely reports on recent short-term economic developments.

1.1. World Economy

According to the World Economic Outlook (WEO) October 2022 report, the global economic growth projection for 2022 remained unchanged at 3.2 percent as projected in July 2022. Meanwhile, the global economic growth for 2023 is revised to 2.7 percent, lower by 0.2 percentage point than projected growth in July 2022. The revision considered challenge associated with the on-going war in Ukraine, cost-of-living crisis caused by persistent and broadening inflation pressures, and the economic slowdown in China.

1.2. Sub-Saharan Africa

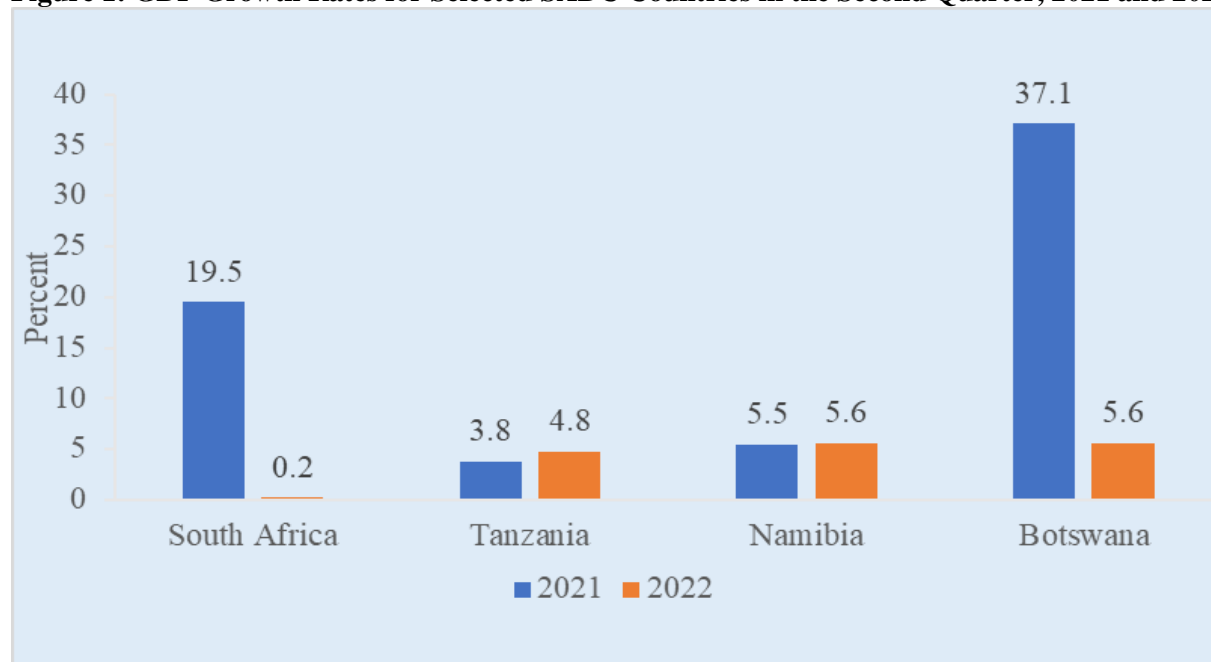
According to the WEO October 2022 report, economic growth among sub-Saharan Africa countries is projected at 3.6 percent equivalent to 0.2 percentage point lower than previous projection in the WEO July 2022 report. South Africa economy is projected to grow at a rate of 2.1 percent in 2022, a decrease of 0.2 percentage points compared to July 2022 projections. In addition, Nigeria economic growth projection is revised to 3.2 percent in October WEO projection which is 0.2 percentage point lower than the WEO July 2022 projection.

1.3. Southern Africa Development Community

According to the WEO October 2022 report, economic growth in the region is expected to grow by 3.6 percent, which is 0.2 percentage point lower than WEO July 2022 projection. Economic growth for South Africa increased by 0.2 percent in the second quarter of 2022 compared to a 19.5 percent increase over a similar period in 2021. Namibia's economy has also grown by 5.6 percent in the second quarter of 2022 compared to 5.5 percent in the similar period in 2021. Botswana economy grew by 5.6 percent in the second quarter of 2022 compared to the growth rate of 37.1 percent in the similar period in 2021. The Tanzania economy has grown at a

rate of 4.8 percent in the second quarter of 2022 compared to 3.8 percent recorded in a similar period of 2021.

Figure 1: GDP Growth Rates for Selected SADC Countries in the Second Quarter, 2021 and 2022

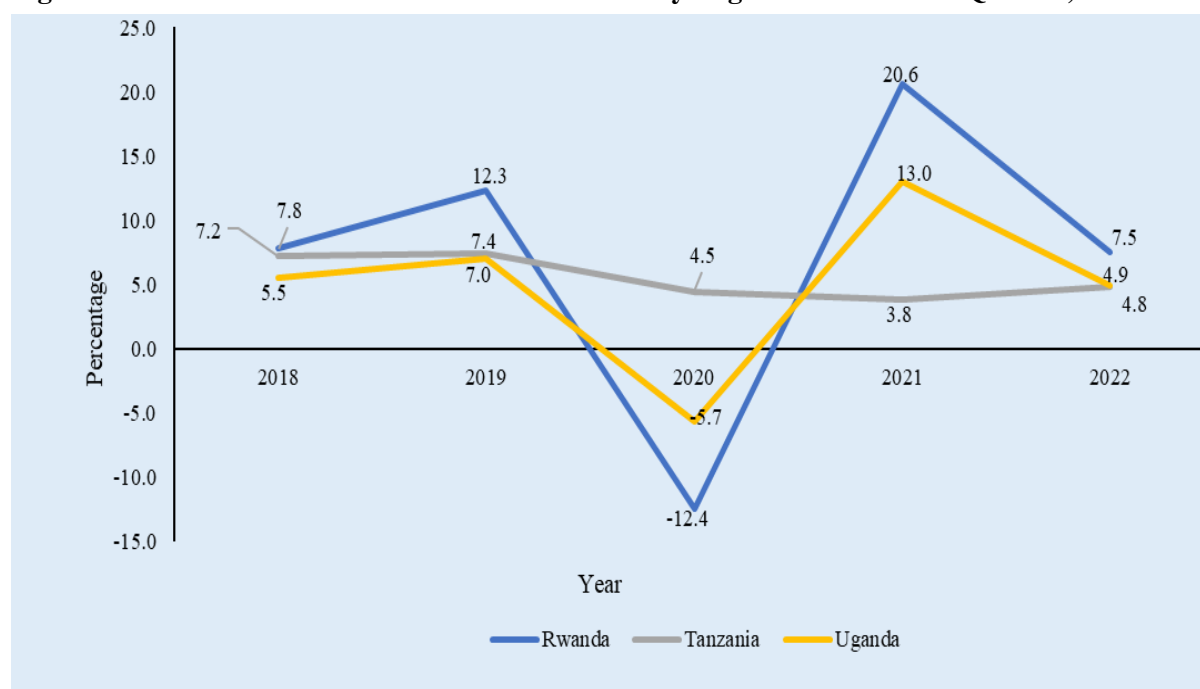

1.4. East Africa Community

Rwanda and Uganda are the only East African Community countries that have already reported the Second Quarter 2022 economic performance. The reports show that, during the second quarter 2022 Rwanda and Uganda GDP grew by 7.5 percent and 4.9 percent respectively. Meanwhile, Tanzania's economy has grown at a rate of 4.8 percent during the quarter under review compared to 3.8 percent recorded in the similar period in 2021.

1.5. GDP Compilation in Tanzania

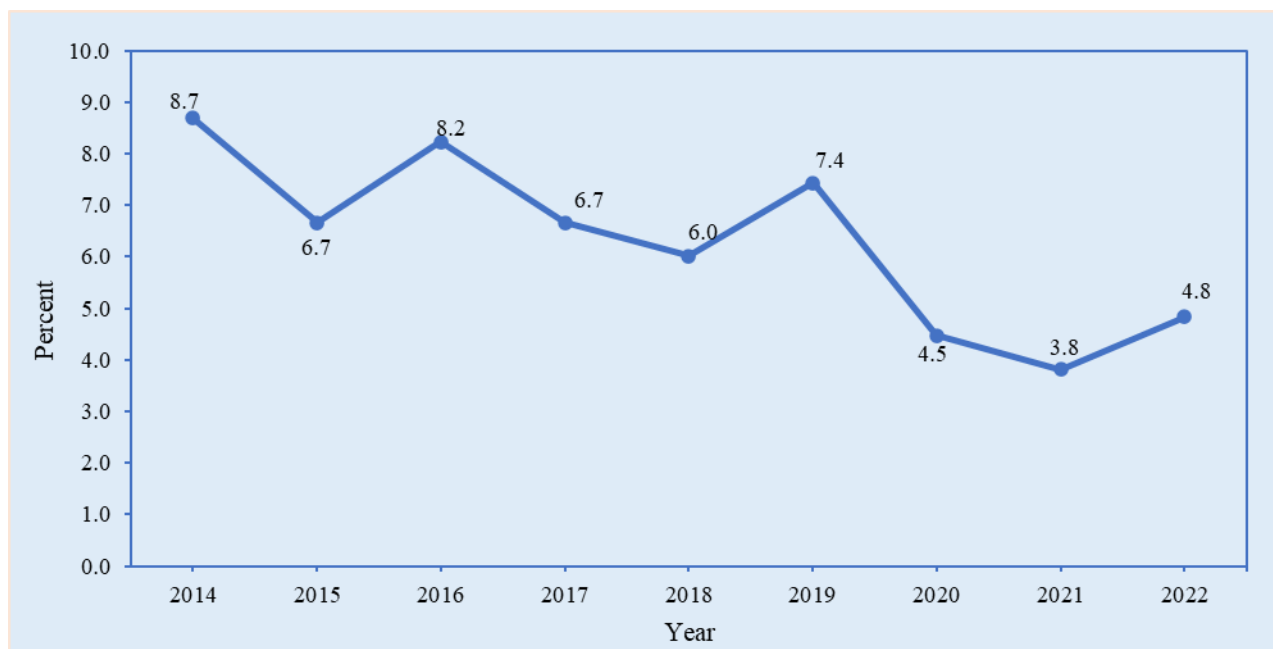
Compilation of the second quarter GDP (April – June) 2022 used data from all economic activities. Compilation followed the United Nations Statistics Division's guideline known as the System of National Accounts 2008. The report presents Gross Domestic Product at current and constant prices for Mainland Tanzania, using the 2015 base year.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in early 2019. The policy allows publication of provisional results and subsequently revised subject to availability of new or updated quarterly and/or annual data.

1.5.1 Second Quarter GDP Growth Rate 2022

During the second quarter in 2022, the value of Quarterly Gross Domestic Product (QGDP) in an absolute term at current prices increased to TZS 45.2 trillion from TZS trillion 39.9 in the similar quarter in 2021. Further, the value of QGDP at 2015 prices also increased to TZS 34.9 trillion in the second quarter of 2022 from TZS 33.3 trillion in the similar period in 2021 equivalent to the growth rate of 4.8 percent.

Figure 2: GDP Growth Rate in the Second Quarter, 2014 - 2022

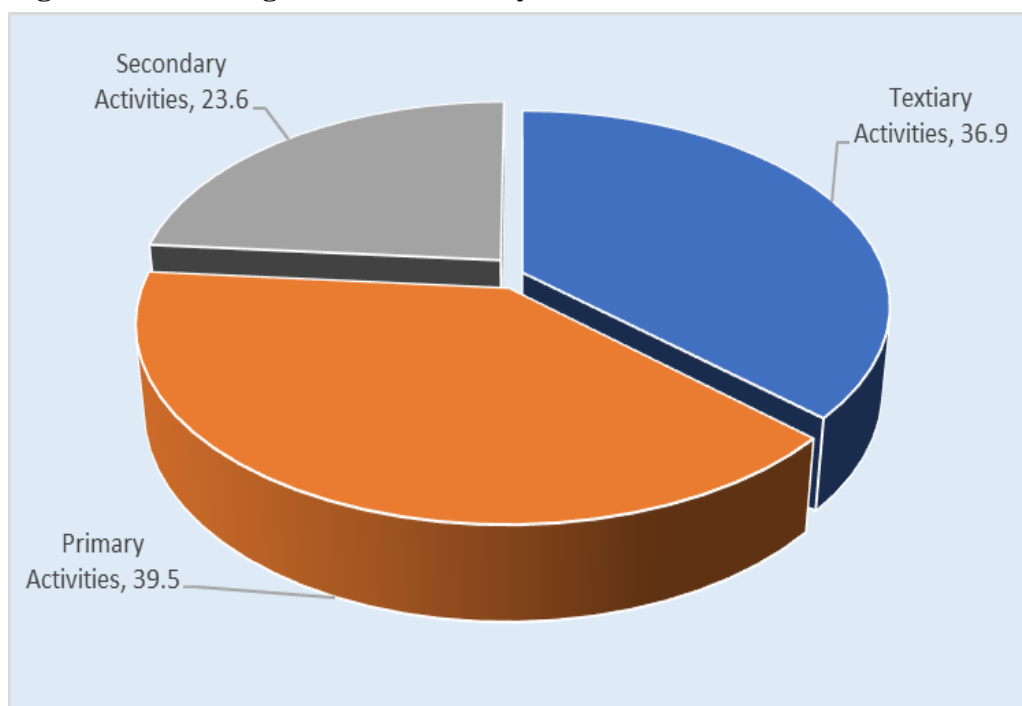

1.5.2 Share to GDP by Broad Economic Classification

Primary activities accounted for the largest share (39.5 percent) in the second quarter GDP 2022, followed by Tertiary activities (36.9 percent) and Secondary activities (23.6 percent). Note that, shares to GDP have been derived before adjustment for taxes.

Figure 3: Percentage Share to GDP by Broad Economic Activities at Current Prices

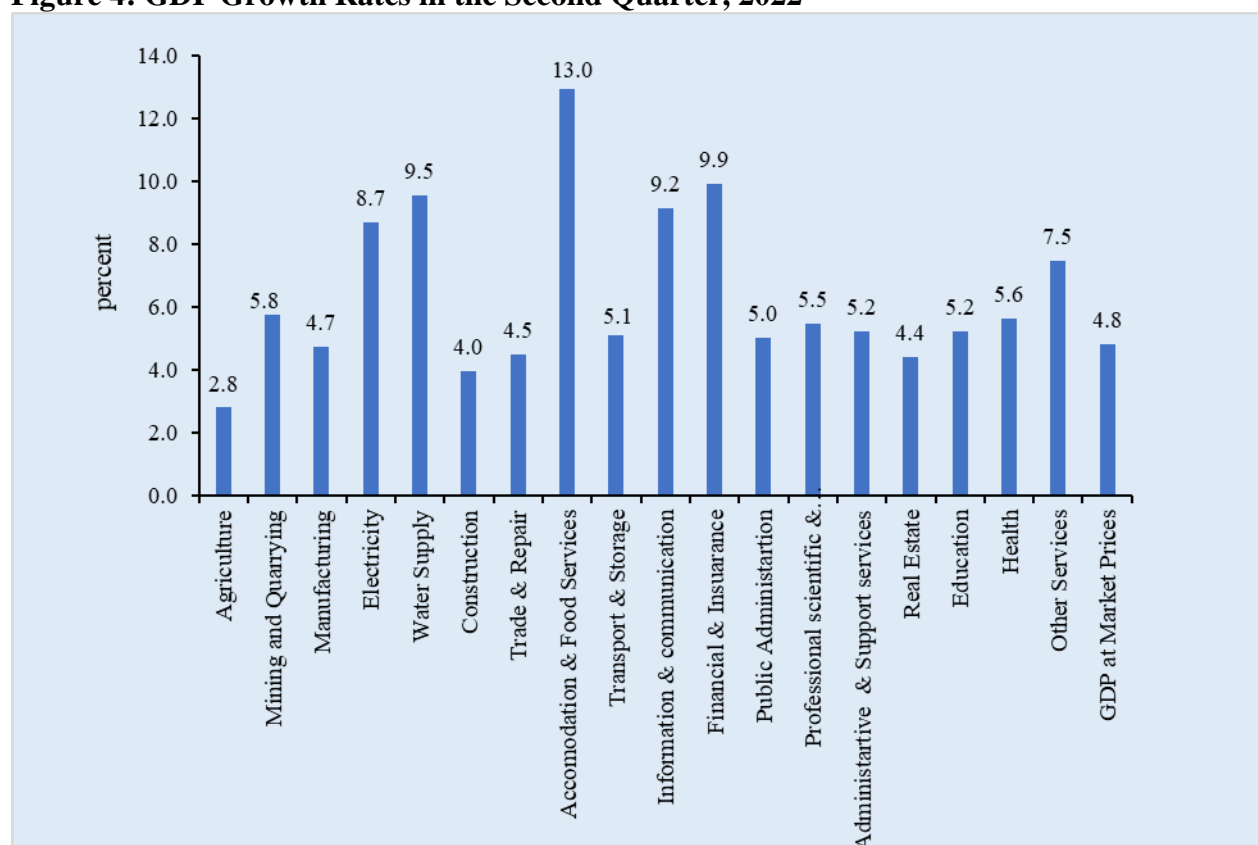

1.5.3 GDP Growth by Economic Activities in the Second Quarter 2022

During the period under review, Accommodation and Food services recorded the highest growth of 13.0 percent, followed by Finance and Insurance (percent 9.9); Water supply (percent 9.5), Information and Communication (9.2 percent); Electricity supply (8.7 percent), Other Services (7.5 percent), Public Administration (6.7) and Mining and Quarrying (5.8 percent).

1.5.4 Contribution to Growth

All economic activities undertaken in the economy in the reference period contributed to the growth of 4.8 percent compared to 3.8 percent recorded in the similar period in 2021. Economic activities with significant contribution to growth include: Agriculture (14.9 percent), Construction (13.1 percent), Transport and Storage (8.4 percent); Wholesale and Retail trade (7.8 percent); Manufacturing (7.6 percent), Financial and Insurance (6.9 percent); Mining and Quarrying (5.6 percent), and Public Administration (4.4 percent).

2.0 Sectoral Performance

2.1 Agriculture, Forestry and Fishing

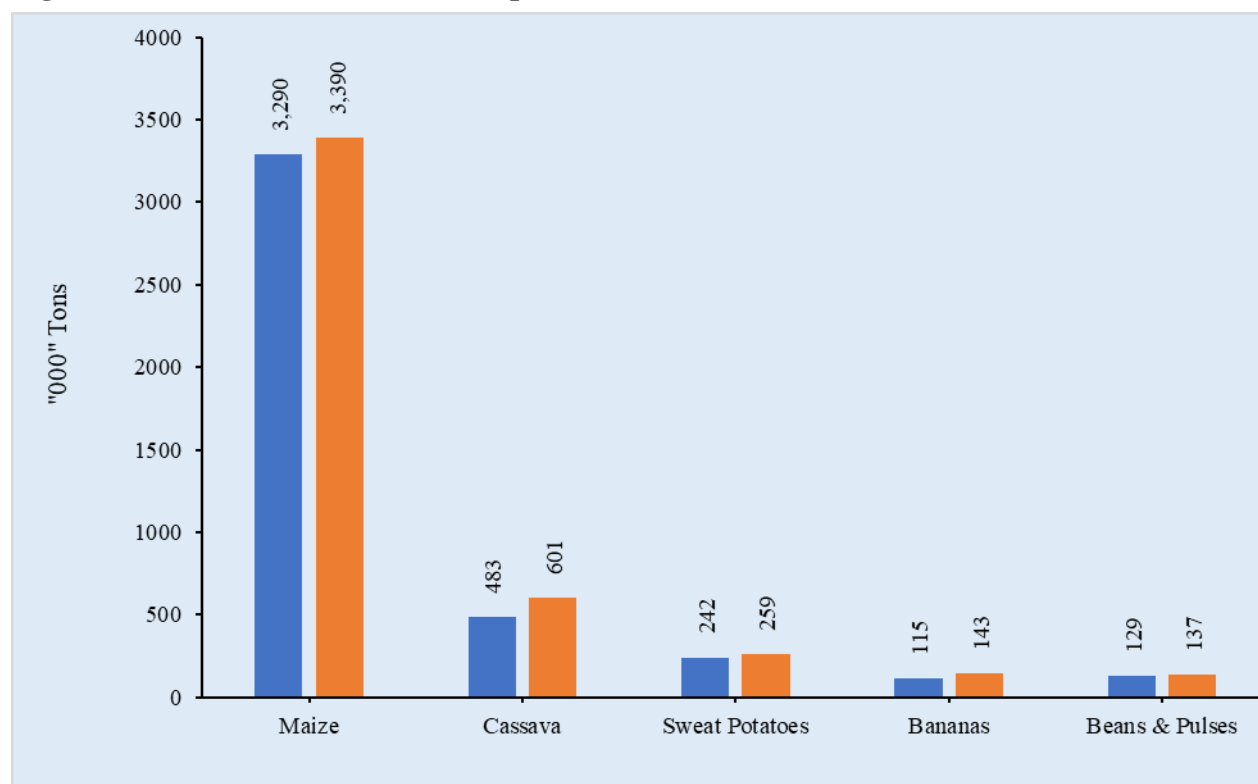
This sector includes the exploitation of vegetable and animal natural resources that comprise of growing of crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

2.1.1 Crops

Major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

This activity grew by 3.0 in the second quarter of 2022 compared to 2.2 recorded in the similar quarter in 2021. The sector growth is on account of favourable weather in areas of the production during the onset of the long rain season that attributed to the growth recorded.

Major crops with significant contribution to growth included: maize which grew by 3.0 percent from 3.29 million tons in the second quarter in 2021 to 3.39 million tons in the similar quarter in 2022. Cassava harvested increased by 24.4 percent from 483 thousand tons in the second quarter in 2021 to 601 thousand tons in the second quarter in 2022. Sweet Potatoes increased by 7.0 percent from 242 thousand tons in 2021 to 259 thousand tons in the similar quarter in 2022. Banana increased by 24.3 percent from 115 thousand tons in 2021 to 143 thousand tons in the similar quarter in 2022. Beans & Pulses increased by 6.2 percent from 129 thousand tons in 2021 to 137 thousand tons in the similar quarter in 2022.

2.1.2 Livestock

The activity covers activities of rearing improved and indigenous cattle; goats; sheep; donkeys and horses; guinea pigs and rabbits; indigenous and commercial chicken; and other poultry.

During the period under review in 2022, livestock activities grew at the growth rate of 5.0 percent the same growth as observed in 2021. The demand for livestock-based products attributed to the growth due to a significant increase in per capita income, urbanization, taste and preference as well as increased awareness on food nutrition.

2.1.3 Forestry and Logging

The activity covers production of timber, charcoal, fuel wood and Logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity recorded a growth rate of 2.4 percent in the second quarter in 2022 compared to 0.8 percent registered in the similar quarter in 2021. The government intervention to ensure sustainable harvest of forest products attributed to the growth.

2.1.4 Fishing

The fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products.

The activity experienced further contraction by 6.7 percent in the second quarter of 2022 compared to 0.7 percent registered in the corresponding quarter in 2021. The growth was caused by the decrease in fish catch during the period under review.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction done can be from underground, on the surface mining or well operation. It also includes supplementary activities aimed at preparing the crude materials for marketing, for example, crushing and grinding; cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations.

Mining and quarrying activity is divided into four industries, which are:

- 1) Mining of coal, lignite, and extraction of peat;
- 2) Crude petroleum and natural gas;
- 3) Mining of metal ores; and
- 4) Other mining and quarrying.

The activity recorded a growth rate of 5.8 percent in second quarter in 2022 compared to a growth rate of 9.4 percent recorded during the similar quarter in 2021. The growth was attributable to an increase in production of Diamond, Silver, Coal and Natural Gas. During the period under review, diamond production increased to 71,054 carats in the second quarter in 2022 from 5,126 carats realized in the corresponding quarter in 2021, coal increased to 537,563 tons in second quarter in 2022 compared to 247,770 tons in the correspondence quarter in 2021.

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity expanded by 4.7 percent in the second quarter in 2022 compared to 4.5 percent in the similar quarter in 2021. The growth rate was attributed to a general increase in the production of industrial goods.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers generation and supply of electric power and natural gas, through permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are the power generation companies.

During the period of April to June 2022, total electricity generated increased to 1,977 million kWh from 1,764 kWh million generated in the corresponding quarter in 2021. The activity recorded a growth rate of 8.7 percent in the second quarter of 2022 compared to 12.1 percent in the similar quarter of 2021.

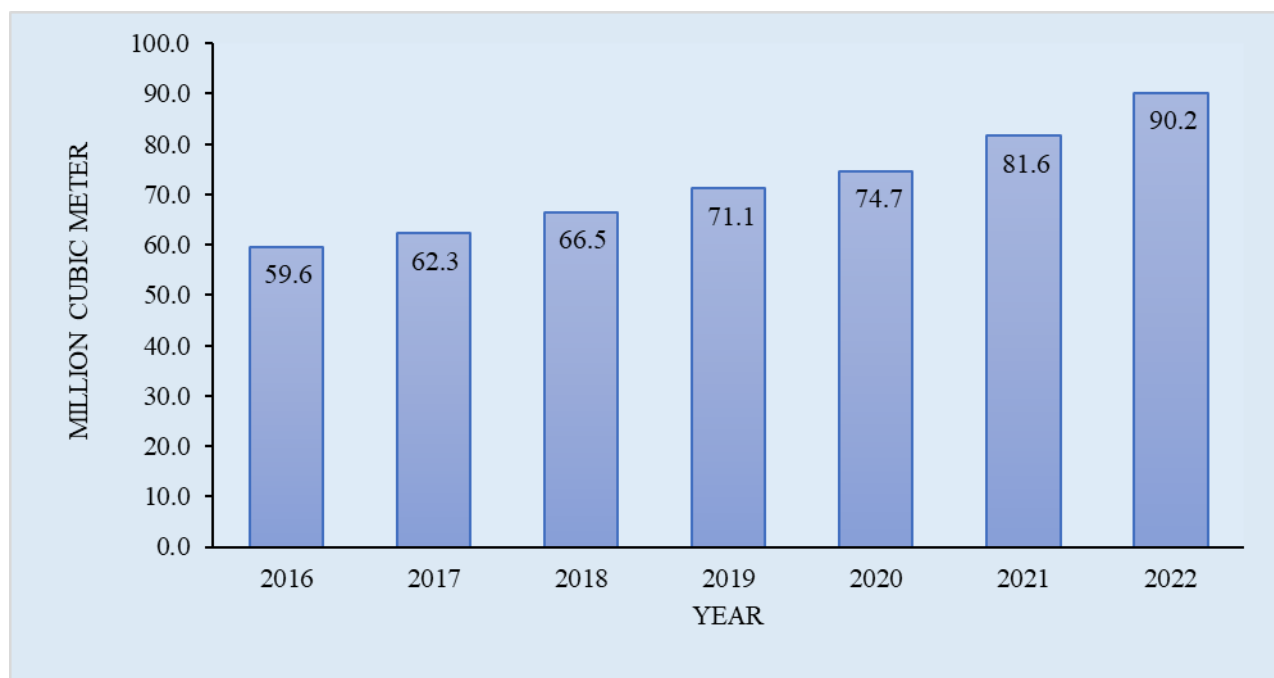
2.5 Water Supply and Sewerage Services

The activity includes collection and purification of water for water supply purposes, desalting of sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on own-account in agriculture or households. It also includes water distribution activities.

The indicator for the growth of water supply activity is the quantity of water produced. During the period under review, quantity of water produced increased to 90.2 million cubic meters from 81.6 million cubic meters recorded in the similar quarter in 2021.

The activity grew at a rate of 9.5 percent compared to 8.4 percent observed in the corresponding quarter in 2021. Improvement in water production infrastructure, increased capacity and production to match water demand due to population growth specifically in urban areas

2.6 Construction Activities

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of a temporary nature.

General construction deals with construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., It also includes construction of civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc .

The activity recorded a marginal growth rate of 4.0 percent in the second quarter of 2022 compared to 1.9 percent in the corresponding quarter in 2021. The growth was

attributed to an increase in local production of construction materials like iron and steels which are proxies for construction activities.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sale (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves the buying and selling of goods.

The activity recorded a growth rate of 4.5 percent in the second quarter in 2022 compared to a growth rate of 4.3 in the second quarter in 2021. The growth was due to an increase in traded goods specifically agriculture products.

2.8 Transport and Storage Services

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water or air and associated activities such as cargo handling, storage etc. The activity also includes renting of transport equipment with driver or operator and postal and courier activities.

The activity recorded a growth rate of 5.1 percent in the second quarter in 2022 compared to 4.9 percent recorded in the similar quarter in 2021. The growth was attributed to increased tonnage and passenger transported by road transport services.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services recorded a growth rate of 13.0 percent in the second quarter in 2022 compared to 10.1 percent recorded in the similar period in 2021. The growth was attributed to an increase in number of tourist arrivals. The number of tourist arrivals increased to 286,025 in the second quarter of 2022 from 143,828 recorded in the similar quarter in 2021.

2.10 Information and Communication Services

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities and information service activities such as data processing and news agencies.

The activity recorded a growth rate of 9.2 percent in the second quarter in 2022 compared to 11.4 percent in the corresponding quarter in 2021. An increase in airtime used by mobile phone customers and the expansion of broadcasting and internet services in the country.

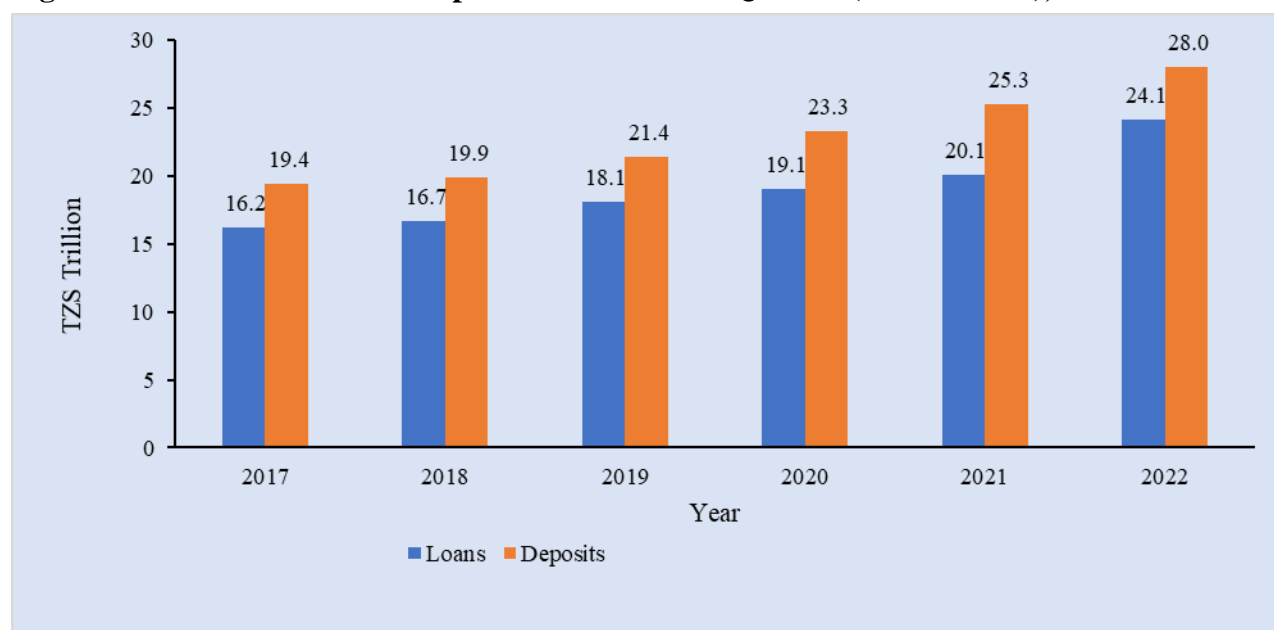

2.11 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, auxiliary to financial service. It also includes the activities of holding assets, such as holding companies, trusts, funds and similar financial entities.

The overall financial and insurance activities increased by 9.9 percent in the second quarter in 2022 compared to 3.8 percent recorded in the similar quarter in 2021. The growth was attributed to an increase in level of deposit by 10.9 from TZS 25.3 trillion in the second quarter in 2021 to TZS 28.1 trillion in similar period in 2022; an increase by 20.0 percent of the level of lending from TZS 20.1 trillion in 2021 to TZS 24.1 trillion in the similar period in 2022; and increase in growth rate of insurance services by 5.5 percent in the second quarter in 2022 compared to 2.4 percent in the corresponding quarter in 2021.

2.12 Real Estate Services

This activity includes selling or buying of real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity recorded a growth rate of 4.4 percent in the second quarter in 2022, compared to 4.6 percent experienced in the corresponding quarter in 2021. The growth was attributed to an increase in demand for accommodation especially in urban areas.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activities require a high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity recorded a growth rate of 5.5 percent in the second quarter in 2022 compared to 7.6 percent recorded in the similar period in 2021. The outstanding increase in other professional, legal, and accounting services attributed to the growth.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth of 5.2 percent in the second quarter in 2022 compared to 7.3 percent record in 2021. The performance of travel agents and tour operators' activities attributed to the growth.

2.15 Public Administration and Defense; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defense, public order and safety, immigration services, foreign affairs and the administration of government programmes. This activity also includes compulsory social security activities.

The activity growth rate improved to 5.0 percent in the second quarter in 2022 compared to 4.1 percent recorded in the corresponding period in 2021. An increase in government spending in maintaining peace and order as well as provision of social services attributed to the growth.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at its different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

The activity recorded a growth rate of 5.2 percent in the second quarter in 2022 compared to 4.8 percent recorded in the corresponding quarter in 2021. An increase in the number of enrolled students in public and private primary and secondary schools coupled with an increase in government spending in provision of fee-free education services attributed to the growth.

2.17 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

The activity recorded a growth rate of 5.6 percent in the second quarter in 2022 compared to growth rate of 5.5 percent in the similar quarter in 2021. The growth was attributable to provision of health services at all levels operated by both public and private sectors.

2.18 Other Social Services

This industry includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification. It also includes Art, Entertainment and Recreation and Activities of Households as Employers.

The activity recorded a growth rate of 7.5 percent in the second quarter in 2022 compared to a growth of 10.8 percent recorded in the similar quarter in 2021. An increase in tourist arrivals by 98.9 percent to 286,025 in 2022 from 143,828 in 2021 as well as an increase in urban population and personal service attributed to the growth of the activity.

3.0 Conclusion

During the second quarter in 2022, GDP growth rate increased to 4.8 percent compared to 3.8 percent recorded in 2021. Accommodation and Food services activities recorded the highest growth of 13.0 percent, followed by Financial and Insurance (percent 9.9), Water supply (percent 9.5), Information and

Communication (9.2 percent); Electricity supply (8.7 percent); Other Social Services (7.5 percent), Mining and Quarrying (5.8 percent) and Human Health (5.6).
