1.0 Utangulizi

Pato la Taifa ni thamani ya bidhaa na huduma zinazozalishwa katika kipindi husika. Pato la Taifa kwa robo mwaka hutayarishwa katika vipindi vya miezi mitatu mitatu ambavyo ni Robo ya Kwanza (Januari – Machi), Robo ya Pili (Aprili – Juni), Robo ya tatu (Julai – Septemba) na Robo ya Nne (Oktoba – Desemba). Taarifa ya Pato la Taifa kwa robo mwaka hutumika katika kutathmini mabadiliko ya ukuaji wa uchumi katika vipindi vifupi. Taarifa hii ni kwa kipindi cha kuanzia mwezi Aprili hadi Juni, 2017.

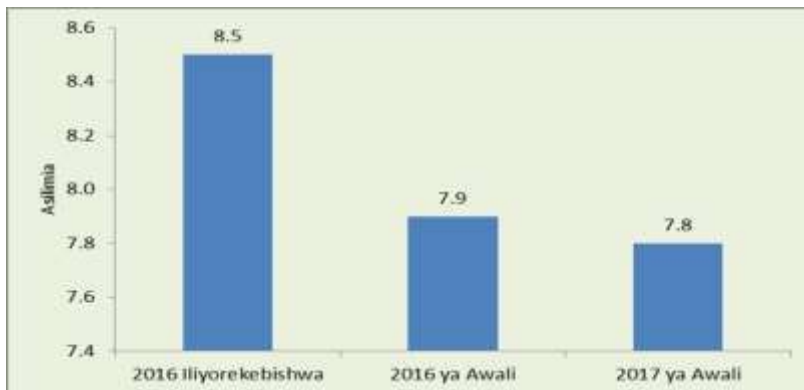
Taarifa zilizotumika kutayarisha takwimu za robo ya pili ya Pato la Taifa zimetokana na uzalishaji wa bidhaa na huduma Nchini katika kipindi cha Aprili hadi Juni 2017. Vilevile, ukokotoaji wa takwimu za Pato la Taifa umezingatia matakwa ya Mfumo wa Umoja wa Mataifa wa ukokotoaji takwimu za Pato la Taifa (UN System of National Accounts 1993 and 2008).

2.0 Matokeo Muhimu

Mwaka 2017, robo ya pili ya Pato la Taifa kwa bei za soko za miaka husika ilikuwa na thamani ya Shilingi trilioni 31.1 ikilinganishwa na Shilingi trilioni 26.6 ya matokeo yaliyopatikana katika robo ya pili ya mwaka 2016.

Thamani ya Pato la Taifa katika robo ya pili ya mwaka 2017 kwa bei za soko za mwaka 2007 ilikuwa Shilingi trilioni 12.8 ikilinganishwa na Shilingi trilioni 11.9 ya thamani iliyopatikana katika kipindi kama hicho mwaka 2016, ambayo ni sawa na kasi ndogo ya ongezeko ya asilimia 7.8 ikilinganishwa na kasi iliyorekebisha ya asilimia 8.5 ya mwaka 2016. Kasi ya ukuaji wa Pato la Taifa kabla ya marekebisho katika robo ya pili ya mwaka 2016 ilikuwa asilimia 7.9 (***Kielelezo Namba 1***).

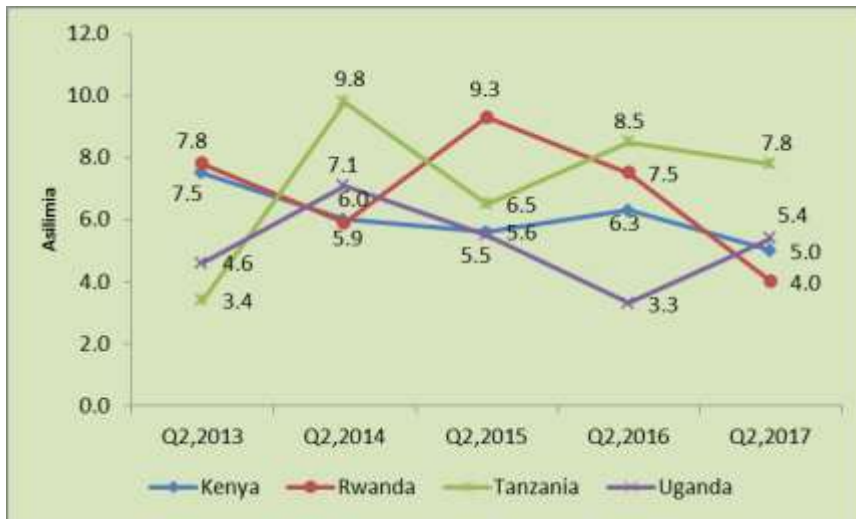

3.0 Ukuaji wa Uchumi katika Nchi za Jumuiya ya Afrika Mashariki (EAC)

Ukuaji wa uchumi katika kipindi cha robo ya pili ya Mwaka 2017 miongoni mwa Nchi za Jumuiya ya Afrika Mashariki, unaonesha kuwa, Pato la Taifa la Nchi ya Kenya liliongezeka kwa kasi ya asilimia 5.0 ikilinganishwa na asilimia 6.3 ya kipindi kama hicho mwaka 2016. Ukuaji kwa Nchi ya Rwanda uliongezeka kwa kasi ya asilimia 4.0 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na asilimia 7.5 ya kipindi kama hicho mwaka 2016. Pato la Nchi ya Uganda liliongezeka kwa kasi ya asilimia 5.4 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na asilimia 3.3 ya kipindi kama hicho mwaka 2016. Nchi ya Burundi haijaanza kukokotoa takwimu za Pato la Taifa kwa robo mwaka.

Kwa ujumla, katika kipindi cha Aprili hadi Juni 2017 katika Kanda ya Afrika Mashariki, Tanzania imeongoza kwa kuwa na kasi kubwa ya ukuaji wa Pato la Taifa ikifuatiwa na Uganda, Kenya na Rwanda. Kasi ya ukuaji wa uchumi kwa Nchi ya Tanzania ilichangiwa na shughuli mpya za uzalishaji wa bidhaa na huduma zilizoingia katika uchumi ziliongeza kasi ya ukuaji wa Pato la Taifa ambazo zimeelezwa kwa kina katika sehemu zinazofuata.

4.0 Ukuaji wa Pato la Taifa kwa Shughuli za Kiuchumi

Kwa ujumla, ukuaji wa shughuli za kiuchumi kwenye Pato la Taifa katika kipindi cha robo ya pili ya mwaka 2017 unaonesha kuwa, shughuli za kiuchumi ambazo zilikuwa kwa kasi ya zaidi ya asilimia 8.0 ni Usafirishaji na Uhifadhi mizigo (asilimia 19.8), Uchimbaji Madini na Mawe (asilimia 18.0), Uzalishaji Viwandani (asilimia 9.3) na Ujenzi (asilimia 8.8). Aidha, katika kipindi hicho, shughuli za kiuchumi zilizokua kwa kasi ndogo ni pamoja na Utawala na Ulinzi (asilimia hasi 3.4), Umeme (asilimia 0.2) na Upangishaji Nyumba (asilimia 2.3). Maelezo ya kina yametolewa kwenye kila shughuli ya kiuchumi.

Muhtasari wa mchanganuo wa shughuli za kiuchumi katika kipindi husika ulikuwa kama ifuatavyo:

4.1 Kilimo, Mifugo, Misitu na Uvuvi

Shughuli hizi zinajumuisha uvunaji wa mazao ya mimea, wanyama, uvunaji wa mazao ya miti kutoka katika mashamba

ya miti pamoja na uvunaji wa wanyama pori na mazao ya miti ya porini na uzalishaji wa samaki na mazao ya samaki.

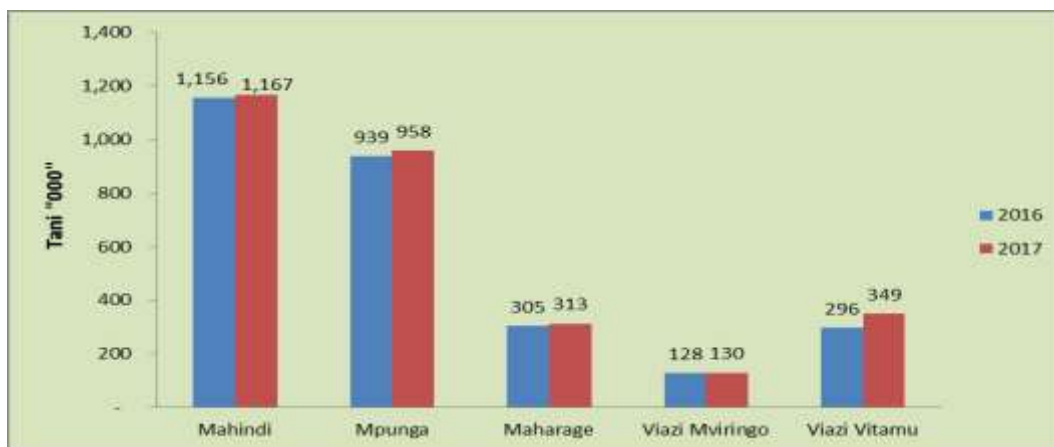
Shughuli za kiuchumi za kilimo, mifugo, misitu na uvuvi zilikuwa kwa kasi ya asilimia 3.7 katika robo ya pili ya mwaka 2017 ikilinganishwa na kasi ya asilimia 2.6 katika kipindi cha Aprili hadi Juni mwaka 2016.

4.1.1 Kilimo cha Mazao

Shughuli za mazao zinajumuisha uvunaji wa mazao ya mimea, na uvunaji wa mazao ya miti kutoka katika mashamba ya miti. Katika kipindi hicho, Shughuli za kilimo cha mazao zilikuwa kwa kasi ya asilimia 4.0 mwaka 2017 ikilinganishwa na asilimia 2.2 mwaka 2016. Ukuaji huu ulitokana na kupatikana kwa mvua za kutosha katika maeneo mengi yanayozalisha mazao kwa wingi na pia wakulima kuzingatia maelekezo ya maafisa ugani.

Baadhi ya mazao makuu yaliyochangia katika ukuaji wa asilimia 4.0 ni pamoja na Mahindi yaliyoongezeka kwa asilimia 0.9 kutoka tani elfu 1,156 katika robo ya pili ya mwaka 2016 hadi tani elfu 1,167 katika kipindi kama hicho mwaka 2017. Mpunga uliongezeka kwa asilimia 2.0 kutoka tani elfu 939 katika robo ya pili ya mwaka 2016 hadi tani elfu 958 katika kipindi kama hicho mwaka 2017. Maharage yaliongezeka kwa asilimia 2.6 kutoka tani elfu 305 robo ya pili ya mwaka 2016 hadi tani elfu 313 kipindi kama hicho mwaka 2017. Viazi mvingo viliongezeka kwa asilimia 1.6 kutoka tani elfu 128 katika robo ya pili ya mwaka 2016 hadi tani elfu 130 kipindi kama hicho mwaka 2017. Viazi vitamu viliongezeka kwa asilimia 17.9 kutoka tani elfu 296 robo ya pili ya mwaka 2016 hadi tani elfu 349 katika kipindi kama hicho mwaka 2017.

4.1.2 Mifugo

Uzalishaji wa mifugo na mazao yake unatokana na ufugaji wa mifugo ya kiasili na iliyoboreshwa. Mifugo hiyo ni pamoja na ng'ombe, mbuzi, kondoo, nguruwe, punda na farasi, sungura na kuku.

Shughuli za uzalishaji Mifugo na mazao yake katika kipindi cha Aprili hadi Juni 2017 zilikuwa kwa kasi ya asilimia 2.7 mwaka 2017 ikilinganishwa na asilimia 2.5 katika kipindi kama hicho mwaka 2016. Kasi ya ukuaji wa shughuli hii ilitokana na kuongezeka kwa idadi ya wanyama waliochinjwa (kuvunwa) na pia kuongezeka kwa wanyama kutokana na kuzaliana.

4.1.3 Misitu

Shughuli hii inahusika na uzalishaji wa mazao ya misitu ambayo ni magogo, mkaa, kuni, na mazao mengine ya misitu yasiyotokana na miti kama asali na nta.

Ukuaji wa shughuli za misitu uliongezeka kwa kasi ya asilimia 5.6 katika robo ya pili ya mwaka 2017 ikilinganishwa na asilimia 3.7 ya kipindi kama hicho mwaka 2016. Kasi ya ukuaji wa shughuli hii iliongezeka kutokana na mahitaji ya mazao ya misitu katika matumizi ya kila siku ya kaya na shughuli za ujenzi zinazoendela hapa Nchini.

4.1.4 Uvuvi

Shughuli ya uvuvi inahusika na uvunaji wa rasilimali za baharini na maji baridi, kwa lengo la kuvua samaki na mazao mengine ya bahari.

Ukuaji wa shughuli za uvuvi uliongezeka kwa kasi ndogo ya asilimia 3.1 katika kipindi cha Aprili hadi Juni mwaka 2017 ikilinganishwa na ukuaji wa asilimia 6.1 kipindi kama hicho mwaka 2016. Kupungua kwa kasi ya ukuaji wa shughuli hii kulitokana na Serikali kuendelea kudhibiti uvuvi haramu na uvuvi usioendelevu unaotumia vifaa haribifu kwa mazingira kama vile makokoro na nyavu zenye kipenyo kidogo, ambapo vinapokamatwa huteketezwa.

4.2 Viwanda na Ujenzi

Shughuli za kiuchumi za viwanda na ujenzi zinajumuisha uchimbaji madini na mawe; uzalishaji viwandani; ujenzi na uzalishaji na usambazaji wa umeme na maji. Shughuli za viwanda na ujenzi zilikuwa kwa kasi ya asilimia 9.8 katika robo ya pili ya mwaka 2017 ikilinganishwa na kasi ya asilimia 10.4 katika kipindi cha Aprili hadi Juni mwaka 2016. Kwa ujumla kupungua kwa kasi ya ukuaji ya asilimia 0.6 kulisababishwa na

kupungua kwa kasi ya ukuaji katika shughuli ya Uzalishaji Umeme. Uchambuzi wa kina kwa shughuli za viwanda na Ujenzi umetolewa hapa chini.

4.2.1 Uzalishaji Bidhaa Viwandani

Shughuli za Uzalishaji bidhaa viwandani ziliongezeka kwa kasi ya asilimia 9.3 katika robo ya pili ya mwaka 2017 ikilinganishwa na kasi ya asilimia 9.1 katika kipindi kama hicho mwaka 2016. Kasi ya ukuaji ilitokana na kuongezeka kwa uzalishaji wa bidhaa za tumbaku, nguo, mbao na karatasi. Shughuli nyingine zilizochangia katika ukuaji ni pamoja na uchapishaji, uzalishaji wa bidhaa za kemikali na simenti. Simenti iliyozalishwa katika kipindi cha Aprili hadi Juni mwaka 2016 iliongezeka kutoka tani 1,000,818 hadi tani 1,030,865 zilizozalishwa katika kipindi kama hicho mwaka 2017.

4.2.2 Uchimbaji Madini Mawe na Kokoto

Uchimbaji madini na mawe unahusisha ukusanyaji wa madini yabisi yanayopatikana kwenye uso wa dunia (kama vile makaa ya mawe na chuma), vimiminika (petroli) au gesi (gesi asilia). Ukusanyaji huu unaweza kuwa chini ya ardhi, juu ya ardhi na pia kutoka kwenye visima. Shughuli hii inajumuisha pia kazi za ziada za kuongeza thamani ya madini kama vile kusafisha kukata na kupanga katika madaraja tayari kwa kupelekwa kwenye masoko.

Shughuli za uchimbaji madini, mawe na kokoto ziliongezeka kwa kasi ya asilimia 18.0 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na kasi ya ukuaji wa asilimia 13.4 katika kipindi kama hicho mwaka 2016.

Ukuaji wa shughuli hii ulitokana na kuongezeka kwa uzalishaji wa madini ya Tanzanite, Almasi, na chumvi. Kiasi cha madini kilichozalishwa kimeainishwa kwenye jedwali na. 1 hapo chini.

4.2.3 Ujenzi

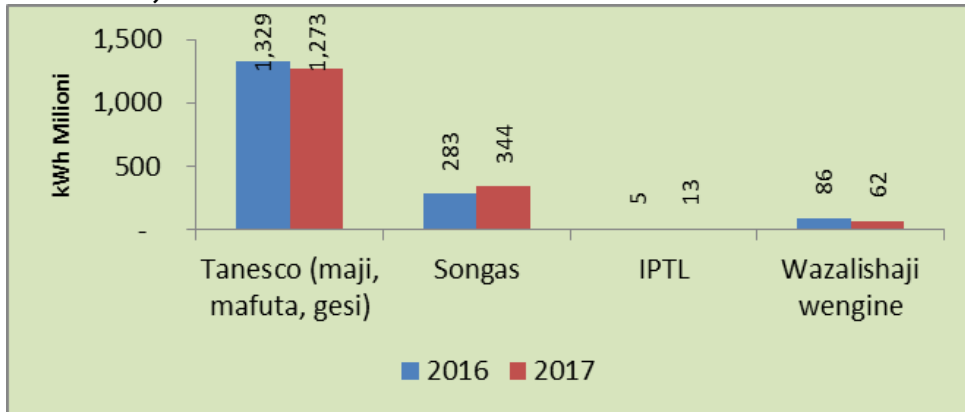
Shughuli za ujenzi ziliongezeka kwa kasi ya asilimia 8.8 katika robo ya pili ya mwaka 2017 ikilinganishwa na kasi ya asilimia 11.1 katika robo ya pili ya mwaka 2016. Ongezeko hili lilitokana na ujenzi wa majengo ya biashara na makazi pamoja na miradi ya ujenzi wa miundombinu inayoendelea kujengwa Nchini kama vile barabara za juu katika makutano ya Ubungo na TAZARA Jijini Dar es Salaam na ujenzi wa barabara ya Manyoni – Tabora, na Mtwara - Mvinata.

4.2.4 Umeme

Shughuli ya uzalishaji wa nishati ya umeme ilikua kwa kasi ndogo ya asilimia 0.2 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na kasi ya asilimia 5.0 katika kipindi kama hicho mwaka 2016. Kasi ndogo ya uzalishaji ilichangiwa na kutokuzalishwa kwa umeme katika vituo vya Symbion, Ngombeni, Tanwat na Iyunga kutokana na muda wa mikataba ya baadhi ya makampuni kumalizika na matengenezo ya mitambo ya kufua umeme. Aidha, uzalishaji wa umeme katika mabwawa uliongezeka kwa asilimia 6.5 katika kipindi cha Aprili hadi Juni mwaka 2017 ikilinganishwa na asilimia 0.3 katika kipindi kama hicho mwaka 2016.

Vilevile, kiasi cha umeme kilichosambazwa katika kipindi cha Aprili hadi Juni mwaka 2017 kiliongezeka na kufikia kWh milioni 1,425 kutoka kWh milioni 1,414 zilizosambazwa katika kipindi kama hicho mwaka 2016 sawa na ongezeko la asilimia 0.78.

4.2.5 Usambazaji Maji

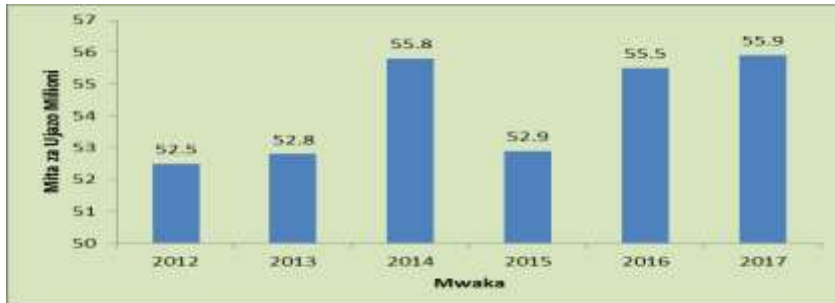
Shughuli ya kiuchumi ya usambazaji maji inahusika na kukusanya, kusafisha na kusambaza maji kwa ajili ya matumizi ya nyumbani. Shughuli hii inatekelezwa na Mamlaka za Maji Safi na Maji Taka za Miji na Manispaa hapa Nchini. Maji yanayosambazwa yanatumika pia katika shughuli ya ujenzi na uzalishaji wa mazao na mifugo.

Katika kipindi husika cha mwaka 2017, kiasi cha maji kilichozalishwa kiliongezeka hadi mita za ujazo milioni 55.9 kutoka mita za ujazo milioni 55.5 zilizozalishwa katika kipindi kama hicho mwaka 2016.

Ukuaji wa shughuli hii uliongezeka kwa kasi ndogo ya asilimia 7.0 katika robo ya pili ya mwaka 2017 ikilinganishwa na asilimia 4.3 ya ukuaji katika kipindi kama hicho mwaka 2016. Kasi ya

ukuaji ilisababishwa na kuongezeka kwa maji yaliyosambazwa na Mamlaka za Maji safi Nchini.

4.3 Shughuli za Utoaji Huduma

Shughuli za kiuchumi za utoaji huduma zinajumuisha biashara na matengenezo; malazi na huduma za chakula; uchukuzi na uhifadhi wa mizigo; habari na mawasiliano; fedha na bima; upangishaji majengo; huduma za kitaalamu, kisayansi na kiufundi; shughuli nyinginezo za utawala na huduma. Vilevile zinajumuisha utawala na ulinzi; elimu; afya; sanaa na burudani; huduma nyingine za kijamii na shughuli za kaya binafsi katika kuajiri. Shughuli za utoaji huduma zilikua kwa kasi ya asilimia 6.8 katika robo ya pili ya mwaka 2017 ikilinganishwa na asilimia 10.6 katika kipindi kama hicho mwaka 2016. Uchambuzi wa kina umetolewa hapa chini.

4.3.1 Biashara na Matengenezo

Shughuli hii inahusisha uuzaji wa bidhaa za jumla na rejareja wa aina zote za bidhaa na utoaji wa huduma zinazohusiana na shughuli za kibiashara kwa ujumla. Pia inajumuisha matengenezo madogo madogo ya magari na matengenezo ya bidhaa za binafsi na kaya.

Katika kipindi cha robo ya pili ya mwaka 2017, shughuli hii ilikua kwa kasi ya asilimia 5.4 ikilinganishwa na kasi ya asilimia 4.7 katika kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na biashara ya ununuzi na uuzaji wa mazao ya kilimo, mifugo pamoja na bidhaa za viwandani zilizozalishwa katika kipindi husika.

4.3.2 Usafirishaji na Uhifadhi Mizigo

Shughuli hii inahusika na usafirishaji wa abiria na mizigo kwa njia ya reli, barabara, maji na anga. Vilevile inahusika na usafirishaji wa mafuta na gesi kwa njia ya mabomba. Pia shughuli hii inahusika na utoaji wa huduma za uhifadhi wa mizigo. Aidha, shughuli hii inajumuisha ukodishaji wa vifaa vya uchukuzi na madereva pamoja na usafirishaji wa barua na vifurushi.

Shughuli za uchukuzi na uhifadhi katika robo ya pili ya mwaka 2017 zilikuwa kwa kasi ndogo ya asilimia 19.8 ikilinganishwa na kasi ya asilimia 30.6 katika robo ya pili ya mwaka 2016. Kasi ya ukuaji wa shughuli hii ilichangiwa na usafirishaji wa mazao ya kilimo na mifugo, abiria na bidhaa za viwandani kwa kutumia reli, barabara na bomba la kusafirisha gesi asilia kutoka Mtwara hadi Dar es Salaam.

4.3.3 Huduma za Malazi na Chakula

Shughuli hii inahusika na utoaji wa huduma za malazi za muda mfupi kwa wageni na wasafiri wengine na utoaji wa huduma za chakula na vinywaji.

Shughuli ya huduma ya malazi na chakula katika robo ya pili ya mwaka 2017 ilikua kwa kasi ya asilimia 3.7 ikilinganishwa na asilimia 2.5 katika kipindi kama hicho mwaka 2016. Kasi ya ukuaji wa shughuli hii ilitokana na kuongezeka kwa idadi ya watalii wa nje kutoka 236,268 robo ya pili ya mwaka 2016 hadi 278,012 katika robo ya pili ya mwaka 2017.

4.3.4 Habari na Mawasiliano

Shughuli hii inahusika na uchapishaji vitabu na muziki, upigaji picha za video, uandaaji wa programu za video na runinga, kurekodi sauti, kuandaa na kurusha vipindi vya redio na runinga.

Shughuli za Habari na Mawasiliano katika kipindi cha Aprili hadi Juni mwaka 2017 zilikuwa kwa kasi ya asilimia 12.3 ikilinganishwa na asilimia 11.6 kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuongezeka kwa muda wa maongezi kwa simu za mikononi na kupanuka kwa huduma za intaneti na utangazaji Nchini kupitia vipindi vya redio na runinga.

4.3.5 Huduma za Fedha na Bima

Shughuli hii inahusika na utoaji wa huduma za fedha na bima kwenye benki za biashara, maduka ya kubadilisha fedha, Benki Kuu pamoja na huduma za bima Nchini.

Katika kipindi cha Aprili hadi Juni mwaka 2017, shughuli za fedha na bima zilikuwa kwa kasi ya asilimia 8.2 ikilinganishwa na asilimia 12.4 katika kipindi kama hicho mwaka 2016. Kasi ndogo ya ukuaji ilitokana na kuongezeka kidogo kwa mikopo iliyotolewa kwa sekta binafsi na benki za biashara kutoka Shilingi bilioni 16,102.0 katika kipindi cha Aprili hadi Juni mwaka 2016 hadi kufikia shilingi bilioni 16,187.5 kipindi kama hicho mwaka 2017. Vilivile, kiasi cha amana kilichowekwa kwenye benki za biashara kiliongezeka kutoka Shilingi bilioni 18,050.7 kipindi cha Aprili hadi Juni mwaka 2016 hadi kufikia Shilingi bilioni 19,419.3 katika kipindi kama hicho mwaka 2017.

4.3.6 Utawala na Ulinzi

Shughuli hii inajumuisha kazi za kutunga na kutafsiri sheria, kazi za Bunge, ukusanyaji kodi, ulinzi wa Taifa, usalama wa raia na mali zao, uhamiaji, usimamizi wa misaada kutoka nje ya Nchi na uendeshaji wa programu mbalimbali za Serikali. Shughuli za mifuko ya pensheni ni sehemu ya Utawala na Ulinzi.

Shughuli ya Utawala na Ulinzi ilikua kwa asilimia hasi 3.4 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na ukuaji wa asilimia 17.7 kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuondolewa katika malipo ya mishahara ya utumishi wa umma kwa wafanyakazi hewa na wale waliobainika kuwa na vyeti vya kugushi na ambapo zoezi hili ni endelevu.

4.3.7 Huduma za Kitaalamu, Kisayansi na Kiufundi

Huduma hizi zinajumuisha shughuli maalumu za Kitaalamu, Kisayansi na Kiufundi. Shughuli hizi ni pamoja na huduma za kisheria, kijasibu, usanifu majengo na uhandisi; uchunguzi wa kiufundi, utafiti na maendeleo; matangazo na tafiti za kibiashara; huduma nyingine za mifugo.

Katika kipindi cha Aprili hadi Juni mwaka 2017, shughuli hizi zilikuwa kwa kasi ya asilimia 5.4 ikilinganishwa na ukuaji wa asilimia 5.9 katika kipindi kama hicho mwaka 2016. Kasi ya ukuaji wa shughuli hii ulipungua kwa asilimia 0.5 kutokana na kupungua kidogo kwa mahitaji ya huduma za kitaalamu; kisayansi na kiufundi katika kipindi cha Aprili hadi Juni, 2017.

4.3.8 Shughuli Nyingine za Kiutawala na Huduma

Shughuli hizi zinahusika na kukodi na kukodisha mali kupitia madalali, ajira, mawakala wa usafirishaji, usafirishaji watalii na huduma za ulinzi na upelelezi; huduma za majengo na utunzaji

mazingira; uendeshaji ofisi na shughuli nyingine zinazosaidia uendeshaji.

Shughuli hizi zilikuwa kwa kasi ya asilimia 5.0 katika kipindi cha Aprili hadi Juni mwaka 2017 ikilinganishwa na ukuaji wa asilimia 3.2 katika kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuongezeka kwa shughuli za uwakala na udalali katika kipindi husika.

4.3.9 Huduma ya Upangishaji Nyumba

Shughuli hii inahusisha uuzaji, ununuaji, ukodishaji na utoaji wa huduma nyingine za majengo kama vile kutathmini majengo. Shughuli hizi zinaweza kuendeshwa na mwenye jengo au kwa kukodisha na pia zinaweza kuendeshwa kwa kutoza ada au mikataba. Pia shughuli hizi zinajumuisha ujenzi wa miundombinu pamoja na umiliki au ukodishaji wa miundombinu hiyo.

Shughuli za upangishaji nyumba zilikuwa kwa kasi ya asilimia 2.3 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na asilimia 2.4 katika kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuongezeka kwa mahitaji ya nyumba kwa ajili ya makazi hususan katika maeneo ya mijini.

4.3.10 Elimu

Shughuli hii inahusika na utoaji wa elimu katika ngazi mbalimbali katika taasisi binafsi na za umma. Katika kipindi cha Aprili hadi Juni, 2017 ukuaji uliongezeka kwa kasi ya asilimia 5.2 mwaka 2017 ikilinganishwa na asilimia 8.6 kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuongezeka kwa wanafunzi waliodahiliwa katika shule za msingi na sekondari kwa mwaka 2017.

4.3.11 Afya

Shughuli hii inajumuisha utoaji wa huduma za afya ya binadamu na ustawi wa jamii kwa watoa huduma binafsi na umma.

Ukuaji wa shughuli hii uliongezeka hadi kufikia asilimia 7.4 katika kipindi cha robo ya pili ya mwaka 2017 kutoka asilimia 5.5 ya

kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuongezeka kwa utoaji wa huduma kutoka kwa watoa huduma za afya wa binafsi na umma katika kipindi husika.

4.3.12 Huduma Nyingine za Jamii na Shughuli za Kaya Katika Kuajiri

Shughuli hii inajumuisha shughuli za vyama vya siasa, jumuiya mbalimbali za kijamii, matengenezo ya vifaa vya nyumbani ambavyo havijaainishwa katika shughuli nyingine za kiuchumi zilizotajwa. Vilevile inajumuisha shughuli za Sanaa na Burudani na shughuli za Kaya katika kuajiri. Shughuli hizi zilikuwa kwa kasi ya asilimia 7.0 katika kipindi cha robo ya pili ya mwaka 2017 ikilinganishwa na ukuaji wa asilimia 6.4 katika kipindi kama hicho mwaka 2016. Ukuaji huu ulitokana na kuongezeka kwa huduma za kijamii kwa Wananchi na huduma za binafsi.

5.0 Hitimisho

Pato la Taifa limetayarishwa kutokana na taarifa zilizokusanywa kutoka katika shughuli za kiuchumi katika kipindi cha Aprili hadi Juni 2017 na kwa kutumia miongozo ya ukokotoaji wa Pato la Taifa iliyotolewa na Ofisi ya Takwimu ya Umoja wa Mataifa (UNSD) na Shirika la Fedha Duniani (IMF). Katika kipindi hicho, Pato la Taifa lilikuwa kwa kasi ya asilimia 7.8 ikilinganishwa na kasi ya asilimia 8.5 iliyorekebishwa katika kipindi kama hicho mwaka 2016. Shughuli za kiuchumi ambazo zilikuwa kwa kasi kubwa ni pamoja na usafirishaji na uhifadhi mizigo (asilimia 19.8), uchimbaji madini na mawe (asilimia 18.0), uzalishaji viwandani (asilimia 9.3) na ujenzi (asilimia 8.8).

Thamani ya Pato la Taifa kwa bei za soko za mwaka 2007 katika kipindi cha nusu mwaka (Januari hadi Juni), 2017 iliongezeka na kufikia Shilingi trilioni 25.5 kutoka shilingi trilioni 23.9 kipindi cha Januari hadi Juni mwaka 2016, ambayo ni sawa na

kasi ya ongezeko ya asilimia 6.8 ikilinganishwa na asilimia 7.7 ya kipindi kama hicho mwaka 2016. Shughuli za kiuchumi zilizokua kwa kasi kubwa katika kipindi hicho zilikuwa: Uchimbaji Madini na Mawe (asilimia 26.1); Habari na Mawasiliano (asilimia 13.0); Usafirishaji na Uhifadhi mizigo (asilimia 11.3) na Uzalishaji Viwandani (asilimia 8.5).
