INDEX OF INDUSTRIAL PRODUCTION (IIP) FOR OCTOBER - DECEMBER 2024

Definition

The Index of Industrial Production (IIP) measures volume changes in the production by different industrial sectors of an economy. IIP is the index that indicates the performance of various industrial sectors of the economy. The quarterly IIP shows the short-term fluctuations in the economy as well as identifying the turning points in economic development at the earlier stage. Furthermore, it is used in economic policy making and forecasting future economic performance in the industrial sector.

The volume of industrial production is collected every quarter (Q1: January - March), (Q2: April - June), (Q3: July - September) and (Q4: October - December).

Scope, Coverage and Classification

The IIP follows the recommended International Standards Industrial Classification of all economic activities (ISIC) Revision 4 to enhance international comparison. The ISIC classifies all the economic activities of the economy and uses the term 'industry' in a broad sense to mean any economic activity. However, in the compilation of IIP the scope is limited. IIP covers four broad sectors of the economy as classified in International Recommendations for Industrial Statistics of 2008 and International Recommendations for Index of Industrial Production of 2010 namely, mining and quarrying; manufacturing; electricity, gas, steam and air conditioning supply; and water supply; sewerage, waste management and remediation activities. Moreover, IIP covers a total of 285 establishments, 50 industrial activities and a basket of 73 products.

Weighting and a Reference Period

The IIP uses industrial weighting approach for aggregating the elementary indices, this approach focuses on the way industrial production is organized and data is easily accessible. Weights used in IIP are value added for activities derived from the Annual Survey of Industrial Production, 2015. The reference period for IIP is the fourth quarter (October - December) 2018.

Index Calculation Procedures


Indices are calculated by comparing the volume of production in the current period with that in reference (base) period. The result at first stage is a set of volume relatives for the elementary items in the index series. The elementary indices are subsequently aggregated as weighted averages to obtain the indices at higher levels. The base weighted Laspeyres index is used for calculation of index series.

Index of Industrial Production Broad Sectors

The overall Index of Industrial Production increased from 110.6 in the third quarter 2024 to 113.9 in the fourth quarter 2024, recording an increase by 3.0 percentage change over the period. The increase is attributed to water supply; sewerage, waste management and remediation activities which increased by 20.9 percent followed by electricity, gas, steam and air conditioning supply increased by 20.8 percent and mining and quarrying which increased by 1.7 percent

On other hand, long term index recorded an increase from 105.2 in the fourth quarter 2023 to 113.9 of fourth quarter 2024 recording an increase of 8.2 percentage change. The increase was attributed to electricity, gas, steam and air conditioning supply which increased by 18.9 percent, followed by water supply; sewerage, waste management and remediation activities which increased by 14.0 percent and manufacturing which increased by 9.4 percent.

Index of Industrial Production in Manufacturing Industrial Activity

The index in manufacturing sub-sector when comparing current quarter to the previous quarter shows a decrease by 0.5 percent from 117.0 of third quarter 2024 to 116.4 of fourth quarter 2024. A decrease was attributed to manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials which decreased by 20.4 percent followed by manufacture of tobacco products which decreased by 18.6 percent and Manufacture of paper and paper products which decreased by 17.2 percent. Whereas, printing and reproduction of recorded media increased by 21.1 percent followed by manufacture of beverages which increased by 10.6 and manufacture of textiles which increased by 8.1 percent.

On the other hand, comparing IIP in manufacturing sub-sector of fourth quarter of the current year 2024 to the corresponding quarter in the previous year 2023, the results indicate an increase by 9.4 percent from index of 106.4 in fourth quarter 2023 to 116.4 in fourth quarter 2024. The increase was attributed to manufacture of beverages increased by 36.1 percent followed by manufacture of rubber and plastic products increased by 17.3 percent and manufacture of chemicals and chemical products which increased by 16.9 percent. However, during the similar period the index shows a decrease in manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials which decreased by 27.0 percent followed by manufacture of textiles which decreased by 17.5 percent and manufacture of electrical equipment which decreased by 14.8 percent.
