Foreword

Compilation of GDP is consistent with the latest international guideline on compilation of GDP known as the System of National Accounts 2008, and the International Standard of Industrial Classification Rev. 4 (ISIC Rev 4) used to classify all economic activities. The use of internationally agreed standards makes it possible to compare findings for mainland Tanzania with other countries' QGDP.

The fourth Quarter Gross Domestic Product (QGDP) report presents total value of goods and services derived from all economic activities performed in mainland Tanzania for the period of October to December 2024. The QGDP in this report is presented in absolute terms at current prices and constant 2015 prices. Moreover, other items presented are shares to GDP and percentage growth rates by activity.

Findings in this report facilitate frequent and appropriate policy interventions through making available reliable and timely information on recent short-term economic developments. The term "quarter" in this report refers to a period of three months of the Calendar Year (January – March, April – June, July- September, or October – December). The main data sources used in the compilation of this report cover administrative data from all economic activities undertaken during the reference period.

I recognize valuable contributions received from numerous entities and stakeholders, both from public and private, that provided basic input data and information required for the preparation of this report. Moreover, this report serves as a feedback mechanism as well as an avenue for providing views and comments that will be used to improve the quality of the quarterly reports in future.

1.0 Introduction

This report presents Quarterly Gross Domestic Product (QGDP) as one of economic indicators that shows performance trends for all economic activities at current and constant prices for mainland Tanzania. The QGDP facilitates frequent and appropriate policy interventions by providing reliable and timely reports on recent short-term economic developments.

1.1 World Economy

The World Economic Outlook (WEO) October 2024 report revealed the global economy would grow at 3.2 percent in 2025, like the global growth projected in the WEO July 2024 report. The growth was attributed to the strengthening of the United States of America economy thus offsetting downgrades to the growth in the European countries.

1.2 Sub-Saharan Africa

According to the WEO October 2024 report, economic growth among Sub-Saharan Africa countries was projected to grow at 3.6 percent in 2024, like the growth projected in the WEO July 2024 report. South Africa's economy was projected to grow at 1.1 percent in 2024 which is 0.4 percentage points lower than 1.7 percent growth projected in the WEO July 2024 report. Moreover, Nigeria's economy was estimated to grow at the rate of 2.9 percent, like the growth projected in the WEO July 2024 report.

1.3 Southern Africa Development Community

Assessment of economic growth for selected member countries of the Southern African Development Community (SADC) shows that South Africa's economy increased by 0.6 percent in the fourth quarter of 2024 as compared to a growth of 0.3 percent registered in the similar period in 2023. Namibia's economy expanded by 3.1 percent compared to 5.7 percent observed in the corresponding period in 2023. Botswana's economy contracted by 2.0 percent compared to 2.3 percent recorded in the similar quarter in 2023. Further, Tanzania's economy grew by 5.2 percent in the fourth quarter in 2024 compared to 5.0 percent recorded in the similar period in 2023.




Figure 1: Fourth Quarter GDP Growth Rates for Selected SADC Countries in 2023 and 2024

1.4 East Africa Community




Figure 2: Fourth Quarter GDP Growth Rates for Selected EAC Countries, 2020 – 2024

The East African Community member countries, that have published reports on economic performance during the fourth quarter of 2024 are Rwanda, Uganda and Tanzania. During the period under review, Rwanda's economy grew by 8.0 percent as compared to 10.0 percent recorded in the similar quarter in 2023. Uganda's economy expanded by 5.3 percent compared to 5.8 percent registered in the similar period in 2023. Furthermore, Tanzania's economy grew by 5.2 percent compared to 5.0 percent recorded in the corresponding period in 2023. Reports on economic performance for other East African Community Partner States have not yet been published on the websites of the respective National Statistical Offices (**Figure 2**).

1.5 GDP Compilation in Tanzania

The fourth quarter GDP (October – December) 2024 compilation used data collected from all economic activities. GDP estimates were compiled in accordance with the United Nations Statistics Division's guideline known as the **System of National Accounts (SNA) 2008**. The report presents the highlights of the fourth quarter Gross Domestic Product at current prices and constant prices for mainland Tanzania using the 2015 base year.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in 2019. The policy allows publication of provisional results subject to availability of new or revised quarterly and/or annual data. Gross Domestic Product estimates have been aligned in consistent with the revised balance of payment statistics released by Bank of Tanzania for year 2017 to 2023.

1.5.1 Fourth Quarter GDP Growth Rate 2024

During the period under review, the quarterly Gross Domestic Product (QGDP) 2024 at current prices in absolute terms increased to TZS 56.5 trillion up from TZS 50.6 trillion recorded in the similar quarter in 2023. Furthermore, real QGDP 2024 at (*at constant 2015 prices*) increased to TZS 41.9 trillion, up from TZS 39.9 trillion registered in the corresponding period in 2023, equivalent to 5.2 percent growth.




Figure 3: Fourth Quarter GDP Growth Rates, 2020 – 2024

1.5.2 Share to GDP by Broad Economic Classification

Analysis of broad economic activities share to GDP during the fourth quarter 2024 revealed that, primary activities accounted for the largest share of 42.9 percent, followed by tertiary activities (37.4 percent) and secondary activities (19.7 percent). Note that shares to GDP were compiled before adjustment for taxes.




Figure 4: Percentage Share to GDP by Broad Economic Activities at Current Prices

1.5.3 Fourth Quarter GDP Growth by Economic Activities, 2024

During the fourth quarter of 2024, the GDP at constant prices increased by 5.2 percent, up from 5.0 percent growth recorded in the corresponding period in 2023. Economic activities that recorded significant growth rates include: Electricity (15.0 percent); Financial and insurance (14.2 percent); Information and Communication (10.0 percent); Mining and quarrying (8.5 percent); Other Social Services (7.5 percent); Human Health (5.9 percent); Public Administration and Defence (5.9 percent); Accommodation and Food Services (5.7 percent); Education (5.6 percent); Professional, Scientific and Technical activities (5.6 percent); and Transport and Storage (5.3 percent).




Figure 5: Growth Rates by Economic Activity for the Fourth Quarter in 2024

1.5.4 Contribution to Growth

All economic activities that took place between October and December 2024 accounted differently to the growth of the economy. During the reference period, agriculture had the largest contribution to growth of 21.1 percent, followed by Financial and insurance (10.1 percent); Mining and quarrying (8.7 percent); Construction (8.4 percent); Trade and repair (8.1 percent); Transport and Storage (7.4 percent); and Manufacturing (6.1 percent).

2.0 Sectoral Performance

2.1 Agriculture, Forestry and Fishing

This sector includes exploitation of vegetables and animal natural resources that comprise of growing crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats.

2.1.1 Crops

Major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

The activity grew by 4.0 percent in the fourth quarter of 2024, compared to 3.9 percent achieved in the similar quarter in 2023. This growth was driven by an increase in crop production, which benefited from the use of enhanced technology and inputs, including extension services.




Figure 6: Production of Selected Crops in Tones (000), Fourth Quarter 2023 and 2024

The crops that significantly contributed to the growth of crops sub activity in the fourth quarter of 2024 were paddy, beans and pulses, banana, sorghum/millet and cashew nuts. During the reference period, paddy production increased by 9.6 percent from 868 thousand tons in 2023 to 952 thousand tons in the corresponding period in 2024, beans and pulses harvested increased by 11.2 percent from 409 thousand tons in 2023 to 455 thousand tons in 2024. Furthermore, bananas increased by 8.2 percent from 270 thousand tons in 2023 to 293 thousand tons in 2024, sorghum/millet production increased by 7.6 percent from 238 thousand tons in 2023 to 256 thousand tons in 2024 and cashew nuts increased by 22.4 percent from 88 thousand tons in 2023 to 107 thousand tons in 2024.

2.1.2 Livestock

The activity covers livestock rearing activities, improved and indigenous cattle; goats; sheep; donkeys and horses; guinea pigs and rabbits; indigenous and commercial chicken; and other poultry.

During the period from October to December 2024, livestock activity grew by 5.0 percent similar to the growth rate recorded in the corresponding period in 2023. The demand for livestock-based products, increase in per capita income, urbanization, taste preference as well as increased awareness on food nutrition attributed to the growth.

2.1.3 Forestry and Logging

Forestry and Logging The activity covers production of timber, charcoal, fuel wood and Logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity recorded a growth rate of 2.9 in the fourth quarter of 2024 compared to 4.7 percent achieved in the corresponding quarter in 2023. The government intervention to ensure sustainable harvest of forest products attributed to the growth.

2.1.4 Fishing

Fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products.

The fishing activity recorded a growth rate of 2.2 percent in the fourth quarter of 2024 compared to 0.9 percent registered in the corresponding quarter in 2023. The growth was attributed to Government efforts to ensure sustainable fish catch and fish products.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction done can be from underground, on the surface mining or well operation. It also includes supplementary activities aimed at preparing the crude materials for marketing, for example, crushing and grinding; cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations. Mining and quarrying activity is divided into four industries, which are:

- i. Mining of coal, lignite, and extraction of peat;
- ii. Crude petroleum and natural gas;
- iii. Mining of metal ores; and
- iv. Other mining and quarrying.

The activity grew at 8.5 percent in the fourth quarter of 2024 compared to 6.9 percent recorded during the similar quarter in 2023. The growth is attributed to an increased production in some minerals, including Gold, Diamond, Tanzanite, Copper ore, Coal, Phosphate, Kaolin, Bauxite, Gypsum, Mica, Limestone, Pozzolana, and Feldspar (Table 1).

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity expanded by 3.9 percent in the fourth quarter of 2024 compared to 3.6 percent registered in the corresponding quarter in 2023. The growth rate was attributed to an increase in the production of industrial goods.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers the supply of electric power and natural gas, through permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity is involved in the generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The main sources of data are power generation companies.

During the period of October to December 2024, the activity recorded a growth rate of 15.0 percent in the fourth quarter of 2024 compared to 2.7 percent in the similar quarter in 2023. This growth rate is a result of the operations of new JNHPP.

2.5 Water Supply and Sewerage

The activity includes collection and purification of water for water supply purposes, desalting sea water to produce water as the principal product of interest and collecting water directly from wells

for use by water supply companies or used on own account in agriculture or households. It also includes water distribution activities.

The indicator for the growth of water supply activity is the quantity of water produced. During the period, the quantity of water produced increased to 101.8 million cubic meters from 98.3 million cubic meters recorded in the similar quarter in 2023.

The activity grew at a rate of 3.5 percent compared to 0.1 percent in the corresponding quarter in 2023. Improvement in water production infrastructure, increased capacity, and production to match water demand due to among others population growth specifically in urban areas.




Figure 7: Water Production (Mill. Cubic Meters), Fourth Quarter 2020 – 2024

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of temporary nature.

General construction deals with construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., It also includes construction of civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc.

During the fourth quarter of 2024, the activity recorded a growth rate of 3.3 percent compared to 2.9 percent in the corresponding quarter in 2023. The growth was attributed to an increase in local production of construction materials including cement production; and iron and steels which are proxies for construction activities.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sales (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves buying and selling goods.

The activity recorded a growth rate of 5.0 percent in the fourth quarter of 2024 compared to a growth rate of 5.8 in the fourth quarter in 2023. The growth was attributed to an increase in goods traded for agriculture, manufactured goods and imported goods.

2.8 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water, or air and associated activities such as cargo handling, storage, etc. The activity also includes renting transport equipment with a driver or operator and postal and courier activities.

The activity recorded a growth rate of 5.3 in the fourth quarter of 2024 compared to 4.6 percent achieved in the corresponding quarter in 2023. The growth was attributed to an increase in cargo tonnage and the number of passengers transported by road and standard gauge railway transport services.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers and the provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

Accommodation and food services recorded a growth rate of 5.7 in the fourth quarter 2024 compared to 6.7 percent achieved in the corresponding quarter in 2023. The growth was attributed to an increase in number of tourist arrivals. During the quarter under review, the number of tourist arrivals increased by 14.4 percent to 581,254 in 2024, up from 508,215 recorded in the similar period in 2023 as well as an increase in the number of bed occupancy.

2.10 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities, and information service activities e.g., data processing, and news agencies.

The activity recorded a growth rate of 10.0 percent in the fourth quarter of 2024 compared to 9.7 percent in the corresponding quarter in 2023. The growth rate was attributed to an increase in the number of voice traffic per minute; the number of short messages services traffic (SMS); the average number of mobile money subscribers and the expansion of broadcasting and internet services in the country.

2.11 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, and auxiliary to financial services. It also includes the activities of holding assets, such as holding companies, trusts, funds, and similar financial entities.

The activity recorded a growth rate of 14.2 percent in the fourth quarter of 2024 compared to 13.2 percent in the similar quarter in 2023. The growth was attributed to an increase by 13.3 percent in the level of deposits from 35.3 trillion in 2023 to 40.1 trillion in 2024; an increase by 13.4 percent in the level of lending from 32.9 trillion in 2023 to 37.3 trillion in 2024; and an increase in the growth rate of insurance services by 7.9 percent in the fourth quarter 2024 from 7.0 percent in the corresponding quarter in 2023.




Figure 8: Loans and Deposits Stock (TZS Trillion), Fourth Quarter 2020 - 2024

2.12 Real Estate

This activity includes selling or buying real estate, renting real estate, providing other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity increased by 4.3 percent in the fourth quarter of 2024, compared to 4.6 percent observed in the corresponding quarter in 2023. The growth was attributed to an increase in demand for accommodation, especially in urban areas.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activities require a high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity recorded a growth rate of 5.6 percent in the fourth 2024 compared to 8.0 percent registered in the similar period in 2023. The growth rate was due to an increase in professional, scientific and technical services during reference period.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth of 3.5 percent in the fourth quarter of 2024 compared to 2.9 percent observed in the corresponding period in 2023. The performance of travel agents and tour operators' activities is attributed to the growth rate of the activity.

2.15 Public Administration and Defence; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defence, public order and safety, immigration services, foreign affairs and the administration of government programmes. This activity also includes compulsory social security activities.

The public administration and defence activity increased by 5.9 percent in the fourth quarter of 2024 compared to 4.5 percent recorded in the corresponding period in 2023. The growth was due to an increase in Government salaries and other spending on maintaining peace and order, as well as the provision of social services.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at its different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

Education activity recorded a growth rate of 5.6 percent in the fourth quarter of 2024 compared to 5.2 percent observed in the corresponding quarter in 2023. The growth was attributed to an increase in the number of students enrolled at all levels of education in public and private institutions.

2.17 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

Human health and social work activity recorded a growth rate of 5.9 percent in the fourth 2024 compared to a growth rate of 5.8 percent in the similar quarter in 2023. The growth was attributed to a continued improvement in the provision of better health services at all levels.

2.18 Other Social Services

This industry includes the activities of membership organizations, the repair of computers and personal and household goods and a variety of personal service activities not covered elsewhere in the classification. It also includes Art, Entertainment and Recreation and Activities of Households as Employers.

The activity increased by 7.5 percent in the fourth quarter of 2024 compared to 7.2 percent in the similar quarter in 2023. The growth of the activity was attributed to an increase in tourist arrivals, urban population, and personal service activities.

3.0 Conclusion

During the fourth quarter of 2024, the GDP at constant prices increased by 5.2 percent, up from 5.0 percent growth recorded in the similar period in 2023. Economic activities that recorded significant growth rates include: Electricity (15.0 percent), Financial and insurance (14.2 percent); Information and communication (10.0 percent); Mining and quarrying (8.5 percent); Other Social Services (7.5 percent), Health (5.9 percent), Public Administration and Defence (5.9 percent); Accommodation and food services (5.7 percent); Education (5.6 percent), Professional, scientific and technical services (5.6 percent); and Transport and storage (5.3 percent).
