Preface

Gross Domestic Product (GDP) compilation in Mainland Tanzania is consistent

with the latest international guideline known as the System of National Accounts

2008 (2008 SNA), and the International Standard of Industrial Classification

Revision. 4 (ISIC Rev 4) used to classify all economic activities. The use of

internationally agreed standards makes it possible to compare findings from

Mainland Tanzania with other countries' Quarterly Gross Domestic Product

(QGDP).

Findings in these reports facilitate frequent and appropriate policy interventions

using available reliable and timely information on recent short-term economic

developments. The term "quarter" in this report refers to a period of three months

of the Calendar Year (January – March, April – June, July- September, or October

– December). The main data sources used in the compilation of these reports were

administrative data from all economic activities undertaken during the reference

period.

The first QGDP presents total value of goods and services derived from all

economic activities performed in Mainland Tanzania for the period of January to

March 2025. The first QGDP in this report is presented in absolute terms at current

prices and constant 2015 prices. Moreover, other items presented are shares to

GDP and growth rates by activity presented as percentages.

I recognize valuable contributions received from numerous entities and

stakeholders, both public and private, that provided basic input data and

information required for the preparation of this report. Moreover, this report serves

as a feedback mechanism as well as an avenue for providing views and comments

that will be used to improve the quality of quarterly reports in future.

1.0 Introduction

This report presents Quarterly Gross Domestic Product (QGDP) being one of economic indicators that shows trend of performance for all economic activities at current and constant prices for Mainland Tanzania. The QGDP facilitates frequent and appropriate policy interventions by providing reliable and timely reports on recent short-term economic developments.

1.1. World Economy

The World Economic Outlook (WEO) report released in April 2025 revealed the projection of global economic growth at 2.8 percent in 2025, compared to the 3.3 percent projected in the WEO report released in January 2025. The update is lower than the projected growth made in January 2025 by 0.5 percentage points. The global economic slowdown is largely on account to the United States' implementation of a new tariff plan affecting its trading partners. This move has triggered significant trade tensions, which have a substantial impact on global economic activity.

1.2. Sub-Saharan Africa

According to the WEO April 2025 report, economic growth in Sub-Sahara countries is projected to grow at 3.8 percent in 2025, compared to 4.2 percent projected in the WEO January 2025 report. South Africa's economy is projected to grow by 1.0 percent in 2025, representing a downward revision of 0.5 percentage points from 1.5 percent projected in the WEO January 2025 report. Meanwhile, Nigeria's economic growth is projected at 3.0 percent, slightly lower than the 3.2 percent estimated in the WEO January 2025 report.

1.3. Southern Africa Development Community

Assessment of economic growth of selected countries in the Southern African Development Community (SADC) for the period of January to March 2025 indicated that South Africa's economy grew by 0.8 percent, up from 0.5 percent growth recorded in 2024. Namibia's economy expanded by 2.7 percent down, from 4.8 percent observed in the corresponding period in 2024. Botswana's economy increased by a negative growth rate of 0.1 percent up, from a negative 1.9 percent growth registered in the similar quarter in 2024. Additionally, Tanzania's economy grew by 5.4 percent in the first quarter of 2025 compared to 5.2 percent recorded in the corresponding period in 2024.





Figure 1: First Quarter GDP Growth Rates for Selected SADC Countries in 2024 and 2025

1.4. **East African Community**

The East Africa Community Partner States, that have published reports on economic performance during the first quarter of 2025 are Rwanda, Uganda and Tanzania. During the period under review, Uganda's economy expanded by 8.6 percent, compared to 7.1 percent registered in the similar period in 2024. Rwanda's economy grew by 7.8 percent, compared to 9.7 percent recorded in the corresponding quarter in 2024. Moreover, Tanzania's economy grew by 5.4 percent up, from 5.2 percent recorded in the corresponding period in 2024. Reports on economic performance for the remaining East Africa Community Partner States have not yet been published on the websites of respective National Statistical Offices (Figure 2).

1.5. GDP Compilation in Tanzania

The first quarter GDP (January – March) 2025 compilation used data collected from all economic activities. GDP estimates were compiled in accordance with the United Nations Statistics Division's guideline known as **the System of National Accounts (SNA) 2008**. The report presents the highlights of the first quarter Gross Domestic Product at current prices and constant prices for Mainland Tanzania, base year 2015.

The National Bureau of Statistics is also implementing the National Accounts Revision Policy that became operational in 2019. The policy allows publication of provisional results subject to availability of new or revised quarterly and/or annual data. Gross Domestic Product estimates have been aligned to the revised balance of payment statistics released by Bank of Tanzania for the period from 2017 to 2024.

1.5.1 First Quarter GDP Growth Rate 2025

During the period under review, the first quarter Gross Domestic Product (QGDP) 2025 at current prices in absolute terms increased to TZS 54.2 trillion, from TZS 49.8 trillion recorded in the similar quarter in 2024. Furthermore, GDP at constant 2015 prices increased to TZS 40.7 trillion, from TZS 38.6 trillion registered in the corresponding period in 2024, equivalent to 5.4 percent growth.

1.5.2 Share to GDP by Broad Economic Classification

Analysis of activities based on Broad Economic Classification (BEC) revealed that during the period under review, **Primary Activities** accounted for the largest share of **40.7 percent**, followed by **Tertiary Activities** (**37.9 percent**) and **Secondary**

Activities (21.4 percent). Note that shares to GDP were compiled before adjustment for taxes.




Figure 4: Share to GDP by Broad Economic Activities at Current Prices

1.5.3 First Quarter GDP Growth by Economic Activities, 2025

During the first quarter of 2025, GDP at constant prices increased by 5.4 percent from 5.2 percent growth recorded in the corresponding period in 2024. Economic activities that recorded significant growth rates were: Electricity (19.0 percent); Mining and Quarrying (16.6 percent); Finance and Insurance (15.4 percent); Education (8.6 percent), Information and Communication (7.8 percent); Manufacturing (7.2 percent); and Transport and Storage (6.5 percent)




Figure 5: First Quarter Growth Rates by Economic Activity 2025

1.5.4 Contribution to Growth

All economic activities that took place between January and March 2025 contributed differently to the growth of 5.4 percent. During the reference period, Mining and Quarrying activity recorded the largest contribution to growth of 15.4 followed by Agriculture (14.2 percent); Finance and Insurance (12.0) percent); Construction (11.3 percent); Manufacturing (10.4 percent); and Transport and Storage (9.3 percent).

2.0 Sectoral Performance

This section provides highlights of the economic activities carried out and their corresponding growth rates between the first quarter of 2025 and 2024. Activities outlined in the sub-sections include crop production, livestock, forestry, and fishing. Other economic activities covered are mining and quarrying; manufacturing; electricity, water supply, and construction. In addition, the section outlines other sectors such as trade and repairs; transportation and storage; accommodation and food services; information and communication; financial and insurance services; real estate; professional, technical and scientific services; public administration and defense-related services; as well as education, human health, and other services activities.


2.1 Agriculture, Forestry and Fishing

This sector includes exploitation of vegetables and animal natural resources that comprise of growing crops, raising and breeding of animals, harvesting of timber and other plants, animals or animal products from a farm or their natural habitats. Agriculture, Forestry and Fishing increased by 3.0 percent, up from 2.5 percent achieved during the similar period in 2024.

2.1.1 Crops

Major crops covered include maize, paddy, sorghum/millet, other cereals, cassava, round potatoes, sweet potatoes, other roots and tubers, beans and other pulses, dried oil seeds, other vegetables, bananas, other fruits, cashew nuts, coffee, cotton, tea, tobacco and other food and cash crops.

The activity expanded to 2.0 percent in the first quarter of 2025 from 1.4 percent observed in the corresponding quarter in 2024. The growth was attributed to an increase in crop production, which benefited from the use of enhanced technology and inputs, including extension services.

This section focuses on the crops that contributed the most to the growth of crop production activity during the first quarter of 2025. The crops are paddy, beans and pulses; oil seeds, and wheat. During the reference period, paddy production increased by 9.6 percent from 568.9 thousand tons in 2024 to 623.3 thousand tons in the corresponding period in 2025, beans and pulses harvested increased by 0.9 percent from 178.5 thousand tons in 2024 to 180.1 thousand tons in 2025. Furthermore, Oils seeds production increased by 5.5 percent from 122.7 thousand

tons in 2024 to 129.5 thousand tons in 2025. Additionally, wheat production increased by 29.4 percent from 29.6 thousand tons to 38.3 thousand tons in 2025.

2.1.2 Livestock

The activity covers livestock rearing activities, improved and indigenous cattle; goats; sheep; donkeys and horses; guinea pigs and rabbits; indigenous and commercial chicken; and other poultry.

During the period of January to March 2025, livestock activity recorded the growth rate of 5.0 percent, similar to the growth rate observed in the corresponding period in 2024. The demand for livestock-based products, increase in per capita income, urbanization, taste preference as well as increased awareness on food nutrition attributed to the growth.

2.1.3 Forestry and Logging

Forestry and Logging The activity covers production of timber, charcoal, fuel wood and Logs, twigs, faggots (bundle of branches) and non-wood forest products.

Forestry activity expanded by 2.8 percent in the first quarter of 2025 compared to 1.1 percent observed in the corresponding quarter in 2024. The government intervention to ensure sustainable harvest of forest products attributed to the growth.

2.1.4 Fishing

Fishing activity covers the harvest of fishery resources from marine or freshwater environments, with the goal of capturing fish, crustaceans, and other marine products. Fishing activity recorded a growth rate of 2.2 percent in the first quarter of 2025 compared to 2.0 percent registered in the corresponding quarter in 2024. The growth was attributed to Government efforts to ensure sustainable fish catch and fish products.

2.2 Mining and Quarrying

Mining and quarrying include the activities of extraction of minerals occurring naturally as solids (coal and ores), liquids (petroleum) or gases (natural gas). Extraction done can be from underground, on the surface mining or well operation. It also includes supplementary activities aimed at preparing the crude materials for marketing, for example, crushing and grinding; cleaning, drying, sorting, concentrating ores, liquefaction of natural gas and agglomeration of solid fuels. The units located nearby often accomplish the operations. Mining and quarrying activity is divided into four industries, which are:

- i. Mining of coal, lignite, and extraction of peat;
- ii. Crude petroleum and natural gas;

- iii. Mining of metal ores; and
- iv. Other mining and quarrying.

The activity increased by 16.6 percent in the first quarter of 2025, compared to the 3.5 percent recorded during the similar quarter in 2024. The growth was attributed to an increased production in some minerals, including Gold, Diamond, Copper ore, Coal, Phosphate, Kaolin, Dolomite, Gypsum, Mica, Limestone and Iron (**Table 1**).

2.3 Manufacturing

Manufacturing activity involves physical or chemical transformation of materials, substances, or components into final or semi processed goods. The materials include products of agriculture, forestry, fishing, mining and quarrying as well as products of other manufacturing activities.

The activity recorded a growth rate of 7.2 percent in the first quarter of 2025 compared to 5.8 percent registered in the corresponding quarter in 2024. The growth was attributed to an increase in the production of manufactured goods.

2.4 Electricity, Gas, Steam and Air Conditioning Supply

The activity covers provision of electric power and natural gas, through permanent infrastructure (network) of lines, mains, and pipes. Specifically, the activity involves generation of electricity mainly from hydro, thermal and gas sources. It also includes electricity transmission and distribution activities. The primary sources of electricity generation data include the power generation companies such as TANESCO, SONGAS, TANWAT, TPC, as well as other Independent Power Producers.

The growth of electric generation activities depends on the amount of electricity produced and distributed to customers. The activity increased by 19.0 percent in the first quarter of 2025 compared to 7.6 percent in the similar quarter of 2024 largely due to the commencement of power generation at the Julius Nyerere Hydropower Dam.

2.5 Water Supply and Sewerage

The activity includes collection and purification of water for water supply purposes, desalting sea water to produce water as the principal product of interest and collection of water directly from wells for use by water supply companies or used on own account in agriculture or households. It also includes water distribution activities.




Figure 7: Water Production, First Quarter 2021 – 2025

The indicator for the growth of water supply activity is the quantity of water produced. During the reference period, the quantity of water produced increased to 98.9 million cubic meters from 94.7 million cubic meters recorded in the similar quarter in 2024. The activity grew at a rate of 4.2 percent in the first quarter of 2025 from 3.1 percent recorded in the corresponding quarter in 2024 (**Figure 7**).

2.6 Construction

This activity includes general construction and specialized construction activities for buildings and civil engineering works. It includes new work, repair, additions and alterations, the erection of prefabricated buildings or structures on the site and construction of temporary nature.

General construction deals with construction of entire dwellings, office buildings, stores and other public and utility buildings, farm buildings etc., It also includes construction of civil engineering works such as motorways, streets, bridges, tunnels, railways, airfields, harbours and water projects, irrigation systems, sewerage systems, industrial facilities, pipelines and electric lines, sports facilities etc.

During the first quarter of 2025, the activity recorded a growth rate of 4.3 percent compared to 6.4 percent in the corresponding quarter in 2024. Construction growth

is assessed based on indicators of domestically produced goods which are used in construction activities. The growth was attributed to an increase in local production of construction materials including cement production; and iron steels.

2.7 Wholesale and Retail Trade; Repair of Motor Vehicles, Motorcycles and Personal and Household Goods

The activity includes wholesale and retail sales (sale without transformation) of any type of goods, as well as rendering services incidental to the sale of merchandise. It also includes repair of motor vehicles and installation and repair of personal and household goods. The activity involves buying and selling of goods.

The activity recorded a growth rate of 3.5 percent in the first quarter of 2025 compared to 5.3 in the first quarter of 2024. The growth was due to an increase in goods traded for agriculture, manufactured goods and imported goods.

2.8 Transport and Storage

This activity includes the provision of passenger or freight transport, whether scheduled or not, by rail, pipeline, road, water, or air and associated activities such as cargo handling, storage, etc. The activity also includes renting transport equipment with a driver or operator and postal and courier activities.

The activity expanded by 6.5 in the first quarter of 2025 compared to 5.7 percent registered in the similar quarter in 2024. The growth was attributed to an increase in cargo tonnage and the number of passengers transported by road and standard gauge railway transport services.

2.9 Accommodation and Food Services

This activity includes the provision of short-stay accommodation for visitors and other travelers, and provision of complete meals and drinks fit for immediate consumption. The amount and type of supplementary services provided within this section can vary widely.

in the first quarter of 2025, Accommodation and food services recorded a growth rate of 2.3 compared to 7.2 percent observed in the corresponding quarter in 2024. The growth was attributed to an increase in number of tourist arrivals. During the period under review, the number of tourist arrivals increased by 1.3 percent to 526,856 in 2024 from 520,324 recorded in the similar period in 2024 as well as an increase in the number of bed occupancy.

2.10 Information and Communication

The activity covers publishing activities, motion picture, video and television programming production, sound recording and music publishing, programming and broadcasting activities, e.g., radio and television broadcasting, telecommunications, computer programming, consultancy and related activities, and information service activities e.g., data processing, and news agencies.

The activity recorded a growth rate of 7.8 percent in the first quarter of 2025 compared to 14.6 percent in the corresponding quarter in 2024. The growth rate was attributed to an increase in the number of voice traffic per minute; the number of short messages services traffic (SMS); the average number of mobile money subscribers and the expansion of broadcasting and internet services in the country.

2.11 Financial and Insurance Services

The activity covers financial services, insurance and reinsurance, voluntary pension funding, and auxiliary to financial services. It also includes the activities of holding assets, such as holding companies, trusts, funds, and similar financial entities.

The activity increased by 15.4 percent in the first quarter of 2025 compared to 14.9 percent in the similar quarter in 2024. The growth was driven by 18.5 percent increase in customers' deposits, from TZS 36.3 trillion in the first quarter of 2024 to TZS 43.0 trillion in the similar period in 2025. Meanwhile, loans increased by 14.7 percent from TZS 34.1 trillion in the first quarter of 2024 to TZS 39.1 trillion in the corresponding period in 2025.




Figure 8: Stock of Loans and Deposits, First Quarter, 2021 – 2025

2.12 Real Estate

This activity includes selling or buying real estate, renting real estate, provision of other real estate services such as appraising real estate. Activities in this industry may be carried out on own or leased property and may be done on a fee or contract basis. Also included is the building of structures, combined with maintaining ownership or leasing of such structures.

The activity increased by 4.3 percent in the first quarter of 2025, compared to 4.2 percent observed in the corresponding quarter in 2024. The growth was attributed to an increase in demand for accommodation, especially in urban areas.

2.13 Professional, Scientific and Technical Activities

This activity includes specialized professional, scientific and technical activities. The activity requires high degree of training, as well as making specialized knowledge and skills available to users. The activity includes legal and accounting; activities of head offices; management consultancy; architectural and engineering; technical testing and analysis; scientific research and development; advertising and market research; other professional; scientific and technical as well as veterinary activities.

The activity expanded by 5.1 percent in the first quarter of 2025 compared to 4.5 percent registered in the corresponding period in 2024. The expansion was attributed to an increase in professional, scientific and technical services during reference period.

2.14 Administrative and Support Services

The activity includes a variety of services that support general business operations. Administrative and support services involve rental and leasing; employment; travel agency; tour operator; reservation service and related activities; security and investigation; as well as services to buildings and landscape.

The activity recorded a growth of 3.7 percent in the first quarter of 2025 compared to 5.2 percent observed in the similar quarter in 2024. The performance of travel agents and tour operators' services was attributed to an increase in number of tourist arrivals.

2.15 Public Administration and Defense; Compulsory Social Security

The activity includes the enactment and judicial interpretation of laws, legislative activities, taxation, national defense, public order and safety, immigration services, foreign affairs and the administration of government programmes. This activity also includes compulsory social security services.

The public administration and defense recorded a growth of 4.1 percent in the first quarter of 2025 compared to 5.0 percent observed in the similar quarter in 2024. The growth was attributed to an increase in Government salaries, arrears and other government expenditure for maintaining peace and order, as well as the provision of social services.

2.16 Education

This activity includes education at any level or for any profession, oral or written as well as by radio and television or other means of communication. It includes education by the different institutions in the regular school system at different levels as well as adult education, literacy programs etc. The activity includes public as well as private education.

Education activity increased to 8.6 percent up, during the period of January to March 2025, from 5.5 percent observed in the similar quarter in 2024. The growth was attributed to an increase in the number of students enrolled at all levels of education in both public and private institutions.

2.17 Human Health and Social Work

The activity includes the provision of health and social services. It includes a wide range of activities, including health care provided by trained medical professionals in hospitals and other facilities, other residential care activities that still involve a degree of health care activities to social work activities without any involvement of health care professionals.

Human health and social work activity recorded a growth rate of 4.1 percent in the first quarter of 2025 compared to a growth rate of 9.0 percent registered in the similar quarter in 2024. The growth was attributed to a continued improvement in the provision of better health services at all levels.

2.18 Other Services Activities

This industry includes the activities of membership organizations; repair of computers and personal and household goods; and a variety of personal services not covered elsewhere in the classification. It also includes Art, Entertainment and Recreation, and Activities of Households as Employers.

The activity recorded a growth rate of 5.0 percent in the first quarter of 2025 compared to 8.6 percent in the similar quarter in 2024. The growth of the activity was attributed to an increase in tourist arrivals, urban population, and personal service activities.

3.0 Conclusion

During the first quarter of 2025, GDP at constant prices increased by 5.4 percent up, from 5.2 percent recorded in the similar period in 2024. Economic activities that recorded significant growth rates were Electricity (19.0 percent), Mining and Quarrying (16.6 percent); Finance and Insurance (15.4 percent); Education (8.6 percent), Information and Communication (7.8 percent); Manufacturing (7.2 percent); and Transport and Storage (6.5 percent); (**Figure 1**).
