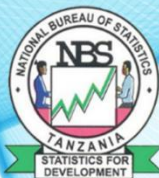

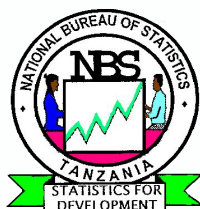

Preface

The compilation of Gross Domestic Product (GDP) in the United Republic of Tanzania (URT) is consistent with the System of National Accounts 2008 (2008 SNA). The use of internationally agreed standards enables the comparison of Quarterly Gross Domestic Product (QGDP) estimates of the United Republic of Tanzania with those of other countries.

The findings presented in this report will facilitate appropriate policy interventions through the provision of timely information for assessing recent short-term economic developments. The term “quarter” in this report refers to a period of three months of the calendar year (January – March, April– June, July- September, and October– December). The data sources are mainly administrative records.

The QGDP estimates of the URT measure the total values of goods and services produced from all economic activities in the country, in this case from the first quarter of 2016 to the fourth quarter of 2025. This report provides QGDP estimates at current and constant market prices, including quarterly GDP shares and growth rates by economic activity for the period 2016 -2025

I sincerely thank all our stakeholders in both the public and private sectors for providing the key data that made this report possible. The National Bureau of Statistics and the Office of the Chief Government Statistician are committed to continuing this partnership to improve our statistical system and the availability of essential data. This work is vital for accurately tracking economic progress and national development.

1.0. Introduction and Background

1.1. Introduction

The National Accounts Statistics of Mainland Tanzania and Zanzibar were rebased from 2015 base year to the 2019 base year. Parallel to this activity, the National Accounts for the URT were developed for the first time in history, with annual and quarterly GDP series covering the period from 2016 – 2025. The URT Quarterly GDP estimates are among the key outcomes of the four quarterly GDP harmonisation workshops conducted between mid-2025 and 2026 for developing the URT quarterly Gros Domestic Product

The Quarterly GDP Harmonisation Workshops were conducted as part of the ongoing efforts to improve coverage and build capacity of compilers, and enhance the quality, consistency, comparability, and reliability of National Accounts Statistics for the URT. The workshops were coordinated by the National Bureau of Statistics (NBS) and the Office of Chief Government Statistician (OCGS), Zanzibar. These harmonisation workshops were necessary for in-depth review of the methodology, discuss and agreement on the QGDP harmonisation and aggregation approach, establishing a time rame for the submission of individual quarterly GDP estimates, release calendar, and addressing sustainability issues. Furthermore, a list of National Accounts tables for publication was also identified.

The workshop provided an opportunity for the experts to review and analyse sectoral developments and assess growth trends across economic activities, identify areas for improvement, including data gaps in both Mainland and Zanzibar. The general consensus was to ensure continuous improvement of the consolidated quarterly GDP estimates. This report summarizes the proceedings of the four quarterly GDP harmonisation and aggregation workshops, highlights the outputs of the workshops, and presents an overview of quarterly performance using GDP as a key indicator used to support evidence-based decision making in the United Republic of Tanzania.

1.2. Background

The first series of the United Republic of Tanzania GDP, base year 2019, was compiled from the revised GDP estimates for Mainland and Zanzibar GDP, which had initially been compiled separately. These estimates are crucial for policy formulation and monitoring of national, regional, and international development programmes, including Tanzania Vision 2050, the East African Community (EAC) Vision 2050, Agenda 2063 : The Africa We

Want, and the Sustainable Development Goals (SGDs) 2030. To improve data quality and comparability between NBS and OCGS, harmonisation workshops were organised to aggregate the revised QGDP series period 2016 to 2025, using base year 2019. This was necessary not only to expand coverage of National Accounts statistics but also to ensure consistency with internationally accepted statistical standards, including the Ten Fundamental Principles of Official Statistics.

The Ten Fundamental Principles provide the ethical, legal, and professional framework for producing official statistics, while harmonisation of national accounts is achieved through the application of these principles alongside internationally agreed standards such as 2008 SNA. Together, they ensure the accuracy, reliability, transparency, consistency, and comparability of national accounts statistics across countries and over time.

1.3. Objectives

The workshops focused on harmonizing compilation methodologies and classifications before integration of separately prepared Mainland Tanzania and Zanzibar revised QGDP estimates, base year of 2019. Specifically, the workshops and integration process were conducted to achieve the following objectives:

- ❖ Review individual QGDP estimates from Mainland and Zanzibar
- ❖ Harmonize compilation methodologies and classifications
- ❖ Validate consolidated QGDP estimates for the URT and produce a report
- ❖ Consolidate validated data into the URT estimates
- ❖ Discuss and agree on sustainability and an action plan after dissemination of the first URT estimates
- ❖ Prepare a roadmap and agree on recommendations for the sustainability of URT QGDP estimates.

1.4. Scope and coverage

The harmonized QGDP covers the entire economic territory of the United Republic of Tanzania, comprising Tanzania Mainland and Zanzibar. The estimates combine quarterly GDP data compiled separately by the respective statistical authorities and harmonized into a single national aggregate for the United Republic of Tanzania. The geographic coverage ensures that all resident production units operating within the territory are represented.

The harmonized quarterly GDP covers all major economic activities classified according to the International Standard Industrial Classification (ISIC Rev. 4). : (A) Agriculture, Forestry and Fishing; (B) Mining and Quarrying; (C) Manufacturing; (D) Electricity; (E) Water Supply, Sewerage and Waste Management; (F) Construction; (G) Wholesale and Retail Trade, Repairs of motor vehicles and motorcycles, personal and household goods; (H) Transport and Storage; (I) Accommodation and Food Services; (J) Information and Communication; (K) Financial and Insurance Activities; (L) Real Estate Activities; (M) Professional, Scientific and Technical Activities; (N) Administrative and Support Services; (O) Public Administration and Defense; Compulsory Social Security (P) Education; (Q) Human Health and Social Welfare; (R) Arts, Entertainment and Recreation; (S) Other Services Activities; and (T) Activities of Households as Employers.

1.5 Rationale

To produce a consolidated Quarterly GDP for the United Republic of Tanzania. a a single and coherent measure of economic performance is required. As a sovereign nation, the URT requires an integrated national measure that reflects the performance of the entire economy. Harmonization enables the aggregation of quarterly GDP estimates from both sides into one national GDP aggregate.

1.6 Workshop Participants

The four workshops were attended by compilers of national accounts statistics mainly from the National Bureau of Statistics (NBS) and the Office of the Chief Government Statistician (OCGS), Zanzibar, as well as representatives from the Ministries, Departments, and Agencies (MDAs), including the Ministry of Finance and the central Bank.

2.0. Revised Quarterly Gross Domestic Product of Mainland Tanzania and Zanzibar

The compilation of QGDP for both Mainland Tanzania and Zanzibar, base year of 2019 adopted the System of National Accounts 2008 guidelines. The rebasing involved the incorporation of updated social economic data, improved classifications, and enhanced estimation procedures across all economic activities. Benchmark GDP estimates by production, income and expenditure were estimated from separately prepared Supply and Use Tables for both Mainland Tanzania and Zanzibar.

The data sources for the revised National Accounts Statistics (NAS) for both Mainland Tanzania and Zanzibar included surveys and censuses, such as the Household Budget Surveys, Annual Surveys of Industrial Production, and the National Sample Census of Agricultural; administrative records, including customs data, VAT turnover, corporate income tax data, external sector statistics, and Government data) as well as special studies conducted for selected sectors. Detailed information on data sources is provided in the *Quarterly and Annual GDP for The United Republic of Tanzania, Base Year 2019, Sources and Methods*.

2.1 Aggregation of Quarterly Gross Domestic Product

The compilation of the URT Quarterly GDP was achieved through three main steps: harmonization, integration, and aggregation. Harmonization of the compilation systems was undertaken to ensure the application of common concepts, definitions, and estimation practices for both NBS and OCGS. Integration involved bringing together the harmonized data and compilation processes into a unified framework before aggregating the Mainland and Zanzibar estimates. The aggregation was carried out to produce a single consistent Quarterly GDP estimate for the URT without duplication. The resulting URT Quarterly GDP series is consistent with international statistical standards and provides a reliable basis for short-term economic planning, analysis, policy formulation, and monitoring of economic growth.

This section presents quarterly Gross Domestic Product estimates for the United Republic of Tanzania resulting from the four harmonization workshops. The URT quarterly GDP estimates incorporate the agreed sources and methods adopted during the workshops. The QGDP estimates are reported at both current and constant 2019 prices, including sectoral shares and growth rates. In addition, selected QGDP tables for Mainland Tanzania and Zanzibar are included to enhance clarity.

2.2. Analysis of the URT Quarterly GDP

The URT Quarterly GDP provides a comprehensive assessment of economic performance from the first quarter of 2016 to the fourth quarter of 2025. The analysis highlights changes in QGDP levels at current and constant 2019 prices, growth rates and shares to GDP during the reference period.

2.3. Quarterly GDP at Current Market Prices

Across the entire 2016 - 2025 series, quarterly Gross Domestic Product (GDP) at current prices indicated an overall fluctuating trend, characterized by a persistent seasonal pattern in which the third quarter consistently recorded the highest performance in every year (Table 1). Over the entire period, quarterly GDP ranged from a peak of TZS 67.1 trillion in the third quarter of 2025 to a minimum of TZS 24.8 trillion in the first quarter of 2016.

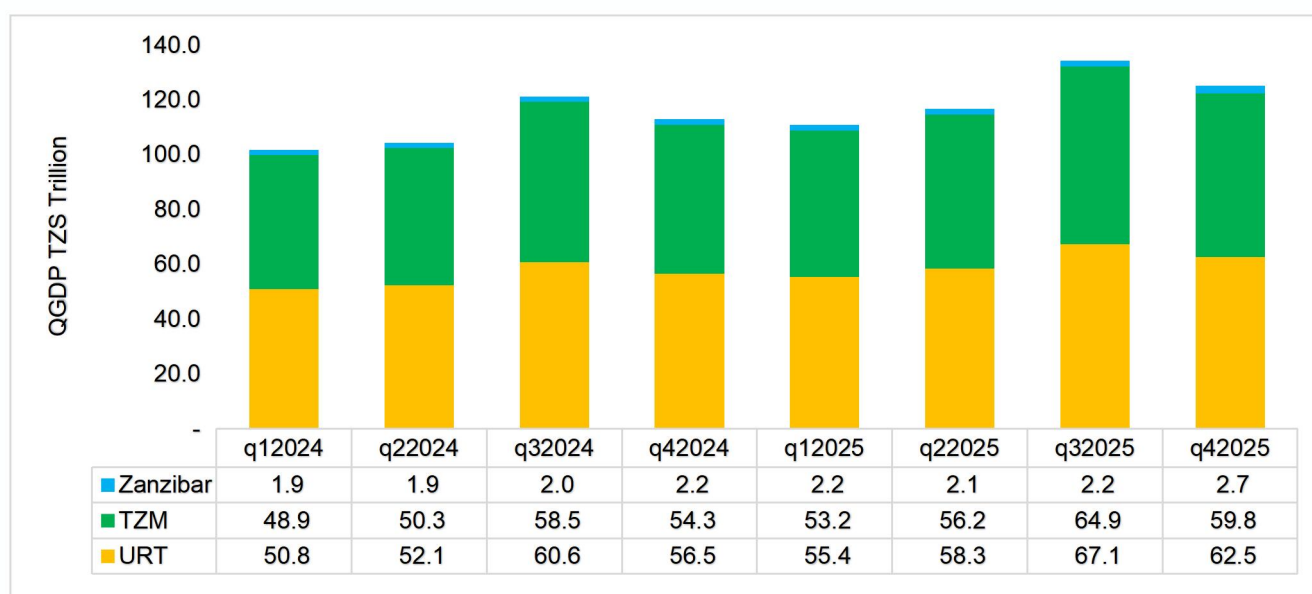

Focusing on the most recent years, the URT quarterly GDP at current prices fluctuated between TZS 50.8 trillion in the first quarter of 2024 and TZS 67.1 trillion in the third quarter of 2025 (Figure 1). Detailed results of the URT estimates are presented in Annexes 1–4.

2.4 Shares to Quarterly Gross Domestic Product

Broad economic activities in the 2008 SNA refer to the main sectors of the economy where production takes place. In this context, activities are classified according to the International Standard Industrial Classification of all Economic Activities (ISIC Rev 4).

The broad economic activities cover: Agriculture (Crops, Livestock, Forestry and Fishing); Industry and construction (Mining, Manufacturing; Electricity, gas, steam, and air conditioning supply, Water supply, sewerage, waste management, and remediation; Construction); and Services (Wholesale and retail trade; Transportation and storage; Accommodation and food services; Information and communication; Financial and insurance services; Real estate activities; Professional, scientific, and technical services; Administrative and support services; Public administration and defence; Education; Human health and social work; Arts, entertainment, and recreation; Other service activities. The shares are computed based on Quarterly GDP at current market prices

2.4.1. Shares to Quarterly GDP by Broad Economic Activities

Overall, the third quarter (July–September) consistently recorded the highest share to the URT GDP from the first quarter of 2016 to the fourth quarter of 2025. The analysis of quarterly GDP by broad economic activities reveals a recurring seasonal pattern, with each broad economic activity regularly recording its highest share to total GDP during specific quarters.

During the reference period, agricultural activities registered the highest share to GDP during the third quarter (July–September) each year. In the URT, the third quarter of the calendar year in most cases, corresponds with the peak season for both agricultural production and many service sector activities. From the first quarter of 2016 to the fourth quarter of 2025, the share of Industry and construction activities in the URT was generally higher during the fourth quarter (October–December) while Service activities accounted for larger share to GDP during the first quarter (January – March) over the period from first quarter of 2016 to the fourth quarter of 2025.

2.5. Quarterly Gross Domestic Product at constant prices

Across the entire 2016 - 2025 series, quarterly Gross Domestic Product (GDP) at constant 2019 prices demonstrated an overall fluctuating trend, characterized by a persistent seasonal pattern in which the third quarter consistently recorded the highest performance in every year (Table No. 3). Over the entire series, quarterly GDP ranged from a peak of TZS 53.6 trillion in the third quarter of 2025 to a minimum of TZS 28.3 trillion in the first quarter of 2016.

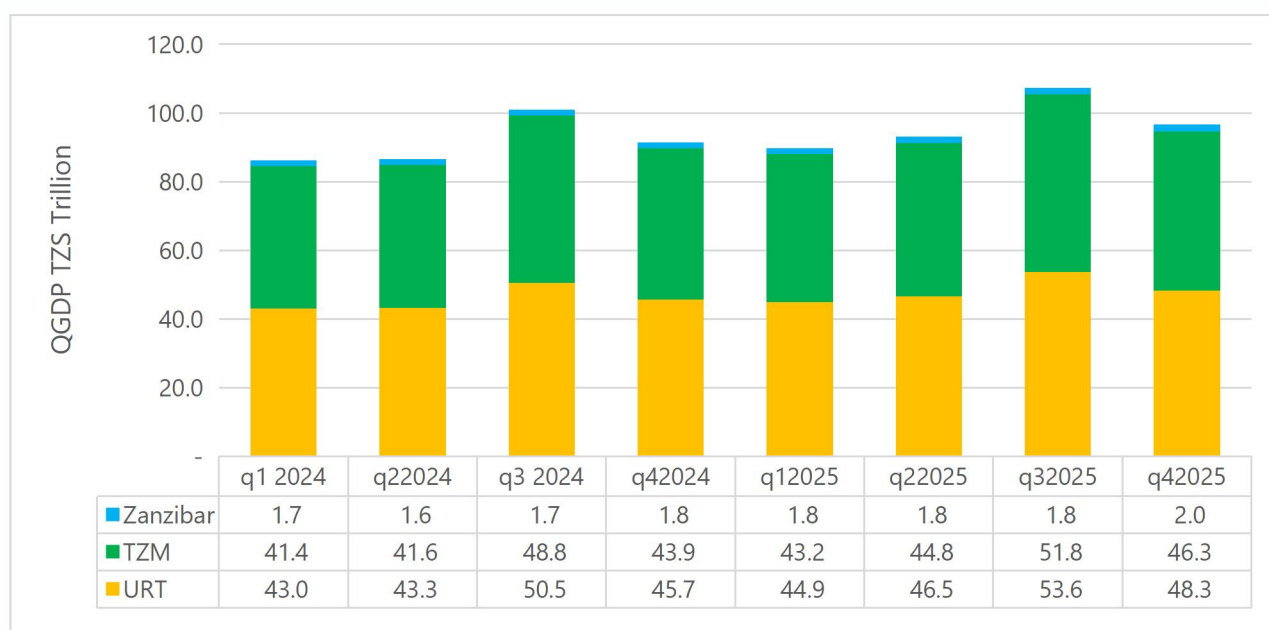

The results presented in Figure 2 and Annex 1 indicate that between the first quarter of 2024 and the fourth quarter of 2025, quarterly GDP at constant 2019 prices fluctuated, with the highest values (TZS 53.6 trillion) recorded in the third quarter of 2025

2.6 Quarterly GDP Growth Rates

Throughout the 2017–2025 period, QGDP growth rates exhibited fluctuations over time, as (Table. 4). The highest quarterly growth across the entire series was recorded at 9.0 percent in the fourth quarter of 2017, while the lowest growth rate of 2.5 percent was registered in both the second quarter of 2020 and the first quarter of 2022

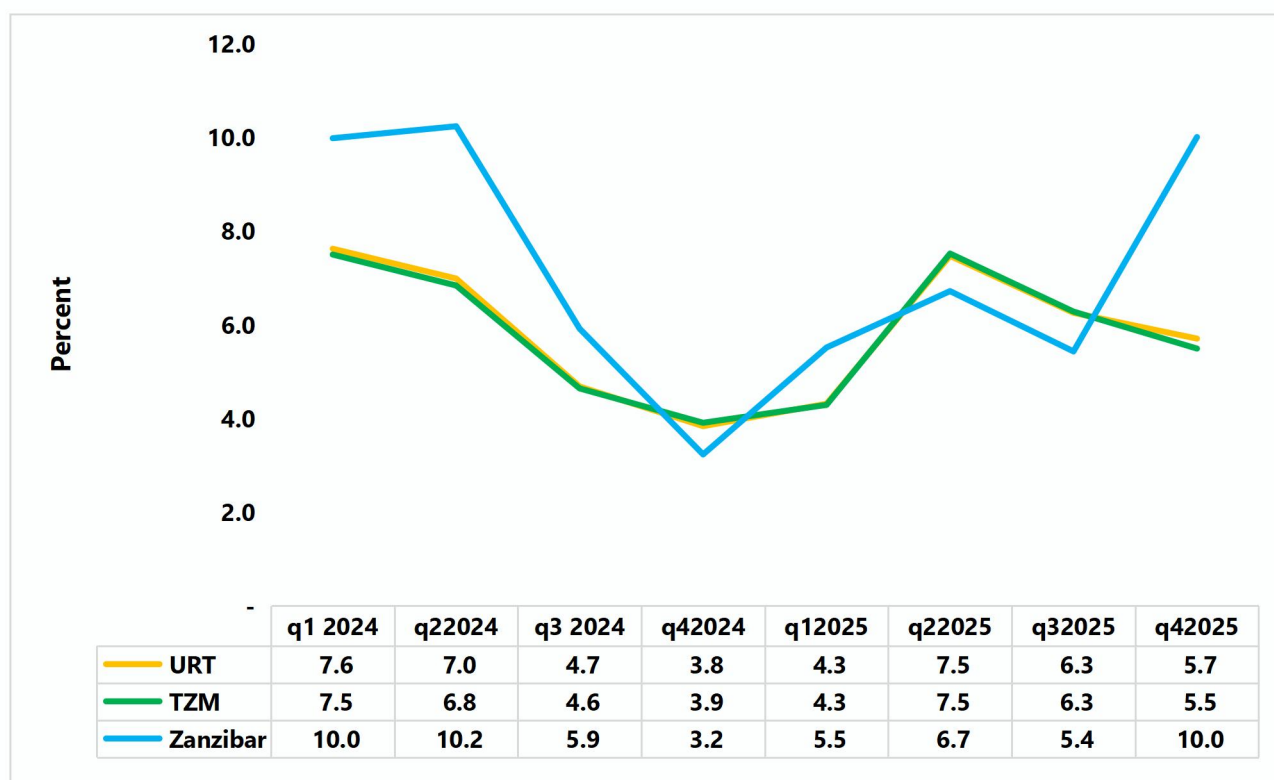

The QGDP growth pattern for the URT and Mainland Tanzania in 2024 and 2025 is more or less the same. The highest and smallest growth rate of 7.6 and 3.8 percent was recorded in the first and fourth quarters of 2024 respectively.

3.0. Outcomes of the Workshops

The four harmonization workshops on the compilation of the Quarterly Gross Domestic Product (QGDP) for the United Republic of Tanzania resulted in the following key results:

- ❖ **Quarterly GDP Estimates of the URT:** Quarterly GDP estimates from 2016 – 2025 for the URT were compiled jointly by the NBS and the OCGS National Accounts team to provide a consistent measure of economic performance.
- ❖ **Harmonised Compilation System:** Participants agreed on the adoption of a common QGDP compilation system and methodology and further improved the estimates as per international NAS compilation manuals.
- ❖ **Documented Sources and Methods:** Detailed documented sources and methods, as well as harmonization proceedings, were prepared for reference.
- ❖ **Standardized GDP compilation templates:** The templates for all economic activities were developed, incorporating common compilation procedures. These common templates will enhance data sharing, improve transparency, and reduce compilation errors.

4.0. Conclusion

The harmonisation of National Accounts Statistics for Mainland Tanzania and Zanzibar represents a significant milestone in strengthening the National Statistical System (NSS). It also enhances the production of quality and comparable economic statistics. This important accomplishment aligns the compilation of NAS with the System of National Accounts 2008, as well as with international best practices in National Accounts compilation. The harmonisation process promotes greater consistency in data sources and methods, classifications, and quality assurance procedures, thereby improving transparency and comparability of official economic statistics across the United Republic of Tanzania.

The harmonised National Accounts Statistics compilation framework will provide a foundation for evidence-based policy formulation, economic planning, and decision-making at all levels. Furthermore, the harmonised statistics will facilitate more effective monitoring of economic performance and structural change, and will support the country's commitments under national, regional, and international initiatives, including the agendas of the East African Community and the African Union, by ensuring the availability of consistent and comparable economic indicators for regional integration and cooperation.

Overall, this achievement marks an important step toward building a more integrated, efficient, and resilient national accounts system that meets the needs of policymakers, researchers, development partners, and other users of official statistics.
